 - a. Senate President Desnoyers-Colas summarizes background of the resolution. The main aim of the resolution was not to communicate that university presidents are not worthy of a raise, but that university faculty are certainly deserving of a raise beyond the small merit raise given.

 - a. Senate President Desnoyers-Colas announced that had she voted on the bill submitted for vote in the April 20, 2015 senate meeting, it would have passed. A literature search was conducted by Armstrong Librarian Caroline Hopkinson and books and peer reviewed journal articles indicate academic bullying and hazing is not an anecdotal concern. Whether appropriate as a senate bill, or a request for administration to address this issue is to be determined, in part by the results of the Campus Climate Survey. Faculty continue to voice concerns to Senate President Desnoyers-Colas about the issue.
