ABOUT THE COLLECTION

Administrative History: Charles E. Cone Realty Company was established in 1915 in Statesboro, Georgia. Robert Moore Benson became the sole owner of the company in 1953.

Scope and Content: The collection consists of the Charles E. Cone Realty Company records from 1926 to 1957 the bulk of which cover the post-war period under ownership of Robert Moore Benson. Materials include correspondence, real estate agreements, plats, and maps of Statesboro, Georgia. Additional documents pertaining to the Charles E. Cone Insurance Company and the Benson Insurance Company are also included which contain information about rates, community committees, and soil conservation regions.
