Each year, all public employees and officials are required to file a report disclosing any business transactions entered into with the state of Georgia or any agency of the state of Georgia over the past calendar year.

The report must be filed by Jan. 31 and should include all transactions entered into by the public employee on behalf of himself or herself OR on behalf of any entity in which the employee, employee's spouse or employee's dependents hold a substantial interest.
