Administrative History: The American Legion's Unit No. 90, known as the Dexter Allen Unit locally, serves the city of Statesboro and Bulloch County. The post is open to local veterans.

Scope and Content : This collection consists of materials documenting the history of the American Legion Auxiliary, Dexter Allen Unit No. 90. Materials span 1917-1930 and include a record of citations and promotions of soldiers as well as the history of the unit. Also included are postcards and letters from soldiers sent to their families and friends, miscellaneous newspaper clippings, a list of non-military patriots, a list of all Bulloch County WWI Veterans, and theater programs printed in French.
