## ABOUT THE COLLECTION

**Biographical History:** Jack Sutton Hill was an American politician. After graduating from Georgia Southern College in 1966 with a B.B.A., he returned to Reidsville, GA and went into the grocery business as owner and operator of Hill Shopping Center. In addition to running the business, Hill served in the Georgia Air National Guard for over 33 years, both as a unit commander and State Inspector General. As a leader in the community, he was appointed to the board of directors of the Tattnall Bank in the early 80s. Then in 1990 he heeded the call to public service and ran for and won his first term as Georgia State Senator for the 4th District of Georgia. Throughout his years of service, he served on many committees including the Senate Rules Committee where he was Vice Chairman and Chairman of the Senate Appropriations Committee.

**Scope and Content:** This collection consists of various political papers to and from Jack S. Hill from the early 1990s to 2020. The collection includes professional correspondence to and from various constituents and organizations, personal correspondence, and audiovisual tapes of Hill's life and work.
