

Obituary

Charlie Baldwin, son of the late Wiley and Eliza Thomas Baldwin, was born on March 1, 1919 in Bulloch County, Georgia. Free from pain, from sorrowing and suffering, Charlie Baldwin departed this life on Sunday, December 10, 1989, at the Veteran's Hospital, Augusta, Georgia.

At an early age, Charlie joined the Hodges Grove Baptist Church where he worked actively until his health failed. He was treasurer and deacon of the Hodges Grove Baptist Church, a member of the Executive Board of the Mt. Tabor Baptist Association, the John Wesley Lodge # 161, and was a Army Veteran of World War II.

On November 7, 1946, he was united in holy matrimony to Mary Ellen Simmons, and to this union a daughter was reared.
