Delta lands in bankruptcy

Northwest and Delta Airlines file for Chapter 11 bankruptcy on same day

WHAT HAPPENED?

Delta Air Lines Inc. and Northwest Airlines Corp., hobbled by high fuel costs and heavy debt and pension obligations, filed for bankruptcy protection from creditors Wednesday, becoming the third and fourth major carriers to enter Chapter 11 since the 2001 terrorist attacks. Atlanta-based Delta, the nation's third-largest carrier, has lost nearly \$10 billion over the last four years despite announcing it would cut up to 24,000 jobs. In September 2004, it also said it would shed its Dallas hub as part of a sweeping turnaround plan aimed at saving the airline. It has since scaled back its operations in Dallas.

WHAT'S NEXT

Delta said it plans to reduce its fleet size and Chief Executive Gerald Grinstein said it's likely more job cuts will be needed on top of the 24,000 job cuts the Atlanta-based carrier has announced since 2001.

Continental and American are in no immediate danger of bankruptcy. Continental had a big cost advantage over other traditional airlines after it slashed expenses during two bankruptcy reorganizations in the 1990s. American may be the strongest financially of the traditional airlines, thanks to \$1.8 billion in annual labor concessions it won in 2003. Its parent company actually turned a profit in the second quarter.

Both airlines are seeking pension reform in Congress to allow them to spread out their payments over more years.

The new bankruptcy laws also will make it harder to pay bonuses to managers to keep them at the company, and will generally force companies to either exit bankruptcy or liquidate faster.

PASSENGERS?

Delta and Northwest said passengers were not expected to see any immediate effects from the filing. Delta also promised to honor all tickets and sent a letter to frequent-flier customers seeking to reassure them. Delta was expected to continue its normal schedule. However, as the company makes its way through bankruptcy court, some changes to Delta's operations could occur, analysts say.

Passengers at Hartsfield-Jackson Atlanta International Airport — which has grown into the world's busiest airport thanks to Delta — didn't seem too concerned about the airline's bankruptcy filing. They said they didn't believe it would affect their travel plans.

IMPACT IN GEORGIA

"I'm confident that Delta will remain a vital part of Georgia's economy," Gov. Sonny Perdue said soon after Delta's filing. "Delta will emerge from this difficult period a leaner, stronger and more financially viable member of our corporate community."

To help Delta, Perdue earlier this year signed a legislation into law that alters sales tax obligations on the purchase of jet fuel. The law exempts Delta from further sales taxes after it pays an obligation of \$15 million to the state. Georgia officials estimated the step will save Delta about \$13 million annually — just a sliver of the company's \$28.3 billion debt.

As for the impact of Delta's bankruptcy on Atlanta's airport, Mayor Shirley Franklin simply said she was encouraged by the airline's plans to expand service out of the city and that the airport's "efficiency and low cost structure make it an attractive place for airlines to operate."

Prince Harry marks 21st birthday in sober style

LONDON - Britain's Prince Harry will spend his 21st birthday Thursday in the sober setting of his military academy but says he has no plans to tone down his wild child image.

"I am who I am and I'm not going to change," Harry said in a round of interviews with news organizations ahead of his birthday.

Royal watchers predict the milestone may mark the maturing of the royal family's most wayward son.

Harry frequently appears in the pages of Britain's tabloid newspapers with a cigarette or can of beer in hand and made headlines this year when he chose a Nazi outfit for a fancy dress party.

Royal watchers have credited Harry's blooming maturity to his enrollment at the prestigious Sandhurst military academy in May, a program which included a grueling five-week induction.

"I think he's buckled under to the team spirit of being a cavalry officer. I imagine he's had to grow up pretty quickly," said Cathy Brooks-Baker of Burke's Peerage.

Spears, Federline have baby boy Wednesday

Britney Spears and husband Kevin Federline are the proud parents of a boy, giving the pop tart's hit "Baby One More Time" a more personal meaning.

Spears, accompanied by her husband, checked into an L.A. hospital about 6 a.m. Wednesday to undergo a Caesarian section.

Baby Spears-Federline is Spears' first, Federline's third. He has two young children from his previous relationship with actress Shar Jackson — including a son who wasn't even born when the dancer hooked up with Spears.

According to Britain's Sky News, Spears was considering naming her son London, because it was in the British capital that his parents' romance blossomed right before the cameras.

But Us Weekly's sources say the infant will be called Preston Michael Spears Federline. Spears' rep had no official confirmation.

Spears, 23, recently told Elle magazine that she considered pregnancy "mind-blowing. And therapeutic — all the secrets from your family come of the closet," she said.

Brit and Kev wed last year, only months after Spears' 55-hour marriage to childhood friend Jason Allen Alex-

ander and the birth of Federline's second child with Jackson.

Spears, a media magnet since the age of 17, then split with her longtime manager, declaring her intention "to just chill." That meant putting down roots in a \$6.9 million Malibu mansion and starting a family.

The director of NASA's John F. Kennedy Space Center (KSC) will present the fifth annual Norman Fries Distinguished Lecture at Georgia Southern during this year's Space Week.

An alumnus of GSU, Kennedy will speak on Tuesday, Sept. 20, at 7:30 p.m. in the Performing Arts Center. "Space Exploration: Past, Present and Future" will be the theme of his lecture, which is free and open to anyone.

In conjunction with Kennedy's appearance, the university will celebrate Space Week. Activities will include a unique exhibit of NASA models, gear and photographs as well as two presentations in the GSU Planetarium.

James W. Kennedy is the eighth director of KSC, which is located in Cape Canaveral, Florida. Kennedy began his career with NASA in 1968 and received a Master of Business Administration degree from GSU in 1977. Kennedy's experience with NASA includes serving as manager for several major projects.

Kennedy has received numerous honors, including the National Space Club's Astronautics Engineer of the Year Award, the NASA Distinguished Service Medal and the Presidential Rank of Meritorious and Distinguished Service Award. Recently, Kennedy was presented with the NASA Outstanding Leadership Medal.

"Space Week" at GSU will get underway with "Human Exploration of Space," which will be presented in the Planetarium on Friday, Sept. 16, at 8 p.m.

This program will trace the historic

Mercury, Gemini and Apollo missions, and it will also discuss space stations, the space shuttle and the future of manned space travel.

A NASA exhibit will be unveiled in the Nessmith-Lane building on Saturday, Sept. 17, from 1 p.m. until 5 p.m. A 1/50 scale model of the space shuttle, a collection of space shuttle photographs and a space suit will be among the items on display.

Visitors can also participate in several interesting programs that will allow them to make their own air rockets, take a walk through the solar system and receive a free map of the moon. The exhibit will remain open for self-guided and group tours

from Sept. 19 through Sept. 23 from 8 a.m. to 5 p.m. Several schools from surrounding counties will visit the exhibits and the planetarium presentations.

The Planetarium will present "Robotic Exploration of Space" on Friday, Sept. 23, at 8 p.m. From the earliest unmanned space crafts to the current Mars rovers and beyond, this program will detail the past, present and future of the robotic exploration of space.

There is no admission fee for any of the Space Week activities. The week is being sponsored by the College of Education, the Museum, the Planetarium and the GSU Foundation.

Closing arguments in case of missing Emory University student

DECATUR — A prosecutor described the man on trial for murder in the death of Emory University student Shannon Melendi a "demon" and asked a DeKalb County Superior Court jury to convict him. Mike McDaniel asked the jury in closing arguments on Wednesday to "make sure the day of blaming inner demons is over. Butch Hinton is the demon." McDaniel was referring to earlier testimony by an inmate in jail with Colvin "Butch" Hinton that he had reportedly screamed, "I didn't kill her. The demon inside me killed that girl."

THE REGION

Ophelia Lashes N.C. coast with rain, surf

NAGS HEAD, N.C. (AP) — Hurricane Ophelia crept up the North Carolina coast Wednesday with high wind, driving rain and pounding surf that washed away a barrier island street, cut off electricity to thousands and threatened widespread flooding. The storm had sustained wind of 85 mph Wednesday afternoon, up from 75 mph early in the morning, the National Hurricane Center said. Hurricane warnings were shifted northward, covering the entire North Carolina coast from the South Carolina line to Virginia, where a tropical storm warning covered the mouth of Chesapeake Bay. In a city where the damage is expected to reach into the tens of billions, there could be enough civil litigation to keep attorneys busy for years.

Judge: school pledge is unconstitutional

SAN FRANCISCO — Reciting the Pledge of Allegiance in public schools was ruled unconstitutional Wednesday by a federal judge who granted legal standing to two families represented by an atheist who lost his previous battle before the U.S. Supreme Court. U.S. District Judge Lawrence Karlton ruled that the pledge's reference to one nation "under God" violates school children's right to be "free from a coercive requirement to affirm God."

Bush urges world to crack down on terror

UNITED NATIONS — Before skeptical world leaders, President Bush on Wednesday urged compassion for the needy and pressed the global community to crack down on terrorists plotting deadly attacks. Addressing more than 160 presidents, prime ministers and kings gathered for three days of U.N. General Assembly meetings, Bush sought to sell his blueprints for spreading democracy in Iraq and elsewhere, overhauling the United Nations and expanding trade.

Nursing home owners charged as Louisiana death toll rises to 423

NEW ORLEANS — The husband-and-wife owners of a nursing home were charged with homicide for not evacuating 34 elderly patients who later died in Hurricane Katrina's floodwaters. The arrests mark the beginning of an attempt by prosecutors to hold those responsible for the New Orleans catastrophe accountable.

The Louisiana attorney general's office said all of its investigators have been pulled from other tasks to work on the Medicaid Fraud Unit, the team whose work led to the arrests Tuesday of the owners of the St. Rita's nursing home in Chalmette.

Kris Wartelle, a spokeswoman for Attorney General Charles Foltz, said the office is looking into other allegations of neglect that may have led to injuries or deaths at nursing homes and hospitals.

"Reports are flooding in. It just depends on what's legitimate and what is not," Wartelle said Wednesday.

In Washington, Senate Republicans on Wednesday scuttled an attempt by Sen. Hillary Clinton to establish an independent, bipartisan panel patterned after the 9/11 Commission to investigate what went wrong with federal, state and local governments' response to the hurricane.

A Senate committee opened a hearing on the disaster, with the panel's Republican chairwoman saying that changes instituted after Sept. 11 in the government's emergency-pre-

paredness failed their first major test during Katrina.

With billions of dollars to boost disaster preparedness at all levels of government, "we would have expected a sharp, crisp response to this terrible tragedy," said Sen. Susan Collins, R-Maine. "Instead, we witnessed

what appeared to be a sluggish initial response."

For Louisiana alone, the death toll surged by more than half Tuesday to 423, and the number is certain to climb. Including deaths in four other states, Katrina's overall toll stood at 659.

Michael Jackson announces performers for Katrina benefit

LOS ANGELES (AP) — Michael Jackson's publicist says eight performers so far have agreed to join a song to benefit Hurricane Katrina victims.

Raymond K. Bain said artists who will appear on Jackson's song, tentatively titled "From the Bottom of My Heart," include James Brown, Jay-Z, Mary J. Blige, Missy Elliott, Lenny Kravitz, R. Kelly, Snoop Dogg

and Ciara.

But representatives for some of the artists said it was premature to say their clients were committed to the charity single.

Representatives for Snoop Dogg said he would take part. But Jay-Z's publicist, Jana Fleishman, said the rapper had "been approached, but Jay told me directly he is not yet confirmed to be on that song." Several other publicists said their clients were in talks and had yet to confirm.

Sea lions sink man's antique sailboat

1 NEWPORT BEACH, Calif. -Jerry Dunlap spent more than a year fixing up his 1910 dream sailboat. But a gaggle of about 15 hefty sea lions managed to sink the 50-foot craft in just one weekend. Dunlap paid \$3,500 to have the boat dragged up from the bottom of Newport Harbor. The radios, radar and electrical system were ruined, and he doesn't know how much it will cost to repair the boat. The scuttling of Dunlap's \$24,000 boat may be the most striking example of mayhem that sea lions have caused since they started showing up in the harbor in May. Residents complain that they bark all night long, and the city received a report that a rogue sea lion tipped over a mother and her child in their kayak. City officials are considering asking the City Council to make it illegal to feed the sea lions. Some boat owners have also strung barricades made of wire and milk carton around their crafts, while others place upside-down lawn chairs on their swim steps.

Residents complain about sickening stench

2 ZEARING, Iowa -Residents of this central Iowa town say they are tired of the smell coming from a trucking company that washes livestock trucks. A resident, Mary Jo Henze, said the stench permeates area homes, although it hasn't reached her home yet. "The smell is so bad in my friend's home, when you open the door it knocks you in the face ...," she said. The company constructed a new building last fall to wash as many as six livestock trucks a day. The city approved a permit for the company to hook up to the city's sewer system, but when the weather turned warm last spring the smell of livestock and rotten eggs overtook area homes, causing headaches, watery eyes and nausea.

City officials have asked water treatment professionals to look at the problem. Rich Reed, owner of the company, said it is working to fix the problem, including replacing filter screens with ones with smaller holes to better filter waste going into the sewer and hiring professionals to determine which chemicals would best treat the waste. The city's water superintendent will test the sewer line near the company, and the city also will look into testing air quality inside nearby homes.

Evading tolls legal by new law in N.H.

3 CONCORD, N.H. — Oops! When New Hampshire introduced E-ZPass at toll booths, it made driving through an E-ZPass lane without paying punishable by a \$25 fine. But in making the change, it inadvertently repealed the law that made it illegal to drive through other lanes without paying, officials now realize. State officials will ask legislators to fix the problem when they return to Concord for the 2006 session. The error occurred last year, when the Legislature passed the law authorizing E-ZPass. Officials say it wasn't discovered until E-ZPass went into operation this summer. Toll evasion had been a violation, comparable to a traffic ticket. Drivers who don't pay within 60 days face escalating consequences. Their licenses and vehicle registrations can be suspended, triggering costly reinstatement fees. The problem is the 2004 law didn't spell out details for dealing with people who drive through cash and exact change lanes without paying. Sweeney said those drivers can be reported by toll attendants or police and are subject to the \$25 administrative fine.

Bill hits drivers who don't de-ice cars

4 BOSTON -Winter drivers too lazy or rushed to clear snow and ice from their cars would face fines and even jail under a bill being consid-

ered by the state Legislature. The bill, considered Tuesday by the Joint Committee on Transportation, seeks to reduce the danger to other drivers from chunks of snow and ice that fly off car roofs or hoods. Motorists who don't clear their vehicles face a \$500 fine or a prison term of up to six months. If it passes, Massachusetts could become the first state to require snow and ice-free cars. Art Kinsman, director of government affairs for AAA Southern New England, said people who don't clear their cars should be fined because they are "lazy and irresponsible." But he said the proposed penalty is too high and said police officers might be reluctant to enforce the law. Rep. Joseph F. Wagner, co-chairman of the Transportation Committee, said the language in the bill is too vague. Right now, it bans "operating a motor vehicle with an accumulation of snow or ice which constitutes a threat to public safety." Paula Waugh saw a need for the bill after a chunk of ice flew off a tractor trailer in Winchendon and smashed her windshield, leaving her with a broken nose and other facial injuries.



Ohio man cited in fake death prank

5 MERCER, Pa. -Police cited an Ohio man for harassment after an ugly prank involving his sister. Glenn Connolly, 35, of Youngstown, called state police in Mercer on Saturday and asked them to advise his sister, Victoria Christie, 34, of Mercer, that their mother had died, authorities said. Troopers did just that, only to find out afterward that the woman hadn't died. Police didn't immediately say what was behind the prank. Connolly doesn't have a listed telephone and couldn't immediately be reached for comment Monday. Because police filed only a summary citation.

L.A.: report of gator capture is a hoax

LOS ANGELES - Authorities on Tuesday dismissed a claim that a wrangler had nabbed a 7-foot-long alligator named "Reggie" from a city lake, where he had been dumped several months ago and repeatedly avoided capture.

Earlier Tuesday, a man claiming to be wrangler Jay Young, who had been hired by the city, told media outlets, including The Associated Press, that he had caught the alligator overnight.

That story was cast into doubt when the promised delivery of the alligator to the Los Angeles Zoo never happened.

"To the best of my knowledge and all the reports I have received this morning, it was a hoax," said Ron Berkowitz, the Los Angeles Recreation and Parks

superintendent, who supervises the area that includes the lake. "I called the zoo to verify and the gator is not there. I called the rangers, the city council office and my staff at the lake. There was no capture."

Reached by phone at his Colorado gator farm later Tuesday, Young said he has not been in Los Angeles recently and that he hadn't called the media earlier in the day. He said the caller apparently was someone impersonating him.

In a written statement later in the day, Young blamed "a jealous ex-employee trying to ruin my reputation."

Young had been hired by the city last month and promised to capture the alligator within a few days. He left town on Aug. 18, unable to deliver on his promise.

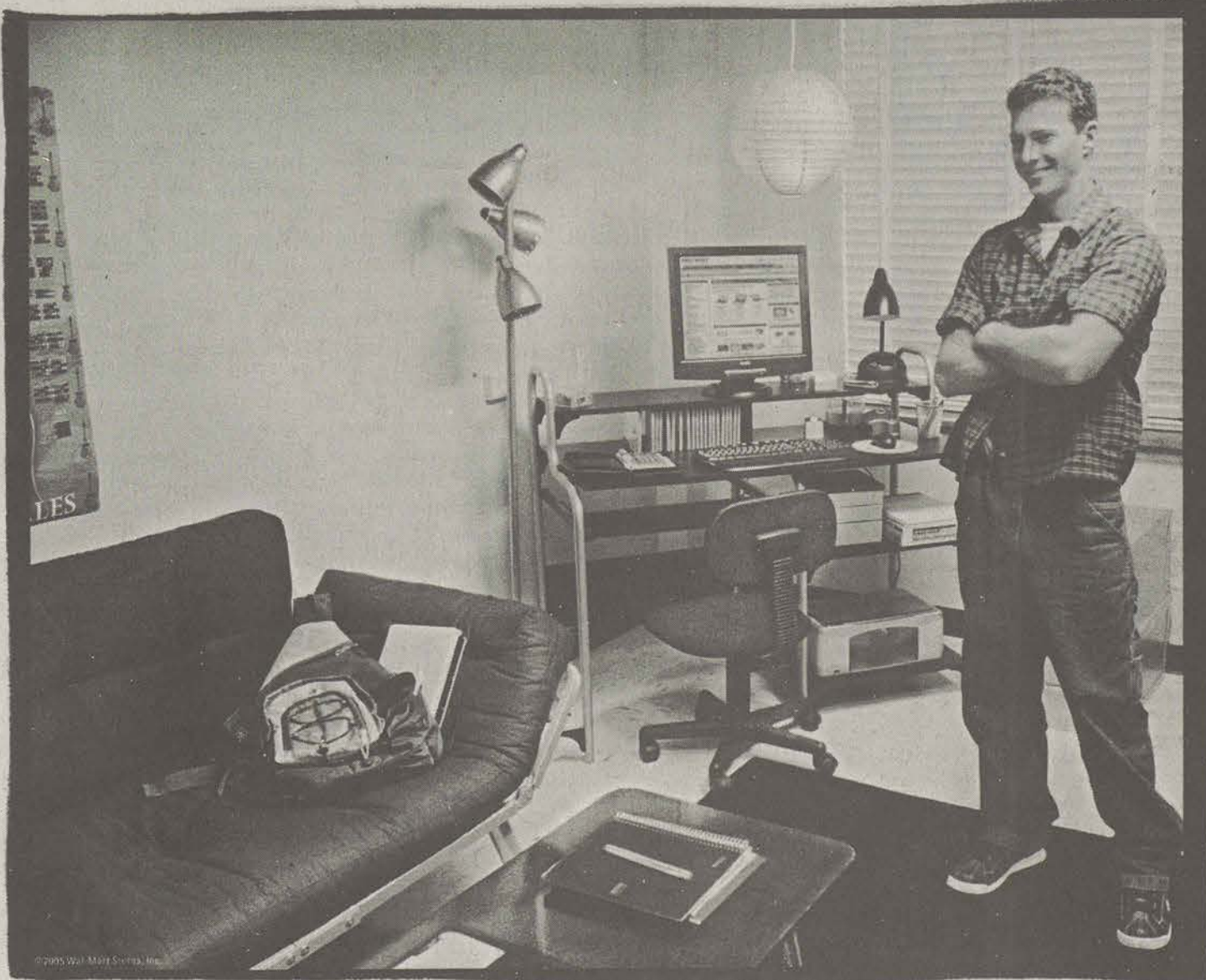

Louisiana.

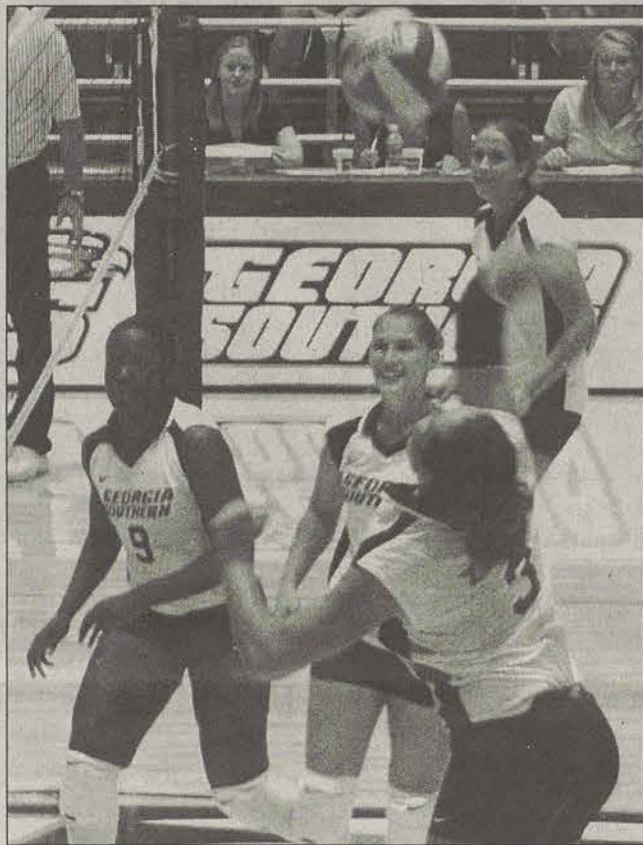

Roberts promises to make decisions based on law

WASHINGTON — Chief Justice nominee John Roberts said Wednesday that the law, not his own personal views, would be his guide in deciding right-to-die cases that might come before the Supreme Court.

Roberts stopped short of providing his specific views on the issue.

"We are rolling the dice with you judge," said Sen. Joseph Biden, D-Del., who made no headway in extracting Roberts' personal feelings about when to decide to end life supports for an ailing family member.

Republicans in the GOP-controlled Senate made it clear that President Bush's choice was on a smooth path toward confirmation to a lifetime job, and they challenged Democrats who might oppose Roberts' nomination to be the nation's 17th chief justice.

"If people can't vote for you, then I doubt that they can vote for any Republican nominee," said Sen. Orrin Hatch, R-Utah.

A persistent Biden sought Roberts' opinion on whether any law could trump the right to die, but the nominee said little more than his oft-repeated response that it would be inappropriate to comment

on a case that he might decide.

"There are cases that come up exactly in that context ... before the court," Roberts said.

"I will confront them with an open mind. They won't be based on my personal views. They will be based on my understanding of the law."

Roberts parried lawmakers' questions on a wide variety of subjects.

Republicans portrayed the appellate judge and former political appointee in the Reagan and first Bush administration as a brilliant legal scholar who is highly capable of leading the court for at least a generation. Bush chose Roberts to succeed the late Chief Justice William H. Rehnquist, who died Sept. 3 of cancer.

Sen. Jon Kyl, R-Ariz., said the nominee had his vote, and John Cornyn, R-Texas, said Roberts "may very well be the most qualified nominee ever appointed" to the court.

Early in his testimony on Wednesday, Roberts' second day of answering senators' questions, the nominee said Congress has the right to counter Supreme Court rulings including a divisive decision giving cities broad power to seize and raze people's homes for private development.

A sharply divided Supreme Court

ruled earlier this year that cities can take and bulldoze people's homes in favor of shopping malls or other private development to generate tax revenue.

The decision drew a scathing dissent from Justice Sandra Day O'Connor as favoring rich corporations, and Republican lawmakers and some Democrats have criticized it as infringing on states' rights.

"This body and legislative bodies in the states are protectors of the people's rights," Roberts said.

Congress has been working on legislation that would ban the use of federal funds for any project that gets a go-ahead relying on the Kelo v. City of New London, Conn., decision.

Also on the question of congressional versus court authority, committee chairman Arlen Specter, R-Pa., bristled at lawmakers "being treated as schoolchildren" in criticism from some judges, including Justice Antonin Scalia.

Roberts said the Supreme Court was not the taskmaster of Congress. "The Constitution is the court's taskmaster and it's Congress' taskmaster as well," he said.

If confirmed, Roberts, 50, would be the youngest chief justice in 200 years.

He is expected to earn the Senate's approval before the Supreme Court begins its term Oct. 3.

President Bush had originally

nominated Roberts, a federal appeals court judge and conservative lawyer in the Reagan and first Bush administrations, to succeed O'Connor, who

announced in July that she would retire.

Upon Rehnquist's death, Bush chose Roberts for chief justice.

Federal judge declares Pledge of Allegiance in public schools unconstitutional

SAN FRANCISCO — A federal judge declared the reciting of the Pledge of Allegiance in public schools unconstitutional Wednesday in a case brought by the same atheist whose previous battle against the words "under God" was rejected by the U.S. Supreme Court on procedural grounds.

U.S. District Judge Lawrence Karlton ruled that the pledge's reference to

one nation "under God" violates school children's right to be "free from a coercive requirement to affirm God."

Karlton said he was bound by precedent of the 9th U.S. Circuit Court of Appeals, which in 2002 ruled in favor of Michael Newdow that the pledge is unconstitutional when recited in public schools.

Newdow, an attorney and a medical doctor, filed an identical case on behalf of three unnamed parents and

their children.

Karlton said he would sign a restraining order preventing the recitation of the pledge at the Elk Grove Unified, Rio Linda and Elverta Joint Elementary school districts in Sacramento County, where the plaintiffs' children attend.

The order would not extend beyond those districts unless it is affirmed by a higher court, in which case it would apply to nine western states.

Hurricane victims piling up credit debt

PLANO, Texas — Jerry and Deborah Alciatore fled New Orleans with nothing but a couple of overnight bags, an ice chest and their credit cards. The bags emptied quickly, but two weeks after Hurricane Katrina hit, the balance on the credit cards is mounting fast.

The Alciatores are quick to say they are lucky compared to others who suffered so much more. They consider themselves middle class, maybe upper middle class.

Still, financial experts say the couple is right to be worried. The Alciatores and other Katrina victims who thought they were financially secure must keep their debt in check while facing huge relocation costs and uncertainty about their income. It's not easy.

"People in a crisis are not thinking clearly. Their emotions take over, and that's not a good place to be when it comes to your finances," said Deb Outlaw, a CPA and financial planner in Dallas.

Helen Salazar-Realini, a financial planner in Miami, said most of those who left the Gulf Coast early will be fine. Insurance, after a deductible that can run several thousand dollars, will

cover their homes and cars and living expenses while they are uprooted.

Renters will be in far worse shape, she said. They may have lacked insurance to cover their belongings and have difficulty recovering security deposits.

Salazar-Realini said people in such a dilemma should seek consumer credit counseling offered by familiar agencies such as United Way.

Critics say credit card issuers are making it harder for people to dig out of debt by increasing penalty rates for late payments. Nearly half raise interest rates for customers who are late paying other bills.

Credit card companies now say they will waive penalties for Katrina victims who are unable to pay on time. Credit card giant MBNA Corp. will give hurricane victims a two-month payment holiday and a break from cash advance and late fees.

The Alciatores and about 40 other Katrina victims are staying in a suites hotel in Plano, a Dallas suburb. The Red Cross is paying for up to 28 days of lodging.

Many have applied for \$2,000 in aid from the Federal Emergency Management Agency.

The Food Corner: 'College-Proof' Pasta

Italian dishes are nice, but they are also expensive. Some restaurants charge as much as \$15 for a single pasta dish.

Why go out and spend your good money when you can make a great pasta dish at home for less? This recipe is good, ridiculously cheap and most of all, college-student friendly.

So turn on your stove, preheat your oven and get ready to make fried sausage ravioli with white sauce.

The ingredients:

-Great Value pre-made pie dough

(not in pan)	\$1.73
-½ a package of Jimmy Dean Italian Sausage	\$2.87
-1 ½ a cup of Great Value heavy whipping cream	\$1.84
-2 tbs. of 5 th Season Italian Seasoning	\$.50
-¼ of an onion and green pepper (or your favorite vegetables)	\$1.00
-1 tbs. of Minced Garlic	\$1.74
Total: Serves two people for \$9.68

How to get cooking:

-Preheat a medium sauce pan with oil filled up half way and a frying pan

to medium heat.

-Start by frying sausage in a pan until meat is light brown (make sure to break up the meat up with spatula); remove from heat and drain grease.

-Slice vegetables thinly and place into saucepan with heavy cream, garlic, 1 tablespoon butter and Italian seasoning.

Bring to a boil then reduce temperature to medium low. Cook about 15 minutes or until sauce is reduced by half and thick enough to coat the back of a spoon.

-Meanwhile, cut pie dough into 2 inch squares. Take one square and place a spoonful of sausage into the

middle. Take another square, place on top of sausage then seal the top and bottom dough squares together by pressing a fork around the edges. Continue until all squares are used.

-Place 1-4 ravioli squares into hot oil and cook until dough is golden brown (about 3 minutes). Place on paper towel to drain excess grease. Plate and pour white sauce over.

Get another meal for your money:

Use left over sausage for sausage biscuits in the morning.

Just make into patties, fry and place on biscuits (canned biscuits are great for this recipe) with cheese.

When downloaders GO WRONG

GSU students can be charged for illegal downloading on campus

Downloading copyrighted music off the Internet: a quick, easy and free way of getting quality music. It's so simple. You can instantly download a free program such as Morpheus or LimeWire and you're ready to go.

The variety of music provided by these sites is nearly endless, and once music is downloaded, it can be put directly onto an mp3 player or copied onto a CD. This makes downloading music especially popular with college students. The only problem with it's illegal.

Downloading music from the Internet may still be quick and easy, but because it is in violation of copyright laws, both the RIAA (Recording Industry Association of America) and the MPAA (Motion Picture Association of America) are becoming increasingly aggressive in their pursuit of those who download copyrighted material, and in making sure that these online pirates do not get away for free.

Some penalties for individuals found guilty of online piracy may include up to three years in prison and \$250,000 in fines, the RIAA states.

Georgia Southern's lawyer, Jeff McLellan, says that although the school has been notified many times in past years (mostly by the RIAA but occasionally by the MPAA), there have been fewer cases each semester. He says that there were many cases in 2004, but "it has dried up recently." He attributes this fact to the sincere educational effort being made by Information Technology services at GSU to educate students about the potential consequences of online piracy.

stand their responsibilities and the best practices they should employ as they use the Internet, and it's important for us to use such incidents as a tool to help increase that understanding," said Lisa Spence, head of Information Technology Services here at GSU. Some of the steps being taken include educating students about what is and is not legal.

According to both the RIAA and the MPAA, the Supreme Court ruled that any company found guilty of allowing its customers to pirate music may be sued by the music industry. This poses a particular problem for many institutions, including universities.

The music and motion picture industries, in cooperation with such universities, are taking action against users of illegal software.

Before they can take any steps against suspected online pirates, however, the RIAA must first track them down. They do this by first identifying the Internet service provider used to download the copyrighted music.

This is where GSU comes in. For students living on campus, the server is GSU.

Therefore, when the RIAA dis-

covers that the GSU server is being used for illegal purposes, it directly notifies the school. The school is then required by law to respond to these notifications, as the Digital Millennium Copyright Act makes quite clear, said McLellan.

Spence said that when the RIAA or MPAA notifies GSU that someone has used the school network to illegally download copyrighted material, the school first shuts down the network port, and contacts the owner of the machine being used.

The school then requires the user to turn off the peer-to-peer software. In addition, GSU records the student as a violator of the school's Computer Use Policy, and the case is taken over by the University Judicial Board.

According to the GSU policy, the school will not come to the legal defense of any student accused by the RIAA of illegally downloading music.

Another method the school uses to deter potential online pirates is to limit the bandwidth used by this software, which prevents users from sharing files back over the network.

In case you're curious, there are legal alternatives to programs such as LimeWire and Morpheus. Some of these include iTunes and Napster, which allow customers to download their favorite songs legally, for a small price (usually less than a dollar).

Some complain that this is still too expensive and too much of a hassle, but it's a small price to pay in comparison to the huge fines a lawsuit from the RIAA would bring you.

Just ask the more than 7,000 people who have already been sued by the RIAA and MPAA.

'Desperate Housewives'

Audiences were captivated by the women of Wisteria Lane in the first season of Desperate Housewives, the breakout hit from ABC that almost single-handedly lifted the network from its ratings doldrums and brought back the classic TV soap, remixed now with satire, comedy and mystery. Gay pride comes out to Savannah for 6th annual celebration

The sixth annual Savannah Gay Pride Festival kicks off this Saturday, Sept. 17.

The festival will be from 11 a.m. to 9 p.m., and the celebration continues at Club One in Savannah afterwards, with free cover for Pride volunteers.

The Savannah Pride Festival will be held on River Street for the first time since its start six years ago. Supporters hope this will bring out an even bigger crowd than last year, which was at more than 12,000 people, according to GayPride.com.

Georgia Southern's GSA (Gay-

Straight Alliance) president Megan Donecker says she's glad this year's celebration is on River Street.

"We're really excited about it because we'll be in public now. Usually we've been kind of secluded," said Donecker.

This year's Pride theme is "Equal rights, no more, no less." All are welcome at the celebration, gay or straight. The event is held to provide gay men, lesbians, bisexuals, trans-gendered persons and their allies with cultural and educational programs and activities to promote awareness of the GLBT community.

This year's Pride sponsors include

several big names such as Coca Cola, Dasani, Urban Cargo, Wachovia, Bell-south and Bud Light, as well as many local Savannah businesses.

Entertainment includes amateur performances by volunteers and performances by big-name singers, such as Eric Himan, Kristine W., Pepper MaShay and Lady Chablis on the main 'Pride Stage' at Rousakis Plaza.

Over 60 vendors will be featured at Pride including local restaurants, merchants, businesses and outreach organizations that support the GLBT community.

out water bottles and pamphlets to raise awareness about their organization.

This will be the second year GSA is running a booth at Pride. GSA treasurer Megan Lowery is glad to have Pride at a bigger location this year.

"I think it'll be better for us because we'll have more room to space out," Lowery said.

GSA is taking big steps to raise awareness about the gay community at GSU this year, including volunteering at Pride, participating in Unity Fest and celebrating National Coming Out Day (Oct. 11).

Pride is the first big step we're taking this year to get everyone aware and to let them know we're here," Donecker said. She added, "Most people don't really understand [the GLBT community] ... Marjorie Fair: Music for ears that try too hard

From more than three years of gestation in Los Angeles comes the debut album of Marjorie Fair, aptly titled "Self Help Serenade." Fans of the Garden State Soundtrack unite, this is your band.

If you ascribe to the lengthy chords of the late John Lennon, the shivery indie tunes of Flaming Lips or even the sweet melodies of early Coldplay, Marjorie Fair is just for you.

The album, just released from Capitol Records, had already received many kudos from the UK. I guess I'm just not into the indie scene, though; I was unimpressed.

To be fair, the album feels very whole. Its continuity is amazing, reminiscent of Pink Floyd's signature flow.

Each song is obviously the heart and soul of its writer/singer, Evan Slamka, a self-described "neo-hippie who wished he lived in the sixties." He wants to be understood, even saying, "That's a big thing for an artist—to feel that your expression is actually translating." Sorry, Evan, but I think something was lost.

This album is wonderful if you're trying to fall asleep. The soft guitars and haunting vocals are very soothing, but they fall flat. The lyrics are apathetic, discussing sometimes very disturbing images ("They found her in a plastic veil/with blood-stained boots and glass in her hair") with a casualness and simplicity that is almost abrasive. It's like they're trying way too hard to be tragic, but they don't really care.

Even without the lyrics, the music leaves much to be desired. It's as if

the band can't decide between being modern or old school.

Imagine, if you will, a perfectly good melodic piece, rich with soothing, though emotional guitar and honestly well done vocals. Now add some very bad synthesized organ. The music would be very good, if it weren't for the synthesized additions. They just don't make sense with the music, and the effect falls flat.

The overall impression left by "Self Help Serenade" is that of just one more indie band. To be honest, it hurts because there is real potential for greatness there, but this is only their first album. With time and maturity, the simplistic lyrics and bad organ music might wash away, leaving some really good music behind.
