Rockwell reports half-year, 1960 sales and earnings

PITTSBURGH, Pa.—Sales of Rockwell Manufacturing Company for the first six months of this year were about the same as last year's first half. Earnings per share dropped to \$1.06 from \$1.26, W. F. Rockwell, Jr., president, said in a report to the shareholders today. Sales for the first six months of 1960 were \$57,775,000 as compared to \$57,355,000 for the same period in 1959. Earnings were \$3,747,000 to June 30, 1960 and \$4,446,000 to June 30, 1959.

PRICE-COST SQUEEZE

Discussing the drop in earnings, Mr. Rockwell said, "The important problem today is the price-cost squeeze on many of our prices in the face of continuing increases in the cost of labor and, to some extent, materials. To combat this, our continuing cost control program has been expanded and all expenses not connected directly with sales and profits are being curtailed. Expenditures for research and engineering, because of their critical influence on future sales and profits, have been increased and are now in excess of 3.5% of sales."

WEST GERMAN SALES CLIMB

Mr. Rockwell said continuing success of Rockwell overseas operations, especially sales in West Germany, made at the West German manufacturing facilities, a particularly bright spot in the company's performance.

When It . . .

SUCH A REVIVAL must begin at the personal level. Each of us must turn to the Lord in humble confession of sin and willingness to be filled with the Spirit and used by Him. As we do this, let us get others to join with us in united prayer and work for revival. If this takes place, we can have the joy of seeing a tremendous change in the Church and in the land we love. We will then have taken the steps through which God can act to divert disaster to men as individuals, and to our nation as a people.

Against the devilish ingenuity and effective spread of Communism, there is but one answer: separate from it and trust the Lord to take care of the consequences. We believe our present dilemma is due to a fatal mistake. If this is true, the mistake must be remedied at the place where it was made.

IT IS OUR conviction that America's future rests squarely on that which God permits to take place, and we believe we now have no right to claim His special protection. The work of Isaiah may speak to us today:

"Woe to the rebellious children, saith the Lord, that take counsel, but not of me; and that cover with a covering, but not of my spirit, that they may add sin to sin; that walk to go down into Egypt, and have not asked my mouth; to strengthen themselves in the strength of Pharaoh, and to trust in the shadow of Egypt!" —Isaiah 36:1-2.

"Lo thou trustest in the staff of this broken reed, or Egypt, whereon if a man lean, it will go into his hand, and pierce it." —Isaiah 36:6.

From a spiritual standpoint, what is the answer?

PROBLEMS can never be settled aright purely at the secular or political level. The ultimate solution of America's dilemma has to do with our right relationship with God. The answer then lies in repentance, conversion and healing.

And that is exactly what the Gospel of Jesus Christ does—it brings repentance of sin, conversion to Christ and healing of the soul and spirit.

The answer to this dire crisis is a revival of true religion; a turning to Christ and the blessings which flow therefrom.

How can such a revival come? It cannot come from a watered-down Gospel. It cannot be brought about by a compromised Christianity. It will never come as the result of a perverted message.

THERE IS a desperate need for revival within the Church in pulpits and pews. We can never go out to win men for Christ with doubt in our hearts, compromises in our personal lives or faith in an organization alone. America needs Christ crucified, dead and risen. America needs the power of the Holy Spirit working in the lives of men and women. We need a new sense of sinfulness and a crying out to God in importunate prayer.

Frankly, the writer does not believe that the Church in America is at the present time capable of bringing about such a revival. Unbelief must be changed to simple faith; lovelessness and contentiousness must be supplanted by love; trust in man-made schemes and organizations must be renounced; and the power of the Holy Spirit be applied to the hearts of men.

In other words, the Church must be brought back to the power of the Holy Spirit, and the power of the Holy Scriptures. Omit any of these and failure looms for prayer alone can lead to failure to witness; a trust in the Holy Spirit alone to fail; and unbelief in, or mistrust of the Bible, to warfare without a weapon.

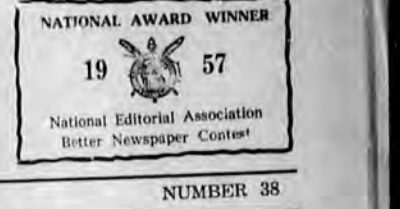

Tobacco sales down here first 2 days

On Tuesday night, August 2, after four days, the Statesboro tobacco market had sold 1,753,122 pounds of tobacco for a total of \$781,780.52.

The difference is 1,584,912 pounds and \$1,160,445.46 is accounted for by the "blue tag law" passed by the Georgia General Assembly in January of this year.

Full sales were reported to be on the floors of all the warehouses in Statesboro yesterday (Wednesday).

Blue tag hearing set for August 10

A hearing was granted Tuesday to the state of Georgia on a motion to lift a federal court order prohibiting Georgia from enforcing its "blue tag law." It will be held in Brunswick on Wednesday, August 10.

It all began when the 1960 Georgia General Assembly passed, what has come to be known as the "blue tag" law. The law, Act No. 557, page 214 of the General statutes, is administered by the Commissioner of Agriculture, assisted by an Advisory Board.

The Act requires that tobacco sold on Georgia markets from areas north of the Savannah River (South Carolina, North Carolina, Virginia) be marked with a blue tag. Tobacco grown south of the Savannah River (Georgia, Florida) and in Alabama must be identified by a white tag.

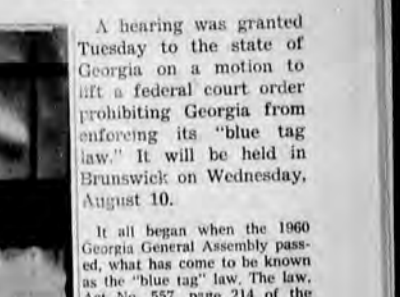
The law, when put into operation on the Statesboro market, set up a situation which brought concentration and unhappiness to warehousemen and many tobacco growers. When the sales opened here on Thursday, July 28, tobacco buyers ignored the blue-tagged tobacco by either not bidding on it or by bidding lower than they did on the white tagged tobacco.

The situation did not improve on the second day of the state. Then the Statesboro warehousemen filed a Federal Court suit Saturday and Saturday night District Court Judge Frank M. Scarlett signed an injunction preventing Georgia Commissioner of Agriculture Phil Campbell from enforcing the state's tobacco identification bill.

The petition was filed in the names of Aubert J. Brannen Sr., Aubert J. Brannen Jr., Robert Brannen, and Williams George Jr., all of Statesboro; Henry C. Scruggs, Ed Wiggins, Guy Sutton Jr. and Mrs. L. B. Willoughby, Statesboro; and Swainson and Statesboro warehouse operators.

The petition charged that the act is unconstitutional and an act of Congress' right to regulate interstate commerce. As soon as Judge Scarlett signed the injunction, his attorneys hurried the legal papers to Atlanta to serve on Commissioner Campbell. There would be no question that enforcement would be halted when the market opened here Monday morning of this week.

School study group to study county school system change

The School Study Committee is studying the possibility of a major change in the administration of the Bulloch County School System.

The original purpose of this committee was to study the present situation in regard to the lack of adequate classrooms for the coming school year. It was found that the trend in good educational systems today is a school board composed of eleven members. These board members are elected by the people and they in turn appoint the County School Superintendent and elect the chairman of the board.

The committee plans a complete and thorough study of this model form of school board administration by visiting some of the best educational systems in Georgia.

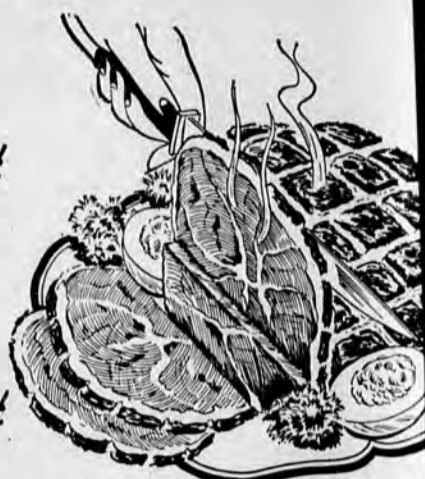

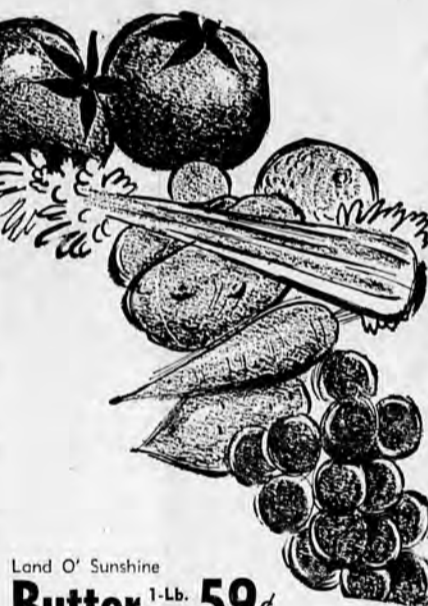

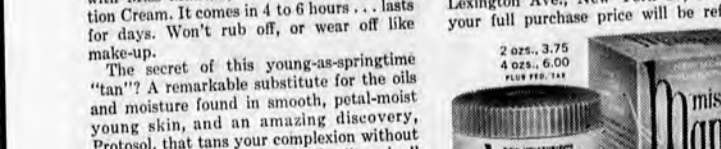

Bike owners to get stickers from B&P

Members of the Sallie Zetterer and Mattie Lively B&P Bike Safety Club will be issued scotchlike license stickers for their bicycles at the Sallie Zetterer school Saturday morning, August 13, from 8:30 to 11:30 a.m. at the Mattie Lively school from 1 to 4 o'clock that afternoon.

The B&P Bike Safety Club was organized with the cooperation of the Statesboro police department, the county department of education, and the Statesboro Business and Professional Woman's Club in the spring of this year.

Members of the bike safety club who attend the Sallie Zetterer school may get their scotchlike license stickers at that school on Saturday morning, August 13, from 8:30 to 11:30 o'clock. Members of the club from the Mattie Lively may get their stickers at their school on Saturday afternoon, August 13, from 1 to 4 p.m. Members of the B&P safety committee will issue the stickers.

Each bike owner must provide the name or make of his or her bicycle, its serial number and its color that it might be properly registered.

This is a protection against the bike's being stolen and to impress upon bike owners the need of exercising proper bicycle safety rules and practices, members of the B&P safety committee say.

and Judge Scarlett will hold a hearing on Wednesday, August 10 on the motion made by the State. If the objection to the hearing date was set on Tuesday of this week at a meeting in Brunswick of Judge Scarlett, Georgia Assistant Attorney General Hugh Harrison and attorneys for the Statesboro and Swainsboro warehousemen.

On Friday of last week Congress Prince Preston spent some time on the warehouse floors observing the sales and agreed that the buyers were not bidding on high government-grade South Carolina tobacco the first two days of the 1960 market.

According to U. S. Department of Agriculture primings were down \$1 to \$3 a hundred on the first two days of the 1959 market, with the largest losses in low quality tobacco. Nondescript of \$4 to \$7 a hundred, while leaf and cutters were unchanged to \$1 higher. The average top price for the state was \$66. There was more low quality tobacco and nondescript offered on the sales floor this year than last year. More lush and less leaf was sold the first two days.

The blue tag law was sponsored by the Georgia Farm Bureau federation and growers who contended the identifying of out of state tobacco would prevent an influx of inferior tobacco from outside the belt.

Russell talks volubly about the problems of education, and the belief that education in Georgia is on the up grade. "I feel that I am fortunate to have the opportunity to work with the exceptionally dedicated teachers of Long County for the next four years."

From all indications the accent on education in Long County for the next four years will be on youth and progress and the state's youngest school superintendent will be in the spot light.
