Farmers Help Support Cotton Group

Bulloch county cotton ginners have all agreed to work with the National Cotton Council and growers this year, R. P. Mikell, president of the Farm Bureau, reports.

At a ginners' and community presidents' meeting Tuesday, the groups voted to cooperate in the council's program of research and advertising of cotton goods. The ginners agreed to serve as the collecting agent for the 10 cents per bale to be donated by farmers. The ginners not present were contacted individually and also agreed to work with the council.

Mr. Mikell pointed out that cotton had always been here and taken for granted, but that the introduction of many synthetic products made it necessary that attention be given some special attention if the present markets are held and any expansion made.

Tobacco Market Remains Firm After Five Days Of Selling Activity Here

Statesboro's tobacco market—Georgia's largest—got a firm but somewhat slow start Thursday and after five days of sales has moved over two million pounds of the bright leaf to buyers for a total of more than a million dollars.

Figures covering sales through Wednesday of this week show a total of 2,619,462 pounds sold, for an average of more than 500,000 pounds per day. This tobacco has brought growers a total of \$1,116,666.35, to average \$42.63 per hundred pounds. This price and poundage is somewhat lower than last year's sales for the same period, but this decline is attributed to the late growing season this year—brought on by long dry spells followed by long rainy periods—and the earlier opening of the market.

Reports from the three warehouse firms in Statesboro indicate that there is much of the common grades of leaf on the floor each day and that prices of these grades are holding up in many cases. The better grades are beginning to appear on the market but have been somewhat slow in coming in. Prices of the better grades are holding up well, warehousemen report.

Sales today are expected to bring the amount past the three million pound mark and the money received will be in excess of a million dollars.

The average price has taken a small drop daily, and warehousemen report this is due to the poorer grades of tobacco which make up a considerable portion of the leaf being sold.

During the first two days of sales a large part of the tobacco offered (some warehouse officials estimated 30 per cent) was purchased by the government under the Tobacco Stabilization program. This week, however, the percentage has fallen off sharply as buyers became more familiar with the support price.

Under this program a farmer may, by paying a five-dollar fee, become a member of the organization and be entitled to its benefits. When this tobacco is offered for sale if commercial buyers do not bid 90 per cent of the parity price as established by the government for that particular grade, the grower may place the tobacco in the program and it is immediately paid for by the government at the 90 per cent parity price. Later, when the government sells the leaf if it is moved at a profit, the extra money reverts to the grower. If it is later sold for a loss, however, the loss is absorbed by the government corporation. A majority of tobacco growers in this section are taking advantage of the benefits offered by the stabilization program.

Grand Jury Holds Quick Session Here

A rapid-fire session of the July Superior Court would up all civil matters and dismissed the July Grand Jury in less than one day Monday. This was the shortest grand jury session held in Statesboro in many years.

The jury, with Emit Akins as foreman and Harry S. Cone as clerk, did not take their seats in the courtroom as Judge J. L. Renfro instructed them not to sit, but to retire to the grand jury room and proceed with their work. In less than a day the jury returned six true bills, the fewest returned since Fred T. Lanier says he has had during his term, and then adjourned.

Main reason for the rapid-fire session was the desire of farmers to get back to their tobacco and other crops. Other than the grand jury and trial juries, very few farmers were seen around the courtroom.

Winding up civil matters in one day, Judge Renfro recessed the court until yesterday when the criminal docket was taken up. This docket of criminal matters was expected to be completed today.

City - County Radio To Be Operating By October 15

Equipment for the new city-county radio setup has been ordered and delivery has been promised before September 15, Mayor Gilbert Cone announced this week.

The City Council took action on the proposal Tuesday and authorized its purchase. Present plans call for the transmitter to be located in the city hall in a room adjacent to the fire station. A trained operator will be on hand at all times the station is in operation.

It is understood that the radio network will serve the city police system, the county police force, and the area forestry service. A main frequency-modulated transmitter, powerful enough to cover Bulloch county, will be installed at the controlling station in the city hall.

Receivers and portable transmitters will be installed in the city police car, the county sheriff's car, the automobiles of the deputy sheriffs, the county policeman's auto, the automobile of the county warden, and in ten various fire protection units of the forestry service.

Matters affecting any of these units will be broadcast and received by all concerned. The addition of this new service is expected with greater or compliance with the requirements of the law. Judge Grants Permanent Injunction

A permanent injunction prohibiting the Ordinary of Bulloch county from calling a special "wet-dry" liquor election in this county was issued Friday by Judge Mel Price, of the Atlantic Judicial Superior Court circuit. Judge Price acted in place of Judge J. L. Renfro, of Statesboro, who had previously disqualified himself.

The injunction plea had been brought by the Bulloch County Association for Legal Control, an organization composed of some 14 licensed liquor dealers in the county. It was based upon the contention that the petition presented to the Ordinary calling for an election was not a valid and legal petition.

Earlier, Judge Price had granted a temporary restraining order until a check could be made to determine if the petition met all requirements of the law. He instructed the Ordinary to make a careful check of the petition as presented and determine if the names contained therein were valid signatures of registered voters of the county. Previous to this, the Board of Registrars had certified the petition contained the required number of names, but no certification had been made as to whether these names were those of certified and qualified voters.

In issuing the injunction, Judge Price ruled the petition, which was composed of individual postcards passed upon a roll of wrapping paper, was not a legal one. In his ruling he said, in part: "... The courts have held that several petitions of the kind under consideration may be used in the various districts of a county, the kind of purported petition involved in this case has never been passed on by an appellate court. New equipment has been ordered and will be installed under the supervision of J. D. Underwood, radio technician.

Congressman Prince Preston Jr. Sets Up His Office Here

Principle H. Preston, Jr., Georgia's First District Congressman, returned "home" to Statesboro this week and immediately set up a "summer office" to handle the volume of activities that go with being a representative. He has established his headquarters in the offices of his former law partner, Col. Hinton Booth.

During the first few days, Mr. Preston has been busy conferring with acquaintances in the district. He plans to make a tour of his district within the next few days and talk with as many of his constituents as possible. "I am delighted," he said, "to be back home and am looking forward to seeing friends all over the district."

One of his first official acts upon returning was to appoint J. Brantley Johnson, representative to the States Legislature from Bulloch county, as his field secretary. Mr. Johnson, a Marine veteran of World War II, will aid Congressman Preston in carrying on affairs while Congress is adjourned.

Also with Mr. Preston in the "summer headquarters" will be his secretary, F. C. Drexel, in January, was one to abolish sugar rationing. The bill was identical with one later passed by Congress, but the measure introduced by Mr. Preston was not considered on the floor of the Republican-controlled House because it was introduced by a Democrat.

His second bill was one to return property purchased by the government to establish Camp Stewart in 1941 to its former owners. Extensive hearings were conducted on this matter but, after two days, it was decided to refer the matter to the Armed Services committee rather than have it remain in the Surplus Property committee, where it was under discussion.

Mr. Preston voted for the income tax reduction measure when it was first considered by Congress. He then voted to override President Truman's veto of the measure. He again voted for the measure when it was reintroduced. "Although this tax reduction measure did not provide enough relief for small taxpayers," he said, "it was at least some relief and I felt honor-bound to support it, inasmuch as tax reduction was one of the main planks in my platform."

Legislation affecting veterans has had active consideration from the Congressman. He voted for and assisted in passage of a bill raising pensions for veterans and dependents of veterans of the Spanish-American war. He was active in promoting passage of the bill allowing veterans to cash their military leave pay bonds. He has supported the bill which would raise the subsistence allowance of veterans attending school under the GI Bill of Rights.

Commenting on his first session in Congress, Mr. Preston said: "This first session has been most educational to me. I have become familiar with rules and procedure and I am now prepared to participate in legislative affairs to a greater degree during the coming term."

Mr. Preston plans to maintain his office here until January 1.

So Mother told them, "You go to the fields and the barn for a good look at tobacco before you visit the warehouses."

One Tuesday the Four Cowboys visited Angus and Annie May Fisher, on Mrs. W. E. Cobb's farm. The Cowboys went first to the five acres where tobacco grew taller than they could reach. As they looked on, Angus was breaking leaves off each tobacco stalk to tuckling them under his arm. When he had an armful he put the tobacco, stems all pointing

The biggest Cowboy learned that the green leaves change their color when the sun burns steadily in the barn to "cure" the tobacco. The stoves go for five days and nights, and are fired hotter and hotter, till the leaves turn a golden yellow

After the crowd passed on, the youngsters watched the tobacco make its last move in Bulloch county. Each bundle was wrapped in a big burlap sheet with the name of the tobacco company

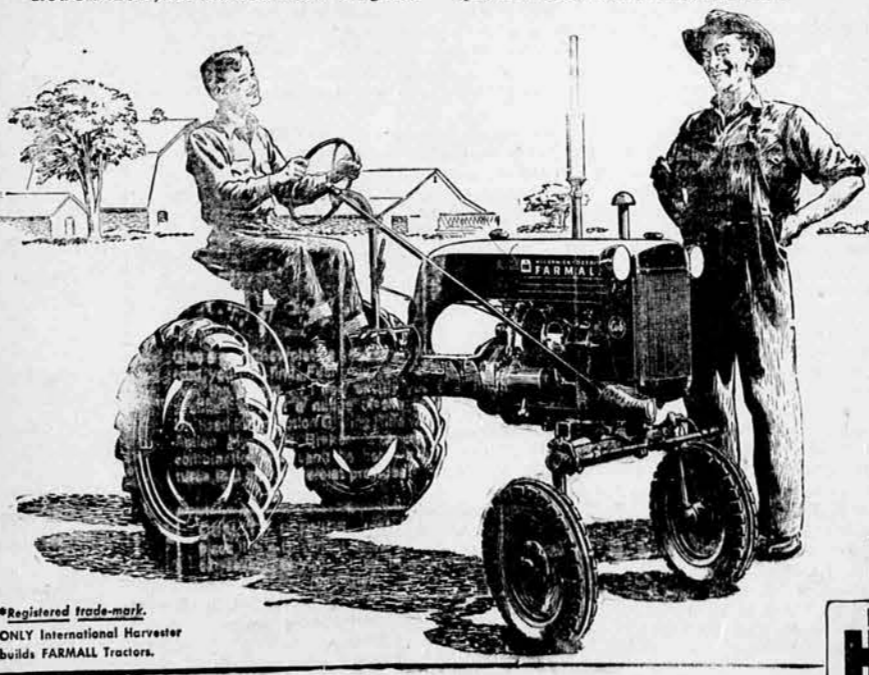

Man Held Here on Murder Charge
Walter Keel, about 20, is being held in Bulloch County jail today on a charge of murder in connection with the death Saturday night of Lloyd Simmons. The charges grew out of an incident which occurred Saturday afternoon involving the arrest of both Keel and Simmons on a charge of being drunk on the streets of Statesboro. Mayor Gilbert Cone gave the following account of the affair as it was reported to him by city police officers: Keel was arrested Saturday afternoon on a charge of being drunk and was placed in the city jail. Later, Simmons, an older man than Keel, was arrested on the same charge and taken to the jail. Police said they noticed Simmons appeared to be sick, that his stomach was swollen, and that he was obviously in need of medical attention. Acting on orders previously given by Mayor Cone, which required that the city physician be summoned when any elderly or sick person was arrested, the arresting officers immediately called the physician, who came and ordered the man taken to Bulloch County Hospital. This was immediately done and Simmons died at the hospital Saturday night. Keel was tried on the drunkenness charge in Mayor's court Monday morning, was fined and released. He was immediately re-arrested pending an investigation into the death of Simmons. Yesterday, W. Meldrim Simmons, of Savannah, a relative of the deceased, swore out a warrant charging Keel with the murder of Lloyd Simmons. Keel was then booked on this charge and moved to the Bulloch county jail. The report of the medical examiner, dealing with the cause of death of Simmons, was not available for publication as the Herald went to press.
