This resolution, "we must stick by it," Mr. Young of the Nevills school questioned the value of the contracts which the teachers are required to sign.

A general feeling of confusion was prevalent over the provisions of the Minimum Foundation Program. Many of the teachers felt that the public misunderstands it and said that the public has not been informed too well, pointing out that too much emphasis has been put on the teachers' salary provision when the more important provisions concern buildings, equipment, teacher materials.

## Portal High School Is Destroyed By Fire

The Portal high school building was destroyed by fire early this (Thursday) morning.

When the janitor reported for work early this morning, he found the building on fire. It was reported about five minutes after seven o'clock. The Statesboro fire department was called and about 18 minutes after seven o'clock it was joined by the Portal fire department in fighting the flames which destroyed the building and did considerable damage to the elementary building.

The new gymnasium was scorched, but little damage was done. The firefighters concentrated on saving the new building.

The loss is estimated at about \$40,000.

As The Herald went to press this morning, Portal school superintendent, Jim Jordan, was in conference with County School Superintendent H. P. Womack.

The fire is believed to have started in the school chemical laboratory.

According to a story detailed "Ludovici, Ga.," on May 3, the body of Fred D. Beasley Jr. has been found.

Fred Beasley Sr. called his wife from Sioux Lookout, Ontario, on Tuesday to tell her the body of their son, who drowned in a Canadian lake while on a hunting trip on November 5 of last year, had been found.

The body of Peter Serson, a resident of Sioux Lookout, was found at the same time as the body of young Beasley. The bodies of Rev. Earl Serson of Statesboro and William Evans of Sioux Lookout were found soon after they were drowned last year.

Mr. Beasley will bring his son's body to Statesboro for burial as soon as possible.

He had gone to that area with the first reports of the lake's thawing.

## Julian Groover to Operate Seed Dryer

The local packing plant has purchased by Julian C. Groover for the purpose of installing a seed-drying plant.

For some three years Mr. Groover has been investigating the need and method of installing such a plant in Statesboro. It is almost essential that blue and sweet lupine seed be dried before they are stored. This will be a major part of the business for the new plant here. However, Mr. Groover pointed out that he would be in position to dry peanuts and other seed.

Mr. Groover thinks the old packing plant will be ideal for his peanut shelling operations as well as the seed drying plant.

He hopes to be ready to operate the plant in a few days.

## Traffic Check Here Shows Drivers, Pedestrians Ignore Safety Practices

Automobile drivers, truck drivers, bicycle drivers, motor-scooter drivers, and pedestrians of Statesboro were unknowingly placed under the microscope on Tuesday afternoon of this week—and what was seen is bad!

As part of the Driver Education and Training Institute being held this week at the Teachers College, 23 teachers in the First District made an intensive traffic check on the streets of Statesboro between 4 and 5 o'clock Tuesday afternoon.

The check was made under the direction of Dr. H. R. Danford, New York University; S. K. Collins, New York University; L. E. S. Burke, supervisor, Safety Education, Department of Public Safety; and Mrs. James F. Coleman, coordinator, Safety Education, State Department of Education.

These teachers found pedestrians ignoring the traffic light and incorrectly crossing streets, found automobile passengers getting in and out of cars in the midst of moving traffic, automobile drivers turning the red light, making turns without proper hand signals, failing to stop at street intersections entering moving traffic, and generally tossing all safety rules into the air, and breaking every traffic law in the book.

Some of the specific findings are as follows:

### JAYWALKING

During a one-hour period May 2, on South Main street between the traffic light and the Post Office, 465 citizens of Statesboro and Bulloch county, and visitors, "jaywalked." Here is the breakdown of the "jaywalkers":

### AUTO PASSENGER CHECK

This check was made on South Main street on the West Main street corner. Eighty-seven cars were checked with a total of 111 passengers. Sixty-nine passengers got out of their cars on the sidewalk of the car. Forty-two passengers got out on the traffic side of the car.

This check revealed that 61 per cent of the passengers got in and out of their cars on the sidewalk side of the car, and 39 per cent got in and out on the traffic side.

Only one passenger made a special effort to get out on the sidewalk side. Not a single driver made a special effort to get in or out on the sidewalk side of the car.

### CORNER TURNING

In the check at the Statesboro Buggy and Wagon Company, 486 cars passed the street intersection. Seventy-two cars turned into Courland street. Four of these drivers were concerned enough

about their safety to give a hand signal.

Thirty-nine drivers turned without any hand signal.

Seventy-five drivers turned right on the corner (coming from the east into Seibald). Only 12 drivers gave a hand signal to indicate their intentions.

The teachers making the hand signal check conduct one-half public is not aware of the fact that these signals are given for their own protection. We suggest that John Q. Public learn the proper signals and use them in the interest of highway safety.

### PEDESTRIANS

During the one-hour check at the traffic light 624 people crossed the street for a total of 972 crossings. (This figure includes those people who crossed and re-crossed.)

Of these 333 made correct crossings (that is they observed the traffic light. They did not step down off the curb on a red light) and 291 made incorrect crossings. The checkers on this corner observed: "Of the incorrect crossings about one-half crossed against the light, and one-half walked out about four or five feet from the curb and waited. One small boy, six or seven, walked in the street and sat on the bumper of a car that was waiting for the light to change. Two college or high school girls stood about five feet from the curb and talked for ten minutes. Then one ran across the street AGAINST the light, still yelling back to her friend."

# A Mother Speaks

HERE'S PART of the trouble—

Maybe it's the root of the whole trouble. Everyone is talking about the trouble now besetting our schools.

Even we had a lot to say.

One week we suggested that the fathers and mothers, with children in school, should get together and work at helping solve the problems now causing our schools to founder.

So imagine our surprise when we learned that there is no Parent-Teachers Association working with the Statesboro schools.

No organized group of parents to work with the teachers of their children to see that their children's right to an education is protected.

The schools in the city have these organizations . . . but we wonder if they are going to bat for their children?

Now comes a mother who writes a letter to the editor of the Eastman Times-Journal, Eastman, Ga. We believe it is worth reproducing here:

Dear Sir:

As a citizen of Eastman with children in school, and not as official spokesman for the P.T.A., I want to tell some of the fathers and mothers of Eastman having children in school, that they have less interest in their school than any group of people I know.

Last Thursday afternoon at the Community House, the Eastman P.T.A., closest link between parents and teachers, gave a tea for all the teachers of the Eastman school. The tea was given because they felt the teachers deserved at least one social activity of this type during their year's work, and because the P.T.A. mothers and fathers wanted to express appreciation to them for their efforts on behalf of the children.

"The Community House was beautifully decorated for the occasion and tables were covered with beautifully prepared sandwiches, and cookies. A large number of mothers and fathers were ex-

pected, because more than four hundred invitations had been extended.

The teachers came and were greeted by 10 or 12 P.T.A. hostesses who gave corsages to the lady teachers, and boutonnières to the three male members of the faculty.

"Minute after minute passed, an hour passed, and TEN people had taken the trouble to attend the tea and spend a few minutes talking with the one group of people who spend more time with their children, probably, than they do themselves.

"Embarrassment was written on the faces of P.T.A. members, and as time wore on, there was a feeling of uneasiness in the air. Embarrassment increased as time slipped by without an increase in the number of invited guests.

At the conclusion of the tea, the number of attendants, outside of teachers and 10 P.T.A. hostesses, remained at TEN.

"It is no wonder to me that our teachers feel that the world is down on them. They are overlooked in most instances, underpaid, and when they are offered direction in the form of a social tea, they are disregarded and ill-treated.

"I have greater respect for the teachers attending the tea. Not one has mentioned the fact that so few of the mothers and fathers attended. But everyone knows they were embarrassed and hurt.

"It is funny to me that mothers and fathers can attend any other kind of meeting or party that comes along, but cannot take the time to attend meetings or parties connected with the school which should come FIRST. If mothers and fathers are not going to be interested in their children, then who is, and how can they ask anyone else to be?"

# The Editor's Uneasy Chair

You and we always observe Mother's Day.

We observe it, despite the commercialism that envelops the observance of the second Sunday in May.

We observe it without wondering how it started. We used to think it was a promotion of the flower and candy manufacturers.

The truth of its founding is just as sentimental as commercialism would have us think it is. Forty-four years ago Miss Anna M. Jarvis of Philadelphia lost her mother, Anna Jarvis, then 41 years old. She was in 1905. Her mother taught Sunday School in St. Andrews Methodist Church in Grafton, West Virginia. Each year Mrs. Jarvis conducted a celebration honoring the mothers of her Sunday School pupils.

Following the death of her mother, Anna Jarvis, then 41 years of age, devoted the rest of her life to establish the Second Sunday in May as a memorial to her own mother and to mothers all over the nation.

The first Mother's Day service was arranged by her in May, 1907. It was held in St. Andrews Church and was dedicated to Mrs. Jarvis and all the mothers of Taylor county.

In 1908 Anna Jarvis persuaded Philadelphia to proclaim the first city-wide Mother's Day. Then in 1912 she succeeded in getting West Virginia to make Mother's Day a state-wide holiday, and in 1913 Pennsylvania followed suit.

Anna Jarvis began making speeches before men's and women's clubs and meetings of all kinds. She carried on extensive

Day permanently and authorized federal display of the flag "as a public expression of our love and reverence for the mothers of our country."

In the succeeding years, Miss Jarvis spent every penny of the moderate fortune left by her mother in establishing Mother's Day as a deep-rooted American tradition. During these years, too, she cared for her younger sister, Elsie, blind since birth.

The carnation was suggested as official Mother's Day flower by Anna Jarvis because it had been her mother's favorite. Gradually the custom developed of wearing red carnations to honor living mothers, and white boutonnières for deceased mothers.

In 1943, a small group of her friends and admirers was shocked to discover that Anna Jarvis was penniless, ill, and nearly blind. They immediately placed her in Marshall Square Sanatorium in West Chester, Pa., where she was comfortably cared for during her declining years.

Last November Anna Jarvis died at the age of 84.

turned the corner and crowded pedestrians. Twelve turned the corner from and in a poor position. Thirty-six cars turned the corner and stopped, and of these 36, all but one stopped in the crosswalk. Thirty-six cars made the turn into North Main street without stopping at the yellow line.

## BICYCLE RIDERS

Twenty-one people rode by the post office on bicycles, and three rode by on motor bikes during the one-hour check. Of these 18 were boys, six were girls. Of these 12 made a turn at the post office, and 12 continued along South Main. Of the 12 who turned at the post office not one gave the hand signal. However, only three were riding on the wrong side of the street. Of the 21 bike riders, 12 were Negroes. The estimate age range was 12 to 50. The conclusion drawn—"Bicyclists do not give signals. Although on the right side of the street the riders were in and out traffic."

## PUBLIC-PRIVATE HAZARDS

In a public and private hazard check made on the streets at random, without selecting any specific area, the check reveals, 12 garages built too close to the street; 9 private drives blocked by shrubbery; 3 railroad crossings with no signs, and buildings too near road crossing; 8 street crossings view blocked by trees; one dead-end street not marked.

Seven street crossings with no stop signs; six street crossings covered by shrubbery (three of these had markings, but were obscured by shrubbery).

The conclusions drawn—Most drives are in better residential sections; most unmarked street crossings in less prosperous sections of the city. Most garages are in these sections.
