Camilla, Hopeful, Winners in Georgia Power Co.'s Champion Home Contest

A little place called Hopeful made hope and hard work pay off, and Camilla, the city that wasn't satisfied with second place, took first.

Within 12 miles of each other in northwest Georgia, Camilla and Hopeful are the two \$1,000 top prize winners of the 1949 Champion Home Town Contest, sponsored by the Georgia Power Company, in which 296 communities were entered and 211 qualified for the judging by submitting progress reports. Since taking second place in the 1948 contest, civic leaders of Camilla had publicly announced their determination to be first this year. Little Hopeful, a community of 200 inhabitants served by an REA line, doesn't even appear on most Georgia maps.

Among the 112 towns that finished the contest in the group of over 1,000 population, second prize of \$750 went to Toccoa and the top prize of \$500 was won by Gainesville. Among the 99 small communities, Chatsworth was second and Nicholls third.

Because of the large number of other outstanding entries, the power company increased the total prize money from \$4,500 to \$5,700 in order to give awards of \$100 each to 12 towns chosen by the judges for honorable mention. These are Arlington, Dalton, Ellijah, Sylviana, Sylvester, and Thomaston; and Buchanan, Danville, Fairmount, Hartem, Jasper and Ludowick.

Eighteen other communities were selected to receive special Certificates of Achievement for the high quality of their civic improvement efforts. These are Brunswick, Carrollton, Cedartown, Easton, Marietta, Milledgeville, Smyrna, Thomson and Tifton; and Alley, Ellaville, Forest Park, Funston, Lisle, Mansfield, Sain, Marys, Sandy Springs, and Watkinsonville.

Final judges of the contest were Raimundo de Ovie, dean emeritus of St. Philip's Cathedral in Atlanta; Dr. M. D. Mobley, state director of vocational education; Mrs. Pauline Parks Wilson, dean of home economics at the University of Georgia; Miss Susan Myrick, associate editor of the Macon Telegraph; and O. M. Jackson, vice president of the Atlanta Chamber of Commerce.

The cash prizes for the six top winners will be awarded at a series of dinners in January.

Hang Out the 'Welcome' Sign

COME JANUARY 2, the football teams Wofford College and Florida State University will meet in the Cigar Bowl down in Tampa, Florida.

Kentucky will play Santa Clara in the Orange Bowl, Maryland and Missouri will meet in the Gator Bowl.

Well, where does Statesboro come in on this "Bowl" business? Statesboro comes in all over.

For it is expected that U.S. 301 will be designated as "The Florida Bowls Route" during the annual football bowl season.

That means that fans following Kentucky will use U.S. 25 through Statesboro to the Orange Bowl in Miami.

Just a Small Crowd...

THERE WAS just a small crowd there that night in our county library. Less than a hundred.

Congressman Prince H. Preston was there.

He had deliberately let himself become a target for questioning by the citizens of this community.

He knew that when he accepted the invitation of the Bulloch County League of Women Voters he was letting himself in for a rough time.

Congressman Preston made a brief statement before he declared "open season on Congressman Preston."

He outlined the fiscal spending by our federal government, his position on the Marshall Plan, his feelings on defense spending.

Then the crowd "lit in on him."

Question after question was fired at him.

And he gave quick, concise answers, free of political double-talk. And those there seemed satisfied.

It's No Bonus or Handout!

LET'S GET SOMETHING straightened out.

Soon after the first of the year, veterans of Bulloch county, together with veterans all over the nation, will begin receiving their share of a \$2.8 billion special dividend being paid on their National Service Life Insurance.

Much misinformation concerning these payments is being circulated.

The \$2.8 billion dividend has been termed a "bonus," "a treasury grab" for the benefit of veterans of World War II. It is being contended in some quarters that the payments are not earned dividends at all but, in reality, just a government handout.

This is not so!

National Service Life Insurance is that insurance that every G.I. was given an opportunity to take out when he was a member of the armed forces of the U. S. It was established by law as mutual insurance, which means that any excess funds which accrue from its operation must be shared proportionately by the policyholders, and returned to them.

It is perfectly true that the government assumes certain financial obligations in connection with this G.I. insurance. This was written into law by the Congress so as to provide those entering service with insurance protection at rates they could afford to pay.

The government assumes the cost of the administration. These expenses are paid from the Veterans Administration's regular appropriations. Congress appropriates funds to cover the cost of all the claims against National Service Life Insurance which results from the extra hazards of service in the armed forces. Unless such claims were excluded, premium rates would have had to be set much higher than they were in order to cover the additional risk.

Claims which arise from other than military deaths are paid from premiums received from policyholders. These premiums are invested and placed in the National Service Life Insurance Trust Fund which is maintained in the U. S. Treasury.

Now the real reason why a surplus of \$2.8 billion is available for the payment of dividends is that there have been substantially fewer non-military deaths among NSLI policyholders than was anticipated by the mortality table upon which the premium rates were based. This was especially true among younger age groups.

Under the law, this money must be returned to the policyholders in the form of dividends. The amount each veteran receives is determined by the face amount of insurance carried, the length of time it was kept in force, and the proportionate contribution of his particular age group to the surplus in the fund.

So the payment is in no sense a "bonus" nor is it a government handout. We feel sure that Bulloch county veterans want this definitely understood.

That means that fans of the Maryland team will use 301 on their way to Jacksonville to meet Missouri in the Gator Bowl. Thousands of football fans will join the regular machine seekers that week end on their way into Florida.

Hundreds of them are going to stop in Statesboro for a place to sleep and something to eat.

Tourist homes, tourist courts, hotels, restaurants, cafes, and lunch counters should make preparations for the "Bowl" traffic.

The deal is a "natural" for the eastern traffic to the Florida bowls. Several mid-western and western routes make excellent connections with the Tobacco Trail—all above Statesboro.

Jesup is going all out for the big trek. Other cities along the route will be welcoming the fans with open arms.

Statesboro's future spot on 301 can be assured. Hang out the "WELCOME" sign.

Citizens interested in better government missed a great opportunity to gain an insight into the thinking of their representative in Congress.

Yet, citizens stayed away in great masses.

Here was a made-to-order opportunity for all to satisfy themselves about the manner in which their Congressman was conducting himself as their representative in the national Congress.

In open forum he submitted himself to the scrutiny of his people.

And his people seemed not interested. But he knows, and we know, that this is not so.

For, come election time, many of those citizens who were not there that night, will be screaming the loudest about the most of which they know the least.

We are pleased with the way our Congressman "met the people" that night. See and hear him.

We regret that more were not there to hear his credit to Statesboro, Bulloch County, and the First District.

And Happiness Ahead

"I'M SORRY you can't get your certificate now," the doctor said kindly, "one of the blood tests was positive."

The bride-to-be began to cry softly. "We had it all planned. We were to get the license today—there was to be a party..."

The groom-to-be hung his head and fumbled with his hat. The doctor said, "You'll be much happier in the long run, the treatment won't take long—maybe a week or ten days. Penicillin works wonders with most cases."

There was nothing to do but accept the verdict. The young couple arranged for the treatment... and planned for the later wedding.

And their future happiness was more assured.

Such is a typical hypothetical case of a young couple wanting to get married and learning that one had syphilis.

Statistics released by the Georgia Department of Public Health show that since the pre-marital law went into effect, making a blood test mandatory before the issuance of a marriage license, there have been a total of 306 positive blood tests with syphilis indicated, comprising 4.1 percent of the total of 7,509 blood tests taken under the law.

This means that 306 people anticipating marriage have been badly disappointed.

But it also means that, when the syphilis is cured, the couple stand on a firmer foundation for future happiness in their man-wife relations.

The 306 people who have shown up with positive blood since August 25, 1949, justifies the passage of the pre-marital laws.

Syphilis is highly infectious and sometimes unnoticed in the early stages; but in the later stages it can kill and cripple. Infected mothers usually pass the disease on to their offspring.

The recently completed TB-VD campaign in Bulloch county now can mean that many couples contemplating marriage may go ahead and apply for their marriage license, knowing that their pre-marital test will be negative.

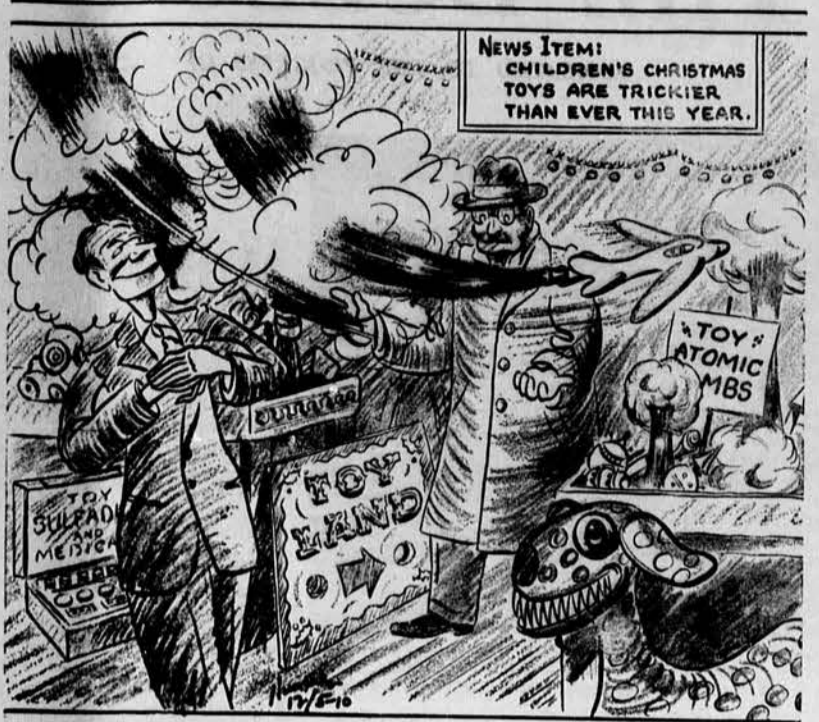

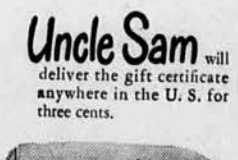

Cotton Farmers Notified to Vote

Cotton farmers throughout Bulloch county will be receiving notices this week of the national cotton marketing quota referendum scheduled for Thursday, December 15.

On that date, "eligible" voters will go to the polls in every cotton-growing community in the United States to decide if marketing quotas are to be used for the 1950 crop. A two-thirds majority of those voting is required to approve quotas.

The Bulloch county office of the Production and Marketing Administration defines an eligible voter as any person as landlord, tenant, or sharecropper—had an interest in a crop of cotton produced in 1948. Only one vote may be cast by each eligible producer, however, even though he may have had an interest in cotton grown on more than one farm.

The referendum notices that were mailed to cotton farmers from the county PMA office include a leaflet that answers many of the pertinent questions about the cotton situation and how the marketing quota program would operate.

Mr. M. L. Taylor, county PMA committee chairman, explains that the notices were sent to every KNOWN eligible voter in the county. Any person who believes he is eligible to vote in the referendum and does not receive one of the notices is asked to contact the PMA office in Statesboro.

Mrs. H.V. Franklin Wins State Living Room Prize

Mrs. H. V. Franklin, of the Register community, has been named state winner in the Georgia, 1949, living room improvement contest, sponsored by Rich's Inc., Atlanta.

Rich's presented Mrs. Franklin with a \$200 gift certificate for a luncheon in the Magnolia Room yesterday honoring the state winners in the living room and kitchen improvement contest.

Mrs. Franklin's son, H. V. Franklin Jr., her daughter, Mrs. Ward Morehouse of New York City, and her daughter-in-law, Mrs. Carl Franklin, were with her at the award presentation. Miss Irma Spers, county home demonstration agent, and Miss Dot Johnson, assistant, were also present at the luncheon.

Mrs. Franklin financed her living room improvement work by growing and selling vegetables and herbs. She developed the hobby of growing these plants when her children were away at school and she now sells approximately 50 varieties of vegetables and herbs.

H. V. Franklin Jr., president of the Register Farm Bureau, helped his mother in remodeling the living room in their home. He did all carpentry and woodwork and Mrs. Franklin did all the drapes, slip covers, and painting. And she admitted, with a smile, that "Maybe I did help H. V. a little with the hammer and saw."

In describing the work on the project she says: "Our old living room was 16 by 16 feet with a ceiling 10 feet high, and there were two small windows in the room."

"The improved living room was extended over an eight-foot porch adjoining it and is now 22 feet by 16 feet. A picture window 10 feet wide and five feet high replaced the two small windows on the west side and now furnishes plenty of light throughout the room."

"The flooring was leveled in the old living room and had to be raised three inches in one corner. This old floor was left for subflooring and a new oak floor was placed over it."

More than 300 Georgia farm women competed in the state contest.
