

It Was Wonderful To Be Alive THE BOY was just twelve years old. He

was a handsome youth and it was wonderful to be alive.

That is, it was wonderful until that day when he got off the school bus and saw there beside the road a stray dog. He reached out to pat the dog on the head. The dog snapped at the boy and sank

his teeth in the bridge of the boy's nose. The dog was mad ... a victim of rabies.

Doctors began giving the boy the vaccine that same afternoon. But the wound was too close to the boy's brain. The rabies worked fast. The boy became nauseated He vomited. He suffered terrible headache. He became extremely nervous and irritable.

He died.

This young, fine, handsome boy, whose family lives not far from Statesboro, died. He died because somebody did not have his dog innoculated for rabies.

He died because somebody cared noth-

ing for the lives of his neighbors. That boy died because somebody cared nothing for himself, nor his own livestock.

The dog population in Bulloch county is between 4,500 and 5,000.

There's a law which specifically states that dogs must be innoculated for rabies. Yet official figures indicate that less than one-half of the dog population in Statesboro and Bulloch county has been

innoculated. That means that the life of every child, the life of every citizen in this county, is vulnerable to the miserable death which

results from rabies carried by a rabiesridden dog. That means that every cow, every hog, and every other dog in this community is

vulnerable to the teeth of a dog with If all the dog owners in Statesboro and

Bulloch county had obeyed the law which makes innoculation mandatory on July 1 of this year, then you and you and you could today feel complete freedom from fear of that dread disease, rabies.

But with July 1, one month gone, only 50 per cent of the dogs in this county had

peen innoculated. That means that when you see two dogs on the Streets of Statesboro, or in the front yard of your country neighbor you have only a 50-50 chance of immunity from rabies-if you or your child should be attacked by one of the dogs.

Not a very wide safety margin, is it? We've been lucky.

There's been little dog rabies in our county. There's been no typhoid, no diptheria,

either-but only because of the constant vigilance on the part of our health department, our school authorities, and our natural fear of these diseases.

But there's no assurance that if we should relax this vigilance that we would not have an epidemic of typhoid, of diptheria.

Why, then, the indifference to this killer, rabies?

Recently the veterinarians published their rounds of visits in the county, announcing when they would be where, and urging citizens to have their dogs innocu

The response was discouraging. Could it be that the increase of the innoculation fee from \$1.00 to \$1.50 the veterinary receives means that much to a dog owner that he would sacrifice the welfare of his children, his family, his livestock and himself for a mere 50 cents? Seems incredible!

Our health department urges dog owners to realize the seriousness of this indifference to the possibilities of an epidemic of rabies.

And right now is the most dangerous time of the year. There's a tendency for dogs to run about in packs. There's a tendency for dogs to stray. Visualize your child suffering as that
