U.S. Cotton Report Indicates Largest Own Crop In History Your

OFFICIAL ESTIMATE PLACES THE 1937 COTTON CROP AT 18,243,000 BALES, 670,000 MORE THAN THE OCTOBER ESTIMATE. HOME

Government estimators, on November 6, estimated the 1937 cotton crop crease your equity in your own home at 18,243,000 bales, which if realized, each month, leading to the happy endwill be 265,000 bales more than the ing that finds You in full possessi previous largest crop of 17,978,000 of debt-free home ownership, bales in 1926. The new estimate was 670,000 more than the indicated production one month ago.

This official forecast will add to the difficulties of government leaders attempting to share a new farm pro gram for the special session of Congress which meets this month.

The crop board also estimated the average yield per acre at 258.8 pounds for the entire cotton belt. This tops for the entire cotton belt. This tops all previous yields. This year's crop is being produced on 33,736,000 acres

Abandonment of acreage this year was much less than average and favther and other condit ombined to boost the productio timate each month after the first of ficial forecast in August.

It is rather interesting to note that the 1937 cotton crop in China is not expected to exceed 4,000,000 bales, compared with earlier estimates 4,200.000 bales. This crop estimate of 4,000,000 will be an all time record for China. Plantings were incre from 10 to 15 per cent this year.

The Turkish cotton crop this year is likely to establish a new high record by exceeding 250,000 bales, according to the Cotton and Cotton Oil







THANKSGIVING To recall the circumstances of the first day of thanksgiving may serve to remind us of how much more we have to be thankful for than had those early Pilgrims. History tells us that of the one hundred and two emigrants that landed on the bleak and rocky coat of Cape Cod Bay in the winter of 1620, almost half died before the following winter fairly set in. Today in our comfortable country and city homes, we cannot even imagine the sufferings of the survivors, both from destitution and the inclement weather, which they were not prepared, either as to clothes or habitations, to brave. The most of the brave people were not inured to hardships; among them were delicately nurtured men and women. They staked and laid out two rows of huts for the nineteen families that composed the colony; but within the first year they had to make seven times more graves for the dead than houses for the living. Notwithstanding all their trials and hardships, these brave founders of a great and glorious race had so much to be thankful for that they had to appoint "an especial day on which to give especial thanks for all their mercies." So they agreed among themselves that, since their prudence and forethought had been so wonderfully blessed of God, they would send out four men hunting, that they might rejoice together in a special manner after the fruit of their labors had been gathered. According to the historian, barley and Indian corn were the'r only crops; the "peases were not worth gathering; for, as we feared, they were too late sown." This was under the good Governor Bradford. The four men who went hunting brought in as much game as served the company for a week. The recreations of the day consisted of the exercises of their arms. Massasoit, the Indian chief, and ninety of his men, coming among them for three days, during which they were entertained and feasted by the colonists, the Indians killing and bringing to the feast five deer. This was in 1621, and was the beginning of Thanksgiving Day in America.

### AN EMINENT GEORGIAN

In the 1937 issue of Eminent Georgians, a book perpetuating the lives and achievements of the state's leading personalities, Mrs. Julin C. Lane is listed.

This volume says of Mrs. Lane: "Of the noted women of Georgia, none is more qualified for leadership by birth, education and ability than Mrs. Julina C. Lane. She has long been an outstanding factor in club and civic activities of her community and State and is regarded as one of the foremost geneologists in the South. She is the author of the idea of Georgia County Histories and did much to secure the passage of the bill creating County Historians. She is at present historian for Bulloch, Screven and Effingham Counties, a section of Georgia's first settlement."

Recognition was given Mrs. Lane for her work two years ago when she was one of five of the state to make welcome addresse to the President when he came to Atlanta. In this address she used the same conclusion that her great-great uncle used when he welcomed President George Washington to his school in Augusta:

"May ye from heaven's sublime eternal scenes See future millions happy through your

And let mankind this serious truth confess: None e'er was praised so much, none ever flattered less."

When the question of cotton consumption comes up in a crowd there is always one who mentions the "cotton for highways" use. But that is as far as they go. They have seen mention of it in the newspapers and perhaps in some scientific periodical. So the question arises: "What is there to it?"

It is true that there are experiments now being made in Nevada and are being planned for Georgia and North Carolina. If these ex-

periments prove that the use of cotton in road construction results in better and longer-lived highways, a new use for the southern staple will have been developed which will have farreaching effect upon the future of cotton production.

This is one of the outstanding developments in efforts to discover new uses for cotton, to widen the market and thus reduce, for the future, the likelihood of over-production and its consequent drop in prices.

If it can be shown that cotton can be used successfully in the building of highways then we can look to a new and important market outlet for the south's most important product.

### AN EXPENSE ITEM ON THE FARM

The American farmer works many hours a day-and then, with little or no resistance, surrenders a tenth of his pay to a hold-up

Every day of the year, he donates the proceeds of about an hour's labor to this robber -almost without a struggle.

The total gross income from American farms last year was about nine and a half billion dollars. The total penalty which the hold-up man collected in agricultural communities was a little less than one billion dollars. This represented a gradual increase over the years. Annually, the demands of the thief have grown.

Who is this villain

He is "Mr. Accident." He is the man who was responsible last year for the deaths of some 4,400 persons an tdhe injury of several hundred thousand others on farms in the United States. He also collected a large toll on highways in rural sections. Every accident costs money.

"Mr. Accident" operates especially profitably in rural sections because less has been done there to combat him than in other places. Persons have been more careless in the country; but "Mr. Accident" collected in other communities, too, though not so successfully.

Figures reveal that accidents claim annually more than 100,000 lives in the United States. They permanently disable nearly 400,000 people. ;They temporarily disable nearly 10,000,000 people.

This tremendous toll, when translated into wage losses, medical expense, cost of insurance, and business interruptions, represents a total annual cash loss of approximately \$2,500,000,000.

The proportion of this enormous loss, allocated to the American farmer, is variously estimate dat from 27 to 35 per cent. Hence \$1,000,000,000 may safely be allocated to the farms

They are closing in on this accident villain in one department of human activity-the occupational. This villain hates bookkeepers. In well-organized industries, bookkeepers have been able to compute more carefully the financial losses from accidents because of the workmen's compensation laws. When the enormity of the toll is shown, business organizes to cut the loss. That accounts for the fact that the death losses among the 20,000,-000 industrial workers in the United States have been cut to 1,900 per annum, as against 4,400 per annum on the farms where bookkeepers are not employed.

Let these figures mean something to you. Organize your resources against this foe which takes such a tremendous toll on your farms.





He said also that good results can be obtained by feeding legume hay and silage in limited quantities with each of the rations uring the first part of the feeding period. An animal should be given not more than eight pounds of legume hay and 15 pounds of silage daily with these feeds, he stated. During the lat ter part of feeding period, the hay

allowance might be reduced. Because of its concentrated nature and quick fattening qualities, the agent said, the number 3 ration is recommended for a short feeding period which is likely the case this year, since many animal were secured rather late.
