DECISION OF GREAT IMPORT.

Georgia State Supreme Court Says, Practically, That Trusts Can Be Proceeded Against.

One of the most far-reaching decisions ever rendered by the Georgia state supreme court was handed down Wednesday when the court held that the efforts of the drug firms in Atlanta to prevent the Jacobs' Pharmacy from purchasing goods from wholesale houses was illegal under the common law and contrary to the public policy of the state, which decision means, practically, that trusts and other combinations can be proceeded against under the common law of the state.

The court also held that the anti-trust law of Georgia passed in 1896 was unconstitutional. This was in line with the decision of the supreme court of the United States, which held only a few days ago that the anti-trust law of Illinois, after which the Georgia law was patterned, was unconstitutional.

This, however, does not affect the decision, which is based altogether on the common law. The supreme court has had the matter under consideration since last October. The opinion which was rendered by Mr. Justice Fish is an elaborate one, and deals with the questions at great length.

The decision of Judge J. H. Lumpkin of the superior court, who held that the action of the druggists was illegal, was adopted almost in its entirety by the supreme court. About a year ago the Atlanta Druggists' association, composed of nearly all the drug firms in Atlanta, wrote to certain drug supply houses in the north telling them that Jacobs was cutting rates and if they continued to sell him goods all the drug firms composing the Atlanta association would withdraw.
