## DISPENSARY SNAP SHOTS.

(By Old Citizen.)

The leading advocates of the dispensary in Statesboro, favor it because they expect to make more money by it.

They believe more trade and more people would come to town if the dispensary were here.

Unless they believed that these two propositions were true, they would fight the dispensary, tooth and nail.

Now can the farmers of the county who are without police protection, afford to have one hundred thousand dollars worth of Statesboro liquor turned openly loose among their boys, farm laborers, and saw mill, and turpentine hands?

The big merchants who have goods to sell, think you can, but hundreds of good men in Statesboro and in the county, don't think you can afford to take this risk, and think it is best to let well enough alone.

Statesboro and Bulloch county increased more than \$300,000.00 in wealth last year alone, and wealth that did not come from a dispensary, but in wealth that is held on a firm foundation.

A drunk man and his daughter take no risk to come to town. How will it be when we get the dispensary?

Men reap what they sow, and when you sow more liquor, you reap more drunkards. It is hard for the strong to resist liquor and drunkenness, while the weak cannot resist temptation. Why place more temptation in the way of your weak brother?

You never saw a dispensary man, who wanted the dispensary so as he could get liquor for himself; he simply wants to accommodate the other fellow.

If the "other fellow," can get all he is able to pay for, why have the dispensary at all?

Twenty-five years ago we had no floating population, while now there is a county filled with whites and negroes who carry pistols and Winchester rifles. In the old days when men got full of liquor, they fought with their fists, and now they use the gun and pistol and dirk. Times are not like they used to be in Bulloch.

Instead of wasting our time in yelling for the dispensary, hoping that a few will get rich, at the expense of the many; let us proceed to go forward in adding three hundred thousand dollars of real, genuine wealth to our county each year; that would stand the test of time and eternity, that wealth, that consists, also, in a higher manhood and in a nobler womanhood; that wealth that places mankind and womanhood, above the filthy dollar, that wealth that will bring sober and upright boys who will bless and advance this great commonwealth; that sober wealth which will be a protecting shield to the women and children of this land. And when we give our attention to building up this kind of wealth, our children, and children's children, will go the ways of truth and sobriety, and walk in the paths of peace and happiness.

Editor, Statesboro News,

Dear Sir: Frequent mention has been made recently of the fact that Statesboro did not grow or progress as fast as other business during the times that whiskey was sold here. And you readers have been told that Statesboro did not grow because whiskey was sold in the village and county. Let us see if the facts will confirm this theory. The sale of whiskey in Bulloch county was prohibited by legislative enactment, without consulting the wishes of the people in 1870. Statesboro did not perceptibly increase her business or population or show any signs of prosperity until after the Dover and Statesboro Railroad had been completed.

CONSUL NOT KILLED

The Attempt, However, Was Made to Assassinate Him.

WARSHIPS GO ANYHOW

Roosevelt Determined to Show "Un-speakable Turk" that Lives and Property of Americans Will be Protected at Any Cost.

According to advices from Constantinople it transpires that the report that United States Vice Consul Magelsen was killed in Turkey.

Ships Not Recalled. A dispatch from Oyster Bay says: President Roosevelt Friday night recalled the United States warships at Washington confirmation of the Associated Press dispatches from Constantinople and Beirut which show that the report of the assassination of Vice Consul Magelsen at Beirut is an error.

The president will not countermand the order to Rear Admiral Cotton to proceed with the cruisers, Brooklyn, Michigan to Turkish waters. The attack on Mr. Magelsen is regarded as an incident which points to the necessity of a demonstration which will have the effect of insuring the protection of Americans in the Turkish empire.

The president expressed gratification that Vice Consul Magelsen had escaped without injury from the assault of the would-be murderer.

For several hours Friday President Roosevelt and Secretary of State Hay were in conference at Sagamore Hill. They discussed every suggested phase of the situation in Turkey.

At 11 o'clock Friday night a telegram was received by Secretary Loeb from Acting Secretary of State Loeb at Washington communicating the text of a cablegram from Minister Leischman at Constantinople, conveying the Associated Press report of the inaccuracy of the report of Consul Magelsen's assassination. As soon as the message from the apartment was deciphered, Secretary Loeb communicated its contents to the president by telephone.

The text of Minister Leischman's cablegram has not been made public. It can be said to be the purpose of President Roosevelt to afford American citizens in the disturbed provinces of Turkey all the protection possible. For that reason and for others, which may develop in a short time, the decision is reached that no change at this time will be made in the orders to the European squadron. Admiral Leischman will proceed with his vessels to Turkish waters with the idea of safeguarding fully American and American interests.

Cruisers Proceed to Turkey. Nice, France, August 25.—The United States cruisers Brooklyn and San Francisco left Villefrance at 8 o'clock this evening for Genoa and Beirut.

Negro Association Holds Rally. The Colored National Emigration and Commercial Association of Georgia concluded a two days' grand rally at Valdosta Wednesday night.

FOR PHILIPPINE SCHOOLS. New Education Measure Provides \$72,000 for First Year's Expenses.

A Manila special says: The new education bill has just become a law. It appropriates the sum of \$72,000 to cover the expenses of the first year.

Further provision that one hundred of the best qualified students, securing at least 75 per cent on each subject at an annual examination, shall have the privilege of going to the United States to complete their education at institutions designated by the governor.

SEEK TO LEASE RAILROAD. Governor of North Carolina Recalls Proposition from Private Parties.

Governor Aycock, of North Carolina, has received from private parties a proposition to lease the Atlantic and North Carolina railway, the capital stock of which is \$3,000,000, the state owning two-thirds. The proposition is for a fifty-year lease, the interest to be paid according to the length of time, but averaging 2 per cent.

Regarding Division of School Funds. An important question relative to the division of school funds as between local school systems operating under special acts of the legislature, and the counties in which local school districts are located, has been rendered by Attorney General John C. Hart on the request of State School Commissioner W. B. Merritt.

Attorney General Hart holds that this division must be made on the basis of the school population of the local school districts. Some of these have held last the division should be made in accordance with the school attendance, and others have pursued a different method.

This opinion does not in anywise affect the systems in the larger cities, such as Atlanta, Savannah, Columbus, Macon and elsewhere in the state, but it will affect materially several of the local school districts which do not contain large towns or cities.

May Solve Murder Mystery. A negro believed to be the murderer of Bertha Jackson, the little girl whose death body was found in the woods near Locust more than three years ago, was arrested and locked up in the DeKalb county jail a few days ago. It is believed by the Georgia county authorities that the mystery surrounding the terrible tragedy is about to be solved at last.

The prisoner is Matt Williamson, the same negro youth who was held on suspicion when the crime was committed, but who was subsequently released as there appeared to be very little evidence against him. He left the county and went to a farm near Decatur, where he resided up to the time of his arrest.

It is said now that new evidence has developed which will make a strong case against the prisoner. Bertha Jackson was the adopted daughter of a man named Howers, who ran a dairy farm near Decatur. She was missing one day three years ago and a week later her dead body was found a mile from the farm and covered up under a clump of bushes. The crime created a widespread sensation and the coroner held an inquest which extended into many weeks.

The negro under arrest continues to affirm his innocence and tells about the same story he told before the coroner's jury.

Vagrancy Law to be Tested. The constitutionality of the vagrancy law is to be tested. Though operative less than two weeks the new law has been given a prominence few laws have acquired after years of usefulness, the prominence coming because of the energetic manner in which it has been carried out in nearly every city in the state.

But in the city court at Macon, a few days ago, the first obstacle was thrown in the way of a complete and quick enforcement of the new act.

Among the negro women of Macon against whom charges of vagrancy have been preferred and who have been locked up is Ella McQuirter, a negro woman who appears to have some money and is friends with the ones suggested at the hearing. She had been before Judge Robert Hodges her attorney, Colonel Cooper, arose saying: "Your honor, I represent this defendant, and as the act under which she is being tried within itself, guarantees to every defendant a trial by jury, as attorney for the woman, I respectfully request that she be released from the jail, and that I make this demand."

Judge Hopkins admitted the correctness of Colonel Cooper's presentation of his case and the trial was set for a later date.

If he loses this trial Colonel Cooper says he will fight the case through all the courts.

The New Game Law. Widespread interest is being manifested in the two bills protective of birds and fishes passed by the general assembly at its recent session.

First under the new law, no wild turkey, pheasant, partridge or quail can be shot, trapped, killed or ensnared between the 15th day of March and the 1st day of November of each year.

No dove can be killed, snared or trapped between the 15th day of March and the 15th day of June of each year. It is not lawful for any person to kill, ensnare or entrap a greater number than jays doves any one day, whether on baited or unbaited grounds.

Snipe or wood duck and woodcock cannot be killed between the 1st day of February and the 1st day of September each year.

It is unlawful to remove from the nests or to destroy the eggs of any of the birds protected by this act.

It is unlawful for any person, except on his own lands, to kill or entrap any wild turkey, quail, dove or deer for the purpose of selling the same, provided that one may obtain a \$25 license to hunt for sale, but during the hunting season only. This provision is operative without the heretofore required consent of the grantor.

Partridges cannot be shipped out of the state at any time, nor can they be trapped except on one's own lands and then during the hunting season only.

It is unlawful to put walrus leaves or walrus huts, devil shostrains or any other poisonous substance whatever in any of the waters or running streams of this state.

It is unlawful to catch any fish with a seine, net or like device between June 1 and September 1 of each year, provided that one may fish with hook and line and by means of a cast net, or other device, any stream in the waters of this state during that four years from the date of the approval of this act.

That a radical provision of law, but it is responsive to the situation. Streams in which sturgeon were super-abundant have been practically depleted of this noble creature. It is unlawful to use dynamite or other explosive or destructive substance for the purpose of killing fish.

Monthly Letter of Commissioner Stevens.

AN INTERESTING REVIEW.

Census Report of Miscellaneous Vegetables Raised in Georgia—Value of Horticultural Products—Wines of Georgia Are of Fine Flavor.

Not only the staple crops demand the fostering care of the Department of Agriculture, but the rapidly growing fruit industry deserves also our occasional notice.

Hon. L. G. Powers, Chief Statistician for Agriculture, in his report to Hon. W. R. Merriam, Director of the Census, says: "Comparisons of the yield of orchard fruits, when made by decennial years, are given little significance, as the yield of any given year is largely determined by the nature of the season."

Three striking facts present themselves in the consideration of the season for sea island cotton that closes on Sept. 1. These are that the receipts will be the largest on record.

By the census report of 1890 shows a production of 8,230,000 pounds. Most of these are sold as table grapes and bring high prices in the northern and western markets.

Georgia has lost none of her reputation for watermelons, and is beginning to take a high rank also in the production of cantaloupes.

PECAN AND OTHER NUT TREES.

The culture of pecan is beginning now to attract considerable attention. The census of 1900 reports 30,455 pecan trees yielding 27,440 pounds of nuts.

VEGETABLES.

Census report of 1900 the miscellaneous vegetables raised in Georgia were valued at \$3,069,206; the sweet potatoes at \$2,354,309; the Irish potatoes at \$203,533; onions at \$41,592; dry peas at \$958,241; dry beans at \$17,382.

TOTAL VALUE OF ALL AGRICULTURAL AND HORTICULTURAL PRODUCTS.

The total value of all the agricultural and horticultural products of Georgia in 1890 was reported at \$86,248,743. This department, however, has later figures than those. The Agricultural year book of 1900, issued in 1901 by the U. S. Department of Agriculture, gives us the production and value of our crops in 1900. Cotton is that year brought in 1,418,300 bales of 50 pounds more than in the previous year or census year.

A NOVEL DEPARTURE

Agricultural Course For Rural District Schools. AS NOW TAUGHT IN GERMANY

There the Common Schools Have a Garden Attached and Pupils are Given Practical Instruction in Agriculture.

Most of the common schools in the smaller German villages have attached to them a small garden. Through these gardens are generally for the use of the teacher and his family, occasionally some wide awake teacher uses his garden as a means of instruction.

Mr. C. B. Smith, of the office of experiment stations, United States Department of Agriculture, has given us the benefit of his observations at Aiter, a village of 2,000 inhabitants, in the German Rhine province, between Bonn and Cologne. Mr. Smith, who visited this village in 1899, gives the following account of it: "The whole region lying about the village is intensely farmed and farms practically contain 400 pupils and all teachers in this school, as in all others in this province, two hours instruction weekly in fruit culture, gardening and farm management during the last two years of the course is required.
