They have shown what they can do in the way of boycotting our goods, and now they propose to suspend operations for a season in order to give Congress an opportunity to lift our boycott against Chinamen who come here on business or pleasure errands and who are not to be classed as coolies. This is a form of reasoning which will not be misunderstood. Congress will be duly impressed.

Mr. Marshall Field, now on his second honeymoon, tells a reporter that marriage is a good thing if one gets the right woman. Undoubtedly. But how can one tell? Take Dr. Carl Witzhoff, for example. He has married eighty-four, according to all accounts, and continues to be dissatisfied. Mr. Field also makes "a strong distinction between speculation and judicious investment"—which induces the suspicion that he is about to start an insurance company.

The intrepid Kaiser, wishing to complement his fellow potentate of Mexico, imported the most lusty native of Tangier he could find and incorporated him in the imperial household. Fremont returns of the new State census of Massachusetts show a population of 2,908,058—a gain of 103,012, or nearly seven per cent, in five years. In the same time Iowa has lost about 15,000 people. Iowa is a rural State, and while it is nearly seven times as large as Massachusetts, with incomparably better land, it has little over two-thirds as many people, and it is losing inhabitants, while crowded Massachusetts is steadily gaining. Massachusetts, with 300 persons to the square mile, is more densely settled than any country of Continental Europe, except Belgium and Holland, and yet a considerable part of its small area is wilder and more thinly peopled than any portion of Iowa. Its masses are in the cities.

PRESIDENT IS SHOCKED

At Insurance Scandals and He May Take a Hand in the Probing.

Confers with Gov. Higgins.

Governor Frank Higgins of New York was a dinner guest of President Roosevelt at the White House Monday night. Invited to meet and dine with the governor was Secretary of State Root and Postmaster General Cortis.

The conference, admittedly important, began at the dinner table, and continued until a late hour. The president invited Governor Higgins to Washington to discuss with him the New York political situation. The whole subject was considered with special reference to the disclosures made before the insurance investigating committee.

President Roosevelt naturally is deeply interested in the situation in his own state, as were the three participants in the conference. The evidence taken at the insurance inquiry has involved several politicians, and that subject was discussed thoroughly at the conference.

The subject of chairman of the republican committee of New York was discussed. The president made the following statement: "I am very solicitous about the political conditions in New York. It is said that he was not for or against any particular man, and does not propose to interfere in the selection of a chairman of the committee, but is anxious that those in charge will be a man of the highest character and reputation."

"That is the only report, gentlemen, I am authorized to make in relation to the conference." Governor Higgins declined to enter into any discussion affecting former Governor Odell and his continued leadership of the party in New York. Governor Higgins left at once on his return to Albany.

STRIKE IN RUSSIA FALES.

"Reds" Now Plan Political Upheaval to Accomplish Purposes.

A St. Petersburg special of Monday says: With the outbreak of the strike the leaders of the "reds" say they will now devote their energies to the preparation of a universal political strike to sustain the revolutionary program when the national assembly meets. These plans, which were suddenly set by the precipitation of the railroad strike last month, are exceedingly ambitious, involving the co-operation, not only of workmen of the cities, but of the peasantry, and, if possible, the army and navy.

The propaganda among the soldiers and sailors will be pushed energetically. The leaders already claim that they have organized the peasantry in five districts of Kharkov province. The peasants having agreed not to work for the landlords when the strike is called. They anticipate that the famine which is at the doors of almost 15,000,000 peasants of the central provinces, according to estimates, will prove an effective ally of the agitation, as they can promise to give the peasants land to an unlimited extent.

JUDGE MUZZLES THE PRESS.

Alabama Court Threatens to Send Reporters to Jail.

A MUTINY IN ARMY

Is Report From Manchuria That Worries Nicholas.

MANY SOLDIERIES ARE SLAIN

Workmen Issue Proclamation to Soldiers and Sailors Expressing Sympathy and Aid in the Struggle for Freedom.

A mutiny in the Manchurian army is the latest sensational rumor in St. Petersburg. According to the report, the emperor has received a dispatch from General Linvitch, telling him of a revolt among the troops, which was suppressed only after a regular fight, in which many soldiers were killed or wounded.

Forty-two officers are reported to have been shot for participation in the conspiracy. No confirmation of the rumor is obtainable from the officials of the war office. Troops have taken possession of the Moscow railroad station and the road will be reopened by means of railroad battalions. The resumption of traffic on this road insured supplies for the capital.

The workmen's organization Friday addressed the following appeal to the soldiers and sailors: "Comrades and Brothers: For a long time we have misunderstood each other. Your officers taught you to regard us as enemies of the fatherland and as criminals whom you should shoot, beat with your whips and butcher with your bayonets. Our struggle for the people's freedom and the people's well being has been depicted to you as a revolution against the fatherland, which you are obliged to suppress."

"Many of you, believing this, have shot your own brothers, filling the streets of our towns with blood. The case is now altered. The eyes of many of the soldiers and sailors have been opened. They understand that all of us are brothers, and that we are sons of the same nation whose common enemies are your commanders and those in power. They understand that the liberty of the people is their own liberty and the good of the people their own good."

"The men of the Black Sea fleet at Kronstadt stood against their commanders and identified that they wanted to lead the lives of men, that they wanted liberty and they associated themselves with the cause of the people. A hundred sailors at Kronstadt have been handed over to a court martial and today or tomorrow may be executed. Knowing this, the workmen of St. Petersburg struck, demanding the release of our soldier and sailor brothers and the abolition of court martials and the death penalty."

"Is it possible that you, soldiers and sailors, will not arise and help your brothers at Kronstadt? Is it possible that you will remain hand in hand with the murderers of your brothers at Kronstadt? The cause of the workmen and the sailor is our cause, and so we have gone out on strike. You must say everywhere 'the cause of the workmen is our cause and the struggle of the workmen is our struggle, and you must associate yourselves with the struggling people. You must strike and refuse to perform the duties imposed on you. Do not listen to the word of command calling you to put down the workmen's movements. Let not one shot be fired by you against the people. 'Down with your bloodthirsty commanders! Long live a free government and a free people!'"

CASTRO HOLDS BACK CASH.

Refuses to Pay Second Installment on French Claims.

The foreign office is advised that President Castro has refused to pay the second installment of the Plumley arbitration award. The arbitration covered damages sustained by French citizens in Venezuela during revolutionary periods prior to 1905. The judgment was in favor of France, which was awarded about \$650,000, and President Castro paid the first installment of the award three months ago.

Epitomized Items of Interest Gathered at Random.

Governors Accept Invitation. Governor Howard of South Carolina and Governor Broward of Florida have accepted the invitations to the Atlanta chamber of commerce to attend the annual dinner of the organization on the evening of November 23 and participate in the discussion regarding the proposed 1910 exposition.

A New Town Launched. The new town of Gough, in Burke county, was formally opened to the public last week and investors for miles around were on hand to buy lots, which were offered for sale, and the first day's work plainly indicates that Gough will, in a very short time, be a thriving and progressive little town.

Sanford's Plea Refused.

Solicitor General Ennis, at Rome, has filed a demurrer in answer to the appeal of Vincent T. Sanford for a speedy trial. The solicitor, in his answer, says there is no law of force in Georgia authorizing such proceeding as that filed by Sanford in this case; that the demurrer is not right, by rule nisi to call upon the state in this peremptory manner by demanding when his case shall be tried.

Ready for Georgia Monument.

The Valley Forge national park is ready for the erection of monument, according to a letter to Governor Terrell from Governor Pennington of Pennsylvania, and Georgia, as one of the original states, is invited to arrange to mark with a suitable monument the location of her troops on that famous field.

Grady's Quota of School Children.

State School Commissioner Merritt has received reports from Grady county going to show the extent of the new county's school population. This was arrived at by estimate and agreement between the new county and the two old counties from which it was created. Grady takes 2,421 school children from DeKalb county and 2,722 children of school age from Thomas county, making a total for the new county of 5,143. The distribution of the state school fund is based on the school population.

Farmers Urged to Sign Pledge.

President M. L. Johnson of the Georgia division of the Southern Cotton Association has issued a call to the farmers to sign the pledge in the hands of the cotton association officers not to sell their cotton under 12-1/2 cents. He calls attention to the fact that this pledge has been violated in some instances, and urges the farmers to keep up the fight and win it. He declares that this disregard of the pledge will mean that the remainder of the crop will have to be sold for 15 cents, or more, in the south, a rightful share of the wealth thus produced.

Howell Challenges Smith.

Following his formal announcement as candidate for governor, Hon. Clark Howell says he will take the stump in January and challenges Hon. Hoke Smith to meet him in joint debate. Mr. Howell announces that he is against "distastefulness" and believes he believes it to be dangerous to the best interests of the state; shows why; favors strict railroad regulation; is against free passes; believes in "building up" not "tearing down"; is opposed to any policy or state government formulated, intended or administered to deter the investment of foreign capital in Georgia; and to confiscate such capital when so invested, favors election of railroad commissioners by the people, and favors a liberal and generous support of our public school system and the passage of such laws as will secure to the teachers the prompt payment of what is due them for their invaluable services.

New York, November 21.—There was a wild bull movement in cotton following the giving out of the ginners' report this afternoon. The May option advanced 97 points, or almost a cent a pound in a few minutes. There was a jump of 40 points between two sales.

There was an excited scene on the floor of the exchange, as the brokers fought one another to buy. Estimates as to the showing of the report had averaged close to 8 million bales, and when the actual figures were published showing 7,498,167 bales ginned to November 14, the rush to buy followed.

HIGH RECORDS REACHED.
New high records for the season were soon reached. The confusion was so great that different prices quoted at the same time, at different points around the rings, at some instances there were gains of 10 to 20 points between sales. Joseph H. Healer was a leader of the movement which caused the staple to leap \$5 a bale within five minutes, adding \$50,000,000 to the value of total year's crop.

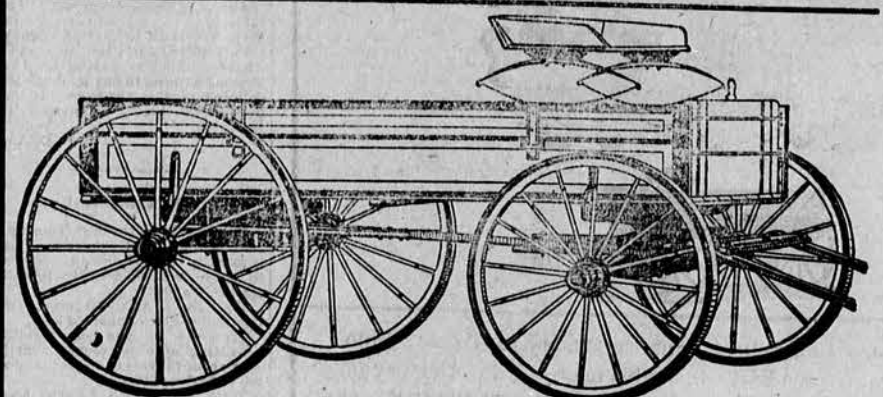

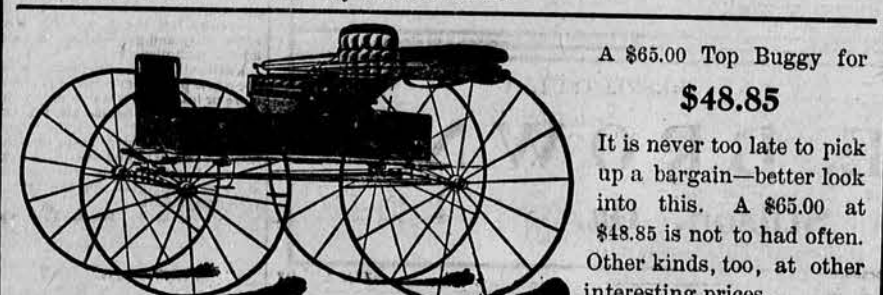
