## EDITORIALS

Give us the farmer who takes time to look up, now and then, to see what is going on in the world about him. Living is not all in bending the back over the hoe in growing good crops, above the Indianapolis News. Life is more than a living. There is a rut in farm life, from which every farmer should try to turn.

Great changes have taken place since the Spanish war broke out eight years ago—changes economic and social as well as political, declares the New York Evening Mail. We now care a good deal about foreign countries, and about their products too, for our imports have almost doubled in the seven years since 1898.

Farmers in southwest Texas get so much money from poultry and eggs and garden truck between cotton seasons that they are almost indifferent about the cotton market now, says the San Antonio Express. It used to be that they only had ready money for a short time during and just after the cotton picking season, but now, thanks to truck farming and more varied industries, they have their pockets bulging out all the time and are decidedly independent.

When you go for a long tramp do not bother to take a lunch with you, advises the New York Evening Mail. Just put a half dozen lumps of sugar in your pocket and eat them when you get tired and hungry. You will at once find your strength and freshness renewed. This is what Dr. Lee, professor of Physiology at Columbia University, and author of several important works on the vital processes of life, firmly asserts. Fatigue, according to Prof. Lee, is a result of certain chemical changes in the body, due to muscular exertion. Sugar, taken internally, arrests and prevents these changes. The sugar, to be specific, replenishes the carbohydrate that is wasted by exertion and causes the fatigue due to this waste to disappear.

Meteorologists are interested in recording observations at high altitude by means of kites, and lately at the aeronautical observatory at Lindenberg, Prussia, a record for height was made, a kite being sent up to an altitude of 21,100 feet. This was accomplished by sending up six kites attached to each other by the use of a length of wireline approximating 48,000 feet in length. The instruments carried by the kite recorded a minimum temperature of -13 degrees F. as compared with 41 degrees F. at the earth's surface. At the maximum altitude, continues Harper's Weekly, the wind blew at a rate of fifty-five miles an hour as compared with eighteen miles an hour at the surface. This maximum altitude exceeds by nearly 1100 feet the previous record made by M. Tisserand de Bort in the Baltic Sea flying his kite from a Danish gunboat.

## VERDICT OF GUILTY

Against Greene and Gaynor Quickly Rendered by Jury.

## LONG TRIAL AT AN END

Famous Fugitive Defendants Were Charged With Conspiracy to Defraud Government and Convicted on All Counts

Benjamin D. Greene and John F. Gaynor were found guilty of conspiracy against the government, presenting false claims and embezzlement in the federal court, at Savannah Thursday afternoon.

The defendants were found guilty with no recommendation, upon each of the indictments. The verdict was returned a few minutes before two o'clock, after the jury had been out three hours and a half.

For fourteen weeks the case had been in progress, and there was the stillness of the tomb in the courtroom as Judge Speer asked the jury if they had agreed upon a verdict. Foreman Hope Thomas answered in the affirmative, and the three indictments were taken and the findings read by the clerk. The jury at the request of the counsel for the defense was then polled, and each member stated that the verdicts rendered upon the indictments were his.

The maximum sentence that the court may impose under the law is an aggregate term of seventeen years in the penitentiary and a fine of \$15,000, the amount of the alleged embezzlement. It is not believed, however, that the sentence will be of extreme severity. Before adjournment to Friday morning, Judge Speer said: "I have no disposition toward these unfortunate men except to be just as merciful as my duty under the law will permit."

The minimum sentence permissible under the law is two years in the penitentiary and a fine of \$1,000.

The defense's counsel will not discuss the next steps to be taken in the case nor will District Attorney Marion Erwin say what will be done regarding the indictments against Othello M. Carter, Michael A. Connelly, William T. and Edward F. Gaynor, who were jointly indicted with the defendants who now stand convicted.

Mr. Erwin received a telegram from Attorney General Moody expressing the congratulations of the president and the attorney general upon the outcome of the case, upon which Mr. Erwin has been engaged for seven years.

The trial of Messrs. Greene and Gaynor consumed about fourteen weeks. The defendants were charged with conspiracy to defraud the government, and embezzlement. In connection with the big government engineering works at Savannah, they were indicted in 1902 and, after flight, were taken to Canada. After lengthy proceedings there, they were finally extradited and were brought to Savannah for trial.

Captain Othello M. Carter, of the engineer corps, who had charge of the improvement works under Greene and Gaynor contract, was court-martialed for his complicity in the alleged bribery charged from the army and to serve a term of imprisonment of five years.

## ASHES DOING DEADLY WORK.

Their Weight Causes Collapse of Many Buildings Near Volcano.

From all quarters reports are received in Naples that the situation has ameliorated, but ashes from Mt. Vesuvius are falling everywhere, the houses are collapsing and burying the occupants and roads near the volcano are no sooner opened than they are closed again by falling clinders.

## TWO FIRES IN THOMASVILLE.

Famous Hotel and a Number of Other Buildings Prey to Flames.

At midnight, Thursday night, after three hours of danger to the whole city, Thomasville, Ga., passed through the most disastrous conflagration in its history. The damage is in the neighborhood of \$100,000, with insurance less than half that amount. The fire started in the basement of the famous resort hotel, "The Piney-woods," which, since April, 1905, has been vacant. The structure was completely destroyed.

## LET THE PEOPLE SELECT.

House Committee Recommends That United States Senators Be Elected by Popular Ballot of People.

A Washington special says: A resolution, providing for the election of senators by direct vote of the people has been favorably acted on by the house committee on election of senators and representatives in congress.

Reasons why the terms of members should be four years are stated to be because no party can inaugurate its policy in two years.

"The people are tired," the report says, "of this continuous drama, and as a result are inclined to give no attention to the primaries and the conventions—the very foundation of our political system—the forum where in the country's interests can best be guarded and protected."

"With an election every two years the political graffer who survives on partisan strife and on the nervous uncertainty controlling candidates for office is able to live from one election to another by the roadside secured at his unholy business. The adoption of the proposed amendment would render it less possible for this creature to ply his trade."

Regarding the election of senators by direct vote, the report says: "The proposition to provide for the election of senators by the direct vote of the people has been before the house of representatives and has received favorable consideration upon several different occasions. A proposition to amend the constitution having this object in view, has passed the house of representatives at four different times, and each time by a practically unanimous vote."

CRIMINAL LIBEL CHARGED Against Editor as Outcome of Red Hot Political Squabble.

At Marietta, Ga., after three days of deliberation into the charges of fraud alleged to have been committed at the Cobb county primary of April 4, John A. Erwin and D. F. McClatchey, against whom charges were preferred by Hon. S. A. Morris, have been freed of blame by the grand jury, and no true bills returned, while Mr. Morris and his paper, the Marietta Courier, have been indicted on two counts, each for criminal libel.

The reversal of the tables in this case will perpetuate for some time the bitterness aroused in a most exciting campaign. The case will come up at the July term of court.

The charges of fraud and irregularity in the management of the polls grew out of the primary of April 4 for the naming of a senator, representative and county officers.

In the last issue of the Marietta Courier, of which Hon. N. A. Morris, ex-speaker of the Georgia house of representatives, is president and managing editor, violent attacks were made editorially charging fraud and corruption and specifically charging fraud against Erwin and McClatchey. It being alleged that in some instances the ballots were actually changed after being handed them to put in the box.

Dowie Says He Is Determined to Fight It Out With Zionists.

A Chicago dispatch says: Dowie has upset the plans for a peaceable adjustment of his troubles with Zion church, as previously announced. Early Thursday he directed his attendants to announce to all inquirers that the report that he was about to compromise with Overseer Voliva and his followers was untrue. He said that he would conduct a legal contest in the courts and get his property back.

## HOSTS HOMELESS

Fifty Thousand Italians Mourn Loss of Their Habitations.

DESSERT WASTE OF ASHES

Vesuvius Eruption Wipes from Earth Twenty Millions in Property and Thousands of Lives Are Blotting Out in Lava Flood.

Dispatches of Wednesday from Naples state that the whole of the Vesuvius district, as far as Naples, Caserta and Castellamare is one vast state that the fall of ashes is not so heavy as it has been for the last few days, and that the ashes are much finer and from this it is argued that the prospects are much brighter.

The blockade of local traffic continues, but service on the main lines of railway have been re-established, although greatly disarranged.

The arrival of King Victor Emmanuel and Queen Helena has done much to restore calm. They have been received with great joy, especially when the sovereigns left a hospital after a visit to the wounded there.

All the papers advise the public to be calm, pointing out the improved condition of affairs. The papers also eulogize Director Martorelli for his services in returning to the ruined city.

The village of San Germano has been partially buried in sand and ashes and several houses have fallen. In the road at Torre del Greco ten persons were found dead from suffocation.

People remaining at Torre Anzuzia are in danger of perishing from starvation, all the shops having been closed. Rations for two hundred persons have been sent there. The warships ordered to Naples have been doing effective service in the removal of refugees.

Just before he reached the vehicle a man sprang past the bodyguard and waved a document in Dowie's face. Before a further move could be made the Zion guards threw him bodily over a nearby railing. It was afterwards learned that the man was a deputy sheriff who was endeavoring to serve Dowie with a summons in a civil suit in which a medical expert claimed that fees to the extent of \$500 had been due him for several years. The incident disturbed Dowie very little, and he was driven to the Auditorium annex, where apartments had been secured for his party.

After a short rest Dowie summoned his legal advisers and then caused a conference which lasted the greater part of the evening. On people remaining at Torre Anzuzia are in danger of perishing from starvation, all the shops having been closed. Rations for two hundred persons have been sent there. The warships ordered to Naples have been doing effective service in the removal of refugees.

Reports of the destruction of two towns, Sarno and San Germano, the former having a population of more than 8,000, have proved to be without foundation.

At Sarno 5,000 persons from nearby villages and farms have found refuge. On Monday, is practically buried now. Three hundred killed is considered a conservative estimate.

There is great difficulty in ascertaining the actual condition of affairs in that part of the stricken district nearest the volcano. The tram and railway tracks are deep under obliterated, and the roads are shattered. The fishermen who ply their calling on the bay of Naples are afraid to venture out in water anywhere in the vicinity of Vesuvius. All these conditions make it difficult to form an intelligent estimate of the loss of property.

One estimate is that \$20,000,000 damage has been done, and that 50,000 persons have been rendered homeless.

Everywhere in Naples and Castellamare and in the lesser towns nearby out of the danger zone are heaped refugees, who are only a few days ago, were prosperous and happy, though living almost underneath the shadow of perpetual menace. For these people whose homes and crops have been destroyed, there is little consolation in the statement of scientists that ultimately the valleys and hillsides will become as fertile as ever they were. Until communication can be restored and search made of the houses in the afflicted district, it will be impossible to determine how many people have perished.

John Alexander Dowie will not advance on the "house of Zion" as suddenly as he expected. Tuesday night after a long consultation with his legal adviser, Dowie said that it might be several days before he sees fit to enter the city which he founded. "The first apostle" arrived in Chicago Tuesday morning. An immense crowd was at the station to greet him. Before leaving the car he cracked several jokes with a number of newspaper correspondents. Escorted by loyal followers he made his way to the end of the train. He was greeted with an assortment of welcomes, ranging from the reverent "peace be with thee" of the Zionists, to the more jocular "good boy, Dowie," of the curious members of the throng. # Letter to Farmers.

Atlanta Ga., April 3, 1906

President M. L. Johnson, of the Georgia division Southern Cotton Association, in a statement issued this week calls the attention of the farmers and business men of Georgia to the importance of working to secure thorough cooperation on the part of the farmers of this country in the matter of marketing the cotton crop.

President Johnson says:

"It should be the policy of the American spinners to give their united cooperation and support to the cotton producers of the south in marketing and maintaining the price of the south's great staple, not only from the standpoint of benefiting their own country, but as well from that of financial advantage to themselves. I believe the farmers and business interests of the south, with the proper effort on their part, can secure this cooperation on the part of the American spinners as assistance which has heretofore been withheld, through it would unquestionably mean more money in the pockets of the spinners."

"The great tariff wall which is thrown around our country practically makes 80,000,000 American people equal in the matter of consumption of cotton and other goods on a similar basis, to 800,000,000 foreigners when the question of price is taken into consideration. Now, it costs eight cents a pound, sometimes more to grow cotton. The foreign spinners take approximately 8,000,000 bales of each crop, and if the American spinners would cooperate, as they would, no doubt, if the matter was taken up with them in the proper way, in maintaining a price of over 12 cents a pound, this would mean a profit of \$20 a bale, or a total of \$160,000,000 from the foreign markets, and just to that extent would the purchasing power and likewise the consumption of the American producer be increased. Think what this means: \$160,000,000 more to spend at home, in our home market and for home products. Georgia exports about one-seventh of this amount, hence her share of this profit would be \$28,000,000, twelve times the amount, which Georgia gives to her common school."

"But to expect and to secure this cooperation on the part of the spinner, the producer must, of course, do his part. He must not proceed with reckless disregard of the law of supply and demand, it rests with the individual to do his part towards controlling the output, and this is what we have tried to do in every section of the south. Do your duty to yourself and you will find no lack of others ready and willing to assist you in asserting and maintaining your rights."

Planters and Spinners

To Meet May 1

The official program has been announced for the international conference of growers and manufacturers of cotton, which will take place at Washington, D. C., on May 1st and 2d.

This will be the first meeting of its kind in the history of cotton production. Delegates will be present from the leading associations of producers and spinners in Europe and America, and the conference will likely be the beginning of a complete revolution of affairs in the cotton world.

The question of bringing the planter and manufacturer into closer relation was first suggested when the Southern Cotton association was organized less than four months ago. Since then the spinners have taken the initiative in the matter, and representatives from the south will attend the conference by special invitation.

Below appears a list of the delegates from the southern cotton associations, who were named by the executive committee at its last meeting in New Orleans:

J. A. Brown, of Chabourn, N. C.; John T. Allison, of Concord, N. C.; E. D. Smith, of Columbia, N. C.; W. F. Vandiver, of Montgomery, Ala.; S. A. Witherspoon, of Meridian, Miss.; J. A. Taylor, president of the National Ginners' association, of Wynnewood, I. T.; and Harvie Jordan, president, of the Southern Cotton association.

Among the prominent manufacturers who will be present are J. R. McColl, of Providence, R. I., president of the New England Cotton Spinners' association, and H. R. Miller, Jr., of Charlotte, N. C., president of the American Cotton Manufacturers' association.

A party of English spinners, named to represent the European interest at the conference, landed in this country some time ago and are making an extensive tour of the cotton belt for the purpose of becoming more familiar with the conditions and methods employed in the south.

The visitors are now in Texas, but are expected in Atlanta on the 18th and 19th of this month. President Jordan, of the Southern Cotton association, will do all in his power to make pleasant their stay in Atlanta and it is probable that some action along that line will be taken by the city officials.

During the conference at Washington two sessions will be held daily.

The meeting will be open to the public and all interested will be invited to attend.—Atlanta Journal.

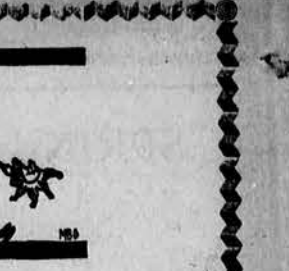
