COOPERS GET 20 YEARS.

Without Emotion Father and Son Hear Verdict of Murder in the Second Degree.

Nashville, Tenn., March 20.—Guilty of murder in the second degree—punishment, twenty years imprisonment—this was the unexpected verdict rendered by the jury against Col. Duncan B. Cooper and Robin J. Cooper when court opened today. The jury yesterday had acquitted John D. Sharp, indicted with the Coopers for the slaying of former United States Senator E. W. Carmack.

Events moved swiftly from the time the verdict was rendered today. Immediately the defense moved to set it aside because of the verdict of disagreement yesterday, and asked the court to declare a mistrial. Judge Hart said he would listen to arguments on this motion later, probably next week. He then fixed the defendants' bonds at \$25,000 each.

Although Judge Hart fixed the bonds at \$25,000, there was a rush to sign it on the part of the wealthy citizens of Nashville, which fairly swamped the clerk of the criminal court. In vain he protested over and over again that more than enough sureties had signed, but the invariable answer was, "We want to put our names on that bond, too."

It seemed as though every friend of the Coopers considered it incumbent upon him to sign the bond. When there was no more room for names at the foot of the document, the new bondsmen endorsed it across the face until it was difficult to decipher the signatures. When filed the bond totaled nearly \$1,500,000.

The Coopers returned to the jail this afternoon late and removed their personal effects. For the present Col. Cooper will make his home with Mrs. Burch and Robin will return to his old headquarters with his uncle, Judge J. C. Bradford.

As soon as Judge Hart entered court and after he removed his coat he ordered the defendants and the jury brought into court. In almost a moment, at 9:25 to be exact, the twelve men entered the room and took the same seats they have occupied for nearly nine weeks.

"Have you agreed upon a verdict, gentlemen?" asked Judge Hart.

"We have," replied Foreman E. M. Burke, hoarsely.

"Advance, Mr. Foreman, and read the verdict."

"We, the jury, find the defendants Duncan B. Cooper and Robin J. Cooper, guilty of murder in the second degree and assess their punishment at confinement in the penitentiary for a period of twenty years."

"So say you all, gentlemen?" "So say we all," in chorus. The verdict, coming as it did upon the heels of Foreman Burke's declaration yesterday that "we are hopelessly tied up as to the Coopers," was a decided surprise. The defendants took it coolly—almost without emotion.

it a bailable case," was the court's retort. "Hence, I will fix the bond of each defendant at \$25,000 unless there be some objection. In event that I will hear arguments." "It is satisfactory to us," said Attorney General McCarn.

"And to us," retorted Judge Anderson.

"There seems to be nothing left but for the court to pass sentence," added Judge Hart.

"I do not think that necessary," said Judge Anderson. "We move that judgment be suspended and that we be given a new trial. We will be prepared to argue the motion later—probably next week."

"All right," remarked the court, "I know you will not delay unnecessarily and I will take it up at your convenience."

The jurors were not inclined to talk, but one said:

"On the first ballot we acquitted John Sharp and disregarded the conspiracy theory. On this same ballot we stood six for murder in the first degree with mitigating circumstances, five for murder in the second degree with twenty years, the maximum penalty, and one for acquittal. The ballots all day Wednesday and Thursday showed the same result. Yesterday the man who voted for acquittal came over to murder in the second degree, but demanded that only ten years be assessed. The rest of us did not deem ten years as anything like adequate, so we disagreed again. Of course, all this refers to the Coopers, not Sharp, whom we had acquitted."

"Early this morning the man who was holding out for ten years agreed to twenty years and the six who were voting for a first degree verdict agreed to this verdict."

While the jurors would not say who the man was who held out for acquittal, it is known from remarks overheard by the deputies that he was S. J. Hyde.

Groover Case Attracts Interest. The case of the City of Statesboro vs. J. B. Groover on trial for the sale of Near Beer is exciting general interest all over the State. Groover who will and folks on the street and elsewhere will ask you what about old man Groover's case? The efforts of the city to rid itself of a beer saloon is watched with eager interest everywhere that newspapers are read in this state. Every town has its problem along this line and have their eyes on Statesboro and Mr. Groover. The case of this city against Mr. Groover is a typical one, the ordinance drawn by the City Council was submitted to one of the best legal talents in this section of the State, and made to drive a beer shop from the limits of town whose authorities did not approve of one. It is supposed to cover every feature of a strong well arranged case, and on it will rest the hope of the opposition to this traffic in Georgia.

The case of Mr. Groover is not a typical one, his business has not been proven to be a disorderly one, and therefore not a nuisance. No case of selling intoxicants have been made out against him, he is a confederate veteran full of fight and determination, one of the boys who faced the cold steel of a half century ago and is not given to being bluffed, he has back of him certain laws and supreme court decisions, on which he bases his case, and if he loses every Confederate Veteran in the State has as well close in communities that protests against this traffic. If he cannot win none of them can, if they cannot close him the best thing to do is to put a reasonable license on it that will permit of competition. It is a hard fight for supremacy between the Municipal authorities on one hand and the rights of Confederate Veterans as guaranteed by the laws of the State on the other. The News simply gives the case as we see it, it is not a question of either politics or public sentiment, but one of law and it will take a great legal battle to settle it, in fact the entire state is looking forward to this case to settle the rights between these two parties. The outcome will be awaited with interest everywhere.

Will Ask for Duty on Egyptian Cotton. A movement is on foot to ask congress to embody in the new tariff bill an import duty on Egyptian cotton. A committee of South Georgia and Florida planters and business men will go to Washington to appear before the tariff committee and urge the incorporation of such a measure. The present crop of sea island cotton has been estimated at 94,000 bales. All of this, except about ten thousand bales, has been sold, and ninety per cent of this is used by American mills. In addition to this 25,000 bales of Egyptian cotton has been imported into this country from the farms of the pauper laborers in Egypt. This cotton sells at seven cents, and drags our prices on sea islands down. It is argued that a tariff of five cents a pound on imported Egyptian cotton would protect our South Georgia product and raise prices to at least 25 cents per pound. A new demand has been created for the product of our sea island cotton belt in the manufacture of automobile tires. It is estimated that this industry alone uses 20,000 bales of sea island cotton. With a duty on Egyptian cotton and the increased demand in the home markets there is no reason why prices should not be raised. The Chamber of Commerce of Statesboro is taking the initiative in this matter. President J. G. Blitch has taken the matter up with our representatives in congress and he and others from here will accompany the delegation to Washington, where they will appear before the committee having this matter in charge. The fight started here will be supported from all sections of the sea island cotton belt.

"Unless all sides join in making Murphy Candler Mr. Brown's successor I will be in the race."

The governor classes the interview as a "fake" and says that while he cannot take time to contradict all the newspaper stories about him, he feels called upon to deny the rumor appearing in the Telegraph.

Although the governor denies that he has said that he will either be the next governor or will name him, it has been constantly rumored about the capitol that unless he does enter the race to succeed Mr. Brown he would like to see Mr. Candler elected to the office, and it has been further rumored that in that event he would throw his support to the recently appointed railroad commissioner.—Atlanta Georgian.

THE BERKSHIRES.

Considered by Professor Hofman the Most Profitable of All Breeds.

There are hogs, big, little, red, black, white and mixed, a large field to select from, says Professor H. C. Hofman of the Iowa Agricultural college, but to the thinking farmer it is often a question as to which breed is the best. First one kind is tried, then another, then perhaps an interest, with the result that correct impressions regarding the final results are impossible. The only correct way is to try the different breeds and cross under like conditions and for two or three years in succession. This is absolutely the only way to determine the best hog.

My own experience of seven years with hogs has led me to breed the Berkshire hog as the most profitable of all breeds. Six years ago it was my pleasure as well as profit to have in charge the six different breeds of hogs at the Iowa Agricultural college. Here the hogs were given the same care and feed. In my observations of the different breeds I found that the Berkshire hog was always ready for the feed, good at taking care of himself with cattle and made the most of the pastures. They always looked the sleekest, and the scales showed that they were the best.

and best hogs of Poland-Chinas in the world. This herd contained some of the finest and highest priced Poland-Chinas in the country, but six months of actual contact, day and night, with this herd only fixed more firmly in my mind that the Berkshire hog was the best of them all.

Since farming for myself I have had in the feed lot Poland-Chinas, Chester Whites, Duroc Jerseys and the Yorkshires alongside of the Berkshire hog of my own breeding. I never had a Berkshire that went down on his back, trampled by the steers or run over by the wagon, and when it came to marketing I found that the Berkshire hog was the best.

Counting Farm Animals. The number of animals on the farms of the United States on Jan. 1, according to a report issued by the department of agriculture, shows an increase compared with the previous year, with two exceptions—swine and cattle other than milk cows. The average price of milk cows shows an increased value of \$1.70 per head, and hogs showed a decreased value of 45 cents per 100 pounds and swine an increase of 50 cents. Comparisons of this year with last year show the following changes: Horses increased 948,000 head, mules increased 184,000, milk cows 529,000, other cattle decreased 684,000, sheep increased 1,432,000, and swine decreased 1,937,000.

Clean Hogpens. One of the surest signs of improved agriculture is a dry, clean hogpen. The up to date farmer has discovered that a pig wallows in mire only when he cannot help himself.

THE VETERINARY.

An abundance of sunlight in the cow stables so arranged that it may reach every part of the stable is one of the best preventives of disease. When possible the cow stables should be separate from the barn in order to secure proper ventilation and the necessary sunlight which it is impossible to obtain in any other way.

Cure For Mange. Mange is a distressing affection that should never be permitted to retain a place on any farm, as it is easily cured. Rub on oil of tar, one ounce, and white oil, two ounces, or one-half pound each of air and sulphur and one pound each of soap and alcohol. In all cases boil all blankets and treat with a strong solution of caustic potash all wood-work, harness, brushes, combs and whatever is possibly infested with the germs of mange.

Blood Purifier For Horses. A good blood purifier for a horse that is run down is an ounce of hypophosphite of soda twice a day. Feed the horse well. Another remedy is two ounces each of powdered copperas, ginger, saltpeter and fenugreek and half a pound of ground gentian. Mix and give a teaspoonful in each feed.

Sours in Calves. There is no surer cause of scours than dirty feed pails. Be scrupulously clean as to pails, troughs and the food used in feeding young calves. It will save a lot of the trouble that comes with carrying calves through the scours.

Removal of Warts. Warts on calves and other young stock are nothing more or less than skin tumors, often due to overstimulation of the parts, says a veterinarian. You can twist them off with your thumb and fingers, after which you may apply tincture iodine to the parts for two or three days in succession. Then keep the parts pliable by rubbing with sweet hog's lard occasionally.

GEO. BELL CUTS HIS OWN THROAT

Ends His Life in Presence of Conductor--Was on His Way to Attend Trial For Divorce.

Savannah, Ga., March 25.—While the Central of Georgia train No. 4 was on its way from Atlanta to Savannah and had reached Tombsboro early this morning at 2:50, George H. Bell, of Swainsboro, formerly representative in the state legislature, committed suicide by cutting his throat, after having inflicted a stab wound slightly beneath the heart.

The act was committed in the presence of Conductor Robert L. Brake, who, though standing beside the unfortunate man, was unable to prevent the suicide. Bell had previous to the coming of the conductor stabbed himself beneath the heart and was lying upon the floor of the smoking compartment of a coach when found by the conductor.

Thinking that the man had suffered from a hemorrhage, Conductor Brake lifted him from the floor and placed him upon a seat and while standing up after his effort was astounded to see Bell take a pocketknife and pull it across his throat from left to right, and immediately under the jaw bone.

Bell sank into a collapse immediately, and expired at once. An examination of the body showed the stab under the heart, from which he had bled profusely, though the evidences were covered by his clothing. The body was kept on the train until Wadley was reached, and from there sent to Swainsboro to his relatives.

That Bell intended suicide after he left Macon is undoubted. He had purchased a ticket from Atlanta to Swainsboro and was due to change trains at Wadley for his destination.

He first occupied a seat in the smoking car, where he was found when the conductor went to take up tickets. Bell was sleeping apparently and though an attempt was made to rouse him he seemed in such a state that the conductor refrained from further inconveniencing him and returned to the other coaches without troubling him any more. At the time his actions had been noticed by several on the train and were thought queer.

After the conductor had left him Bell went into another coach and asked a passenger to lend him a knife with which to peel an orange which loan was readily made. He went to the smoking compartment of another car, and it was there that he stabbed himself in the proximity of the heart. When the conductor again passed through the coaches to collect tickets he found Bell lying upon the floor and the suicide followed as described.

Bell's movement after he was picked up from the floor and placed upon the seat were so unexpected that Conductor Brake had no opportunity to interfere before the suicide had been accomplished.

Bell has only recently been given his liberty from the state sanitarium and was on his way to Swainsboro to attend the divorce proceedings instituted against him by his wife.

It is presumed that the impending suit and the fact that his mind had been previously unbalanced are the direct causes of the suicide.

One month ago, to the day George Bell was released from the state asylum after a sensational fight in which he was aided by Mrs. Blanche Burton, a former actress, now the wife of a wealthy Indianapolis man, whom Bell had once befriended.

In his petition for release from the asylum Bell contended that he had been illegally held. From the beginning of his fight he claimed that he was kidnaped without having been regularly and legally adjudged insane.

He was placed in the asylum on April 18, 1906. He was given his release February 25, 1909.

Several weeks ago Mrs. Bell who is now a stenographer at Waycross filed suit for divorce, alleging cruelty. Bell announced that he would not take any legal steps to contest the suit, nor would he oppose her taking their only child. Mrs. Bell is prominently connected with one of the best families in the state.

During his confinement in the asylum Bell wrote a number of articles to the newspapers of the state, which attracted great attention. In these articles he claimed that he was illegally committed to the asylum, was held against his will and should be released. He was a brilliant writer and hundreds of people, after reading his letters, were apparently convinced that he was sane.

One of the articles attracted the attention of Mrs. Blanche Burton, whom he had once befriended, and she determined to help him. She was aided by Hon. L. J. Kilburn and W. D. McNeil, a well known lawyer of Macon. Mr. Kilburn was a colleague of Bell when he was a member of the legislature. Mrs. Burton was visiting in Macon at the time she enlisted her efforts in behalf of Bell.

Bell was arraigned for a hearing at Milledgeville some weeks ago, but was at its conclusion sent back to the asylum.

Not discouraged, friends of Bell went to work and by habeas corpus proceedings succeeded in having the case again brought up. This time the hearing was before Judge Lewis at Greensboro, who ordered Bell to be held for 30 days and released unless legal steps were taken. The asylum authorities, however, at once freed the former legislator.

Bell was termed a "paranoiac" and declared to be suffering from delusional insanity by Superintendent Jones of the state sanitarium, and Drs. Green and Little, attending physicians.

It was brought out in their testimony that this form of insanity was made evident through the insane belief of persecution and it was stated that Bell had repeatedly declared that his father had tried to poison him by injecting morphine into him against his will. Dr. Green Bell, father of Bell, who is a well known Swainsboro physician, showed that such injections had been made from time to time to make his son sleep as he had practically wrecked his body and mind by the use of intoxicants.

Swainsboro, Ga., March 25.—The town is greatly wrought up over the tragic death of George H. Bell, who committed suicide on a Central train at Swainsboro, at an early hour this morning. The parents of Bell are prostrated with grief and there are hundreds here who have shed tears over the sad fate of the young man who was one of the favorites of the town and the county.

It was just thirty days ago that he came back to the town from the state asylum and was received with open arms by the citizens, all of whom knew and loved him. His

homecoming today was as tragic as the first one was happy. It was two weeks ago that he left here for Macon. While here he received a great deal of attention and there was at no time a suggestion that his mind was not what it should be.

The knife with which he cut his throat was obtained from Mr. W. L. Coleman, a friend. After receiving the knife he went into the forward car where he committed the deed, first stabbing himself under the heart and later cutting his throat. He will be buried tomorrow afternoon.

Thirteen years ago Bell was an actor in a company doing one-night stands in the middle-west. At that time while the company was at Terre Haute, Ind., the manager attempted to leave behind a pretty blue-eyed, golden-haired girl who was ill. Bell forced the manager to take the sick actress with the company and she finally recovered. This girl, now Mrs. Blanche Burton, never forgot the

act of kindness and when she came South recently she learned of Bell's plight and worked for his freedom. When George Bell quit the stage he came back to Georgia. He ran a newspaper at Swainsboro, served in the legislature from Emanuel county and later ran a store in his home town of Swainsboro.

He was about 35 years of age. Beside Bell on the seat when he took his life was a newspaper which contained an account of his wife's petition for divorce.

Bell lived only thirty-five minutes, praying all the time to die. His father, Dr. Green Bell, was notified at once and his body was met at the depot by a number of his friends, who just one month ago met him to congratulate him upon his release from the sanitarium.

Dr. Bell has wired Mrs. Blanche Burton. She did so much to effect Bell's release. It is possible that she will come to Swainsboro to attend the funeral.
