## City Court in Session.

The regular quarterly term of City court convened yesterday morning with Judge Brannen presiding. After sounding the civil docket the criminal docket was taken up and the following justices transacted:

State vs Will Smith; intoxication on public highway; fine \$50 and cost or six months on the gang.

State vs Sam Myers; pointing weapon at another; fine \$100 and cost or 12 months on the gang.

State vs Willie Nelson; stealing butter; guilty, \$100 and cost or nine months.

State vs Sam Zeigler; concealed weapons; guilty, \$25 or three months.

State vs. John Lanier, assault and battery; plea of guilty; fined \$50 and cost, which was paid.

The civil docket will be taken up this morning.

**Bad Saloon Keeper**

Will be Tin Canned.

Cincinnati, O.—This city is to witness the unusual coalition of the brewers and the anti-saloon league and the municipal reform league in a united effort to put the bad saloon keeper out of business.

Through the efforts of the Ohio Brewers' association the state legislature passed the Dean "charitable" law, under which the saloon keeper must swear to a number of interrogatories as to whether he has violated the Sunday closing law or allowed minors to enter his saloon, and so on.

If the saloon keeper answers "no" to all of the interrogatories, but it is found out that he has not given a correct answer to a single one, his license is to be revoked, and it is otherwise stringent.

The Dean law also says that only American citizens can run a saloon. A large number of foreigners run saloons in this city, but the Federal court will not let them naturalize until September.

Her, while the Dean law went into effect April 1st. The point is as to when the law will be applied to the foreigner who runs a saloon, on the score of his naturalization, has not yet been settled.

The brewers declare they will aid the reformers in an effort to put the bad saloon keeper out of business. A brewing company at Hamilton announces that it will not sell beer to a saloon keeper who keeps his saloon open on Sunday. Another brewer in Hamilton recently made the rounds of his customers in that town and besought them to strictly observe the Sunday closing law.

Agents of the municipal reform league have already begun to collect information and the proof of infractions of the law will be filed before June 1, when the next annual tax payment is due.

Chicago, Ill., April 8.—May wheat climbing high above the highest point it touched in this upward movement, stopped momentarily today while James A. Patten, the man who controls it, unloaded some millions of bushels, and then sagged back a little while he bought up millions of other bushels at a lower price.

Following him in his trading were dozens of "lions"—men who had wheat and were holding it for top prices. They unloaded their holdings today, and in response to the flood of selling orders the price broke. Before the break, though, it had made a new record—\$1.26 3/8.

There were many selling orders today and Patten—led the selling when the price, after the opening skirmishes of the market, mounted above \$1.26. When it sold down to a little above \$1.24 the buying orders began to come from Patten.

Already Patten has cleared more than \$5,000,000 on his wheat deal since last October, and today the market has been forced higher than by any other man. It is said on the Board of Trade that it is going higher.

Many of the selling orders today came from the Northwest and Southwest, where there are scattered long. Several selling orders were placed locally.

**Fight Was Won for the South.**

Washington, April 10.—Southern representatives in congress expressed unbounded delight today at the successful outcome of the fight to put on the free list articles entering into the manufacture of commercial fertilizers. Since the Southern cotton farmers are the country's largest users of fertilizers, they would have been harder hit than any others by the original provisions in the Payne tariff bill putting a 20 per cent. ad valorem duty on imports of sulphate of potash and muriate of potash.

But, luckily for the South, this provision was stricken from the bill, and these commodities will continue to be imported free of duty. The same thing is true of kainit. This action of the house will relieve manufacturers of fertilizers from any necessity or reasonable excuse for an advance in the price of fertilizers.

A mistaken impression seems to have gotten abroad as to kainit. This commodity was put on the free list in paragraph 601 of the original Payne Bill. Potash and sulphate salts were in paragraph 652 of the bill, which was also in the free list, but despite this, section 3 of the bill, as it originally stood in effect provided for a 20 per cent. ad valorem tax on these articles. This section sets forth that where any country discriminates in their tariff charges against goods received from us that higher rates which were designated shall be charged their products coming into this country.

A large part of the materials entering into the manufacture of fertilizers are imported from Germany, under which this bill would be subjected to the maximum rates fixed in the bill.

The articles included in paragraph 652, which were formerly made subject to the maximum tariff clause, include: potash, crude or "black salts"; carbonate of potash, crude or refined; hydrate of potash, crude or refined; nitrate of potash or salt peter, crude; sulphate of potash, crude or refined, and muriate of potash.

At the opening of the session yesterday, Chairman Payne of the ways and means committee offered an amendment moving to strike out in the iron ore schedule the words, "basis slag, ground or unground," and stated:

"I will say to the committee that this is a fertilizer and it is the intention of the committee that no fertilizer shall bear any duty, even in the maximum tariff."

Representative Hughes of Georgia, who made a careful study and exposition of the tariff bill as it affects the farmer, expressed great satisfaction over the outcome of this matter. He expressed the hope that the Southern senators would be able to retain this feature of the bill in the shape in which it passed the house.

Col. Livingston was another representative who was deeply interested in this schedule. All the Georgia members had received numerous letters from their constituents and had exerted themselves to the end of having this section amended.

From the Marietta Journal it is learned that Governor-elect Joseph M. Brown will be inaugurated in a suit of "Joe Brown" chevrons made in Cobb county by a new pants factory just established there by Mr. J. Lindsey Johnson, the brilliant editor the Rome Tribune-Herald, one of the brightest and best of the Georgia dailies. He has bought the Concord Woolen Mills, and now has them in operation. Among the patterns are stripes and solid chevrons, black and brown. His brown are called "Joe Brown" chevrons.

The Telegraph is glad to learn of this Georgia enterprise; and is more than glad, if the report is true, to learn that our democratic governor, who is distinctly Jeffersonian in his simplicity, is not ashamed to be inaugurated in "home-made" clothes. We are glad that he is going to cut the silk hat and glad rag parade, and the blustering fanfare of trumpet and drum. Of course the inauguration should be a serious affair—almost solemn—but it is time we were cutting out, at least in Georgia, vain imitations of royal purple and regal capers.

When Jefferson was sworn in he rode to the Capitol on horseback, and hitched the animal to a hitching post, and then walked into the building and took the oath. Mark the contrast with the pomp and circumstance of our latter day inaugurations. More and more we invest our public servants with regal equipages—at least we permit them to thus crown themselves.

Under the theory of government, national and State, our Presidents and Governors are not rulers, not monarchs, but executives—men chosen to execute the will of the people put into the forms of law. Roosevelt was who, in a cablegram to an old-world ruler, spoke of the American people as "my people." We have known small-caliber governors to do the same thing, and also others who felt themselves in authority over them.

The American people became an independent and powerful people because they revolted against the personal rule of a crowned head.

It is time we were getting back to simpler ways. The great common sense of the governor-elect—his dislike for showy pomp—his determination not to ape potentates—his democratic methods of thought and word deed—will do a very great deal toward starting a reform very much needed in our country. Let us hope that this investment of the imperial purple under the Tiedian rule, and under the lesser imitations of it, has reached the meridian of its fictitious splendor; and that the decline from that dangerous eminence has set in.—Macon Telegraph.

**Father Fights, His Son Slays**

Albany, Ga., April 10.—Nevil L. Ragan, one of the best known citizens of Albany, was shot to death on Washington street this afternoon by Howard Clark a young son of John S. Clark.

Early this morning John S. Clark and Ragan engaged in a street fight, in which both Ragan's eyes were blackened. The encounter caused a great deal of excitement, as feeling between the two men had been known to be not the best, dating from an affair which occurred several years ago.

Clark was a member of the April grand jury, which has been investigating charges made by Ragan against an officer of Dougherty county, whom he declared he desired to have indicted for malpractice. Discussion of the case between Ragan and the elder Clark several days ago led to street talk, repeated to both parties, which brought about this morning's street fight.

Both Clark and Ragan had statements in this afternoon's Herald, but the more tragic affair of the afternoon occurred before the paper was on the streets. Howard Clark approached Ragan and asked for a private interview. Ragan insisted that whatever Clark had to say be said within hearing of others present. The following occurred: "I understand," said Clark, "that you made the statement that my father had to beg you this morning in order to keep you from cutting him to death."

"Young man," said Ragan, "your father called me a thief."

"How are a thief," it is asserted Clark said, "a bald-headed old thief."

With that, eyewitnesses declare Ragan ran one hand into a side pocket of his coat, and with the other reached forth as if to seize Clark in the collar. Clark backed away, Ragan following. Clark had retreated a dozen steps, it is said, when he drew a revolver from his pocket and fired, the ball entering Ragan's body very near the heart.

The wounded man was carried into a nearby drug store, where physicians examined his wound and pronounced it fatal. He died thirty minutes after being shot. Clark went from the scene of the difficulty and surrendered to Sheriff Edwards.

Ragan was a brother of Willis Ragan of Atlanta and R. J. Ragan of Rome. He also has an unmarried sister in Rome and other relatives in Lee county. He is survived by his wife.

The tragically caused great excitement in the business section.

**Boys Have Returned Home.**

There is great rejoicing among the Statesboro base ball fans over the return of "the boys"; we mean those who went off for a try-out with the league. Sunday morning two of our young men fell into the embrace of their friends—"home again," after a month's stay in Savannah, where they were to be given a trial; and after a month's practice they were weighed in the balances Saturday afternoon, and owing to the fact that the scales refused to balance right they were released and allowed to return home to their dear friends.

There is nothing so bad but what it could have been worse. When we come to think that the boys were turned down after the trial, it makes our heart feel sad. To begin with, we have a sort of a town pride in our make up that commands us to appreciate the success of our townfolks, even if it's in a base ball try-out. We always want our folks to stand at the top, we want to see Statesboro's fame written high—well up toward the top—in everything her folks tackle, and we freely admit that it caused a tear to come trickling down when we heard that the boys had been "released."

This was a sort of mild way the Savannah paper had of putting it, but it spelled "lose out," just the same.

Our sorrow was somewhat appeased, when, upon more mature reflection, we turned over a new leaf, and concluded that it would have counted to these two young men had they measured up and been retained. A professional base ball player is, in our humble opinion, the sorriest, littiest, most unthankful jolly body, the shinniest str. So, in our opinion, these young men to be congratulated that they were "released." They are back and there are other vocations ready to embrace their efforts and talents.

So there is little cause for regret that they were "released," after we come to think seriously over it.

**Four Recruits on the Gang.**

Yesterday afternoon the chain-gang was recruited to the extent of four—three negroes and one white man.

The white man is named Hugh Stahlers. He is the young man who stole a coat at Register and goes up for twelve months.

The names of the negroes and the terms of their sentences are as follows: Will Smith, 12 months; Will Nelson 12 months, and Richard Atkins, 6 months.

Richard Atkins is a 15-year-old boy who goes in for carrying on sealed weapons. "Richard the Second," which means this is his second term in the gang, boasts that he is the only negro in the county wearing the name of Atkins. He is thoroughly acquainted out on the public works, and the shacks didn't seem to embarrass him in the least.

L. J. Sessions, the walking tiger, who donned the stripes last Friday, has repented and asked for a new trial. He was taken back to jail Sunday awaiting the termination of his motion.

**Roads Prepare for Last Fight.**

Montgomery, Ala., April 10.—When the railroads move on Tuesday next, as they have determined to do, to suspend a part of the order of Judge Thomas G. Jones of the circuit court, so they can proceed with the taking of testimony on the reasonableness of the rates that are a part of the commodity act, they are preparing the way for failure of the only two moves that seem now to be open to them, viz: application for rehearing and assumption of authority by the supreme court of the United States.

In making the orders for the injunctions, Judge Jones suspended any other action until the court of appeals had acted, such action being local only, on the filing of the mandate. This may be twenty-one days after the decree. To obviate the delay effort is being made to have the court allow pleadings and preliminary matters brushed away, so that the taking of testimony may begin at once, as a final matter, there is nothing else to do but put the rates in. The roads are going to contend that six months will be long enough, but the state will likely insist on a year.
