Man Refused to Join Separated Wife in Suicide Pact.

Hotter, Ark., Aug. 30.—Falling in her effort to induce her husband to join her in a suicide pact, Mrs. L. A. McShane grabbed a double-barreled shotgun and fired a load of buckshot into his body. As he fell lifeless to the floor the wife calmly reloaded the weapon and, using her foot to discharge the gun, blew the top of her head off.

The McShanes had been recently separated and McShane called on his wife at her request.

Jealousy Probably Caused Double Tragedy.

Brownsville, Tenn., Aug.—Returning from a drive, the family of John C. Pracht discovered in the parlor of their home the dead body of Owen Toleferro, one of the best known men of this community. Lying beside Toleferro was the dying form of Mrs. Virgie Rieves, a sister of Mrs. Pracht. Toleferro was shot in three places and Mrs. Rieves twice. Lying near the woman was an empty five chambered revolver. Mrs. Rieves lived but one hour after being discovered.

The motive for the crime was evidently jealousy on the part of the woman, who from all indications had killed Toleferro and then shot herself. Mrs. Rieves is a grass widow and lives in St. Louis. She came here several weeks ago to visit her sister, and made the acquaintance of Toleferro, in whose company she had been very much of late.

RICH AND POOR MUST FARE ALIKE.

Declares Governor Brown In Deciding Mitchell Case.

Atlanta, Sept. 2.—After spending almost the entire night in reading and considering the evidence and other documents in connection with the case, Governor Brown decided yesterday to let the sentence originally passed by the court in the case of William H. Mitchell, of Thomasville—twelve months on the chain-gang—stand.

Governor Brown disapproved the commutation or change in sentence recommended by the prison commission, which would have sent Mitchell to the state prison farm for twelve months instead of to the chain-gang in his home county, holding that the original sentence of the court is a correct one, and should in no respect be interfered with.

The governor expresses confidence that the authorities charged with the custody of the prisoner for twelve months will meet all the obligations in connection with his case that may be demanded by humanity.

This is, apparently, the end of the Mitchell case, and Mitchell must serve his twelve months' term in the chain-gang imposed by the court following his conviction of assault and battery upon Miss Lucile Linton, of Thomasville. There are still many mysterious phases of the case, which have never been brought to light.

What further steps he or his friends contemplate, if any, has not been made apparent, and it would seem there is no possibility of escape from the imprisonment and labor which he sought to avoid.

WHAT DR. COOK'S DISCOVERY OF THE NORTH POLE MEANS.

Vast Field for Scientific Research and Observation.

New York, Sept. 2.—A strip of land 30,000 miles in extent, sterile and inhabited only by polar animals, has been added to the area of the United States.

For the first time in the history of the world, an accurate chart of the globe may now be made. Dr. Cook's discovery will finally settle the question of the earth's ellipticity—whether or not there is a flattening of the surface at the poles.

A vast field for meteorological, tidal and magnetic research is opened by the discovery of the pole. Observations must be made there before a full comprehension of nature's laws and processes can be had. The prevalent view among philosophers has been that there was no land at the pole. Dr. Cook's effort has disproved this theory. "The value of the discovery in terms of money probably is nothing. As a scientific achievement its value is incalculably great."

And finally, that the great goal that had defied the efforts of explorers through the centuries and whose pathway was strewn with the bones of the most intrepid travelers of all the great nations of the world, should be first reached by an American, is a triumph that will be patriotically acclaimed from the St. Lawrence to the Rio Grande and from ocean to ocean.

Tom Watson Approves Action of Governor.

Atlanta, Sept. 2.—Gov. Brown received today a large number of letters and telegrams from all sections of the state strongly commending his action in upholding the sentence imposed by the Thomasville court in the case of W. H. Mitchell, of Thomasville, convicted of assault and battery upon Miss Lucile Linton and sentenced to serve twelve months on the Thomas county chain-gang.

One well known South Georgian, who, prompted by sympathy had signed a petition asking for clemency in Mitchell's case, wired that he could not withhold his approval of the Governor's action, although he felt the deepest sympathy for the prisoner and his family.

One of the most strongly worded telegrams came from Thomas E. Watson, who said: "I most heartily congratulate you on your decision in the Mitchell case. It was high time the country was being assured that there is not one sort of law for the friendless poor man and another kind of law for the criminal, who has influential connections."

Publications in certain papers have attempted to convey the impression that Gov. Brown has directed Sheriff Singletary, of Thomas county, to confine Mitchell in jail, which would, in effect, be a change of the sentence as imposed by the court.

This is incorrect. Gov. Brown has not given Sheriff Singletary any instructions to this effect, but has merely notified him, as is customary in such cases, that he has declined to interfere with the sentence of the court.

LYNCHING FEARED AT CARTERSVILLE.

TWO WHITES, ONE NEGRO.

Judge Refuses to Call Special Term of Court to Try Assaulters

Cartersville, Ga., Sept. 1.—An attempt to lynch three white men and one negro incarcerated in the local jail on charges of criminal assault is considered imminent, following the announcement late today that Judge Fite had decided not to hold a special term of court to try the men. It is believed that unless Judge Fite reconsiders and orders the special term of court the prisoners will be taken to Atlanta for safe-keeping.

While the jail has been guarded day and night for the past two weeks, it is not believed that the local officers could withstand an attack from a large mob, such as threatens to come from the upper part of the county and take the prisoners out and lynch them.

On petition of citizens Judge Fite last week decided to order a special term of court, to be held next week to try the assault cases. This afternoon it was announced that he had reconsidered and would not call the special term.

The prisoners charged with assault are: R. J. and John Worthington, white; William Golden, white, and Howard Stokely, a negro. The alleged victims of the three former are white, while Stokely is accused of assaulting a negro girl.

Mr. McGill, who writes the letter himself, says that he desires one of the stills for making whiskey and for the other for distilling essences. This will be good news to the turpentine operators in this section of the world, as they have been quite apprehensive over the possibility of Africa as a turpentine producing section, and have written the Messrs. McMillan a great many letters on the subject since the fact that inquiries from Africa for a still was first published in the Savannah Press about two weeks ago.

DR. FRED COOK REACHES POLE.

Message Received by the Danish Colonial Office From Ship on Which Explorer Returns.

WONDERFUL JOURNEY.

All Traditions Violated by Dr. Cook, Who Made Dash Through Ellesmere Land in Winter Time.

Copenhagen.—Dr. Cook, the American explorer, reached the North pole April 21, 1908, according to a telegram just received at the colonial office here.

The message was received from Lervie, Svalbard Islands: Dr. Frederick A. Cook, accompanied by Norwegian, left Etah, Greenland, March 3, 1908, taking with him eight Esquimaux, four sledges and twelve dog teams.

He was to make his way through Ellesmere Land.

Dr. Cook is on board the Danish government steamer Hans Egede, which passed Lervie at noon today en route for Denmark.

The telegram announcing Dr. Cook's achievement was sent by a Greenland official on board the steamer, and reads as follows:

"We have on board an American traveler, Dr. Cook, who reached the North pole April 21, 1908. Dr. Cook arrived at Upernivik, the northernmost Danish settlement in Greenland, on an island off the west coast coast, in May of 1909, from Cape York (in the northern part of Greenland) on Baffin Bay."

"The Esquimaux of Cape York confirm Dr. Cook's story of his journey."

For years Dr. Cook has given his attention to Arctic explorations and in 1891-92 was surgeon of the Peary Arctic expedition, and in 1897-98, surgeon of the Belgian Arctic expedition.

The doctor started on his present expedition in the summer of 1907, sailing from North Sydney, C. B., on board the schooner John R. Bradley. The party was reinforced with sledges, dogs and Arctic equipment at Etah, Greenland, whence they sailed, March 3, 1908. Dr. Cook's plan was to set aside all tradition by making a dash to the pole during the winter months when the elements are considered least advantageous for an advance northward.

The last news received from him was dated March 17, 1908, when he was near Cape Thomas Hubbard.

He then reported that he intended to push on to the northern point of Grant Land and from there start his dash to the pole in the winter of 1908.

ONE TRAIN ROBBER HOLDS UP PENNSYLVANIA TRAIN.

Crew In Express Car To Surrender.

Lewistown, Pa., Aug. 31.—A lone highwayman held up the Pittsburgh and Northern Express on the Pennsylvania road at Lewistown Narrows this morning, intimidated the train crew and robbed the express car in a daring manner. While there was thousands of dollars in the express car, the robber is believed to have secured only one hundred and ten dollars, and with this he made good his escape, but the railroad company is rushing bloodhounds to the scene and the capture of the desperado is believed to be almost certain.

The Pennsylvania railroad fast express, westbound, was stopped in the narrows, two miles east of here. The stop where the robbery occurred was an ideal locality for a hold-up. The robber placed an obstruction on the track and the engineer sighted it in time to save his train. The unusual stop brought Conductor Peffenberger forward. The robber, who was masked, shot him through the hand.

FARMER LADS ARE WANTED BY THE GOVERNMENT.

Good Positions For Those Who Have Agricultural Training.

Washington, D. C.—Students with an agricultural training who are familiar with laboratory and field work, with classes and varieties of cereals, are in demand by the government at salaries ranging from \$1,200 to \$2,000 a year.

The civil service commission has announced an examination on Sept. 22nd next to secure eligible positions as assistants in grain standardization in the bureau of plant industry of the department of agriculture. One of the requirements is the writing of a thesis of not less than 2,000 words on the kinds and classes of cereal grains grown in the United States and methods of harvesting and marketing with special references to classing and grading grain commercially.

ALL THE WORLD IS AGGLAM- ING DARING DR. COOK.

Story of Discovery of North Pole Seems to Be Generally Accepted.

Brunswick, Maine, Sept. 2.—Mrs. F. A. Cook, wife of the explorer, declined to talk at length today concerning her husband's achievement, declaring she did not desire notoriety.

"I am very glad that my husband has reached the pole and gained the chief desire of his life. I have always had great faith in the success of his undertaking, and have never for a moment felt he would not win."

This is all she would say.

Bagle Island, Maine, Sept. 2.—"If Dr. Cook has found the pole, I most certainly extend my heartiest congratulations," said Mrs. Robert E. Peary today, when asked if she thought Dr. Cook had reached the pole. Mrs. Peary is expecting a message from Commander Peary himself the middle of next month or sooner, and hopes that he, too, has been successful in his endeavors to reach farthest north.

New York, Sept. 2.—Members of

geographical, Arctic, exploring and other scientific societies in America do not in the least doubt that Dr. Frederick A. Cook, of Brooklyn, has really discovered the north pole. Notwithstanding the doubt cast upon the first reports from Copenhagen, especially in Berlin and Rome, the intimates of Dr. Cook here declared that when the explorer reaches Copenhagen, which probably will be Saturday afternoon, he will be able to amply verify his claims. Scientists declare that they can easily tell from Dr. Cook's records and figures if he reached the pole.

Gun Accidentally Discharged by Friend.

Greensboro, Ga., Sept. 3.—Charlie Smith met John Floyd in the public road in the 14th district and pointed a repeating Winchester shot gun at him. Floyd made some remarks about the matter. The gun was discharged and Floyd fell mortally wounded, shot in the breast. He lived about one-half hour and exonerated Smith from any intention of harming him.

Smith says he did not know the gun was loaded.

Jaeckel Hotel Closed.

On Saturday afternoon the doors of the Jaeckel hotel were closed to the public. This action was taken by Manager G. Jaeckel, who had decided that it was no longer profitable for him to continue its operation owing to the fact that his time was altogether taken up with the management of his interest in the New Screen house in Savannah.

The Jaeckel has been under the management of Mr. C. R. Baggot, a brother-in-law of Mr. Jaeckel, for some time. Mr. Jaeckel has a lease on the property until February, 1911, but he has made several efforts to dispose of his lease together with the furniture, but so far no trade has been consummated. The people of Statesboro, as well as the travelling public, are anxious to see the hotel opened up again. It is one of the best in this section of the state, and it is to be regretted that it is closed, which we are sure will be only temporary.

SUBSTITUTE ON END OF A ROPE

Negro's Brother Lynched When Mississippi Mob Loses Slayer.

Clarksdale, Miss., Sept. 6.—Unable to get their hands upon the negro, Nathan McDaniels, who is alleged to have shot and killed Policeman Walter Marshall when the latter attempted to raid a crap game here on Saturday night, and who was captured by a party at Duncan, Miss., last night and spirited away to jail at Jackson, a mob of hundreds caught McDaniels brother, Hiram McDaniels, at midnight and lynched him, striding him up to a telegraph pole on the spot where young Marshall fell dead after being shot.

There was no shooting, no noise and few people outside of those actually formed the mob knew anything about it until afterward. Hiram McDaniels had admitted furnishing a mule to aid his brother's attempted escape.

Nathan McDaniels was caught by a posse of fifteen men headed by Circuit Court Clerk F. G. Wingfield in a swamp near Duncan, Miss., late last night. The negro was carried to Duncan, held there for Sheriff Baugh and Deputy Sheriff Talbot, of this county, who had been notified, and placed in the hands of the officers when they arrived and hurried from Duncan to Cleveland, where he was given over to Sheriff Wray of Bolivar county to be taken to Jackson and placed in jail.

DR. COOK LECTURED IN GEORGIA TOWNS.

North Pole Discoverer Has Been Here and May Come Again.

[From Atlanta Constitution.]

Dr. Frederick A. Cook, the first man to discover the north pole, has lectured in Georgia and will probably do so again in Atlanta and other tothern cities next year under the Alcahest Lyceum system. That the people in this section will hear this noted explorer once more seems almost a certainty.
