## LITTLE MUST DIE FOR MURDER OF SIX

Most Atrocious Crime in Virginia's History.

Grundy, Va., November 27.—Howard Little was today found guilty of the murder of George Meadows, his wife and three children and "Aunt Betty" Justice, 70 years old, near Hurley, several weeks ago, by a jury in Judge Burns court. He was immediately sentenced to die in the electric chair at Richmond, Va., January 7th.

The killing of the six people was the most atrocious crime in Virginia history. The man, to get money to leave his wife and elope with a married woman, entered the Meadows home at night. He killed Meadows by striking him on the head with his Winchester while the man was sleeping. He then killed the defenceless woman and her three children. "Aunt Betty" Justice was shot through the head. The sextupole murderer then set the house on fire and cremated the bodies.

Feeling ran high among the Virginians, who immediately started a search for the guilty man. Little was arrested and placed in the jail at Lebanon. The news spread like wildfire and a mob was organized. The man was moved, under a guard of twelve armed officers, to the Grundy jail before the mob appeared. One of the most damaging pieces of evidence against Little was a bloody penny he had given to a newsboy the day following the crime. His wife and daughter have both desecrated him. He threatened to kill his wife if she told he was not at home on the night of the murder.

During the trial Little made no defense, letting the case go to the jury without a fight. He was taken to Richmond.

## NO SPOTS ON THIS "SUN."

The Show That Will Exhibit Here on Dec. 4th.

## YEAR IN FEDERAL PRISON IS SENTENCE GIVEN DAVE FINCH.

Also to Pay Fine of \$1,000—Plea of Not Guilty Withdrawn; Plea of Guilty Entered.

Savannah, Ga., Dec. 2.—D. C. Finch, who was some time ago arraigned in the United States court, plead not guilty and afterward withdrew his plea and entered one of guilty, was sentenced by Judge Emory Speer this morning to a term of one year and one day in the penitentiary in Atlanta and to pay a fine of \$1,000.

In passing the sentence upon Finch the court reminded him that he was a man of considerable influence, had a strong family connection, held the same way at his home as the head of a clan of Highlanders enjoyed. The court spoke of Finch having been tried, convicted and having served a sentence for an equivalent offense before the state courts. The sentence at that time was a fine of \$1,000, a period in jail and the defendant was afterward pardoned.

The manner in which the violation of the law was effected was a most unworthy one, said Judge Speer, and not that of a good citizen. The responsibility had been shifted upon the shoulders of an old negro. The handling of the liquor had been represented as a business in a measles medicine and in other misleading ways, and indicated a character other than the real substance of the commodity. The court said it understood that Finch was worth one hundred thousand dollars. If he were poor it would mean that the sentence would be light.

"I will not inflict an extreme sentence, but a severe one," said Judge Speer, "which will act as a deterrent to those who would violate the law."

The court said he would not discuss the prohibition law, but he would refer to the devastating, unenvying effects of fiery stimulants upon the African people.

The whole idea of the wave of prohibition in our section of the country was to prevent the same effect which the United States government strives to effect when it prohibits the giving of liquors to the Indians.

The words of the court made a profound impression upon those who heard them.

Finch will immediately begin the serving of his sentence.

Finch is from Statesboro and is a man of considerable influence in Bulloch county. He is in jail here now, having been taken in custody after his sentence. He has been out on bond.

## NICARAGUAN ENVOY GIVEN PASSPORTS.

Slain Americans to be Avenged on Zelaya Personally.

### UNITED STATES ON WAR'S VERGE

Secretary Knox Voices President's Views in Scathing Denunciation of Zelaya—A Decisive Action.

Washington, D. C., Dec. 1.—Secretary of State Knox late today returned the passports of Felipe Rodriguez, charge d'affaires of the Nicaraguan legation, with a letter scathingly denouncing the Zelaya administration of the government of Nicaragua. The letter is definitely declared to represent the views of President Taft, and is about as plain spoken as anything emanating from the state department in years.

The extraordinary feature of the letter is that it seems to evidence an intention on the part of the United States to hold President Zelaya personally responsible for the alleged torture and execution of the two Americans, Cannon and Groce, and exhibits the uniqueness of one government holding the chief executive of another presidency as a common malefactor.

Zelaya is branded a violator of solemn international conventions, a disturber of the national and international peace, a tyrant whose administration has been a blot upon the name of good government.

Secretary Knox virtually announces the recommendation of the Nicaraguan revolutionists, declares it to be the conviction of the United States that the revolution represents the sentiments of a majority of the N. C. a man people, that there is evidently no responsible government with which the United States can deal.

He therefore announces that all parties will be held accountable for their actions as affecting the interests of Americans and the people of Central America.

He further informs Senator Rodriguez that while he has lost his diplomatic quality, he may still serve as an "unofficial" channel of communication with the faction which he is regarded as representing.

This brings the crisis as near to the status of war as it could be brought by executive action without a dynastic declaration by both houses of congress, which will convene next Monday.

Mr. Knox's letter, in all but so many words, makes it plain that the action represents the wish and attitude of all the Central American states with the single exception of Honduras, which is regarded here as entirely dominated by Zelaya. Mexico has all along shown its sympathy with the United States in this matter.

Just what status the consular representatives of the United States in Nicaragua now enjoy is not definitely explained tonight. It is expected, however, that Vice-Consul Caldera, who has been occupying the legation in Managua, together with the other consuls in that country, will be given their passports tomorrow. This is the usual method of procedure in case of such action between governments.

When seen tonight Senator Rodriguez was much excited in manner, but his discussion of the situation was brief.

"We are stricken to the heart; we are paralyzed," was his expression.

## IRA PERKINS KILLS NEGRO

Prominent Young Bulloch County Farmer

### SHOOTS JOHN COLEMAN, JR.

Killing Was Culmination of Row Over Division of Crops—Negro Was a Tenant.

Ira Perkins, one of the substantial young farmers of Bulloch county, living in the neighborhood of Macedonia church, came to town Thursday morning and notified the sheriff that he had had a shooting scrape with John Coleman, Jr., a colored man, who had been a tenant on his farm. The negro, he said, had threatened to shoot him, but that he got the drop on Coleman and shot first.

The negro fell and Mr. Perkins, without waiting to see the result of his pistol shot, came directly to town and gave himself up.

Sheriff Kendrick questioned him very closely about the matter and came to the conclusion that Perkins was excited and that there was some very grave doubt as to whether the shot took effect or not. He, therefore, allowed Mr. Perkins his freedom to walk about as he chose, and not hearing anything further from the trouble, Perkins was permitted to return home.

Yesterday morning, however, news reached the city that the negro was dead and a warrant was, consequently, sworn out for Mr. Perkins and Sheriff Kendrick went out and placed him under arrest.

The circumstances leading up to the shooting, as related here, were, in effect, about as follows:

The negro and his family were tenants on the farm of Mr. Perkins, but they were an impudent and shiftless set and, taking advantage of the kindly nature and disposition of Mr. Perkins, had gotten deeply in debt to him. So badly were they in debt that the little crop that they had made was not sufficient to pay out, and they were preparing to move away to another farm and leave Mr. Perkins in the lurch, the time having arrived for harvesting the corn crop, and Mr. Perkins told the negro that he must not carry the corn off the place until he had settled his indebtedness. This command he ignored and had hauled away a load when Perkins intercepted him. A few words followed and the negro attempted to draw a pistol, but Mr. Perkins was a little too quick for him and, drawing his pistol, he fired. He then came to town and reported the matter to the authorities.

### PATTERSON SENTENCED

To Hang for M'Ree Murder.

Americus, Ga., December 2.—The trial of Henry Patterson for the murder of Captain W. F. McRee, on the Bagley plantation, near Americus in July, concluded this morning with a verdict of guilty. Patterson will be hanged for the atrocious crime. An attempt was made to inject a plea of unwritten law in the trial, but the jury didn't believe the statement of the witnesses, two of whom were immediately jailed upon the charges of perjury and subornation of witnesses. Patterson will probably be hanged in January.

### Eulogy Upon the Fickle.

#### Fleeting Glory—Fame.

How like a drifting cloud, a dancing mote, a flitting ghost, is fame! A platitude, of course, but even platitudes are sometimes true. This one belongs to that rare minority. It is proved anew a million times a year. Where are the star pitchers of yesterday? Who gives a thought these days to Nan Patterson. Is Jake Kilrain still alive? What has become of Dreyfus? Who knows the addresses of Cipriano Castro, Cohn Harvey, Mrs. Leese, Gen. Coxy and Eugene S. and? Who was vice-president in 1888?

Even the noblest souls sink finally into neglect and oblivion. For a moment the spotlights of a whole nation concentrate their blazing rays upon one form, or one pair of flashing eyes, or one bald head—and then they shift and darkness envelops that superhuman. One calls to mind a magnificent creature whose perfections enchanted the plain people but a few years ago! He was tall, bald, whiskered, handsome and happy; a great partisan of the plain people, a jealous watcher of the constitution. He had no human sins and no bad habits. Buttermilk was his only beverage; he abhorred all malt liquors and huddling grape juices; the insidious cocktail made him shudder with horror. Arctic, imputable and austere, he presided like some marble image, some inert incarnation of jurisprudence over the most opulent and virtuous deliberative body in the world.

Naturally enough the great masses loved and admired this colossus. When he visited an Indiana county fair the peo-ants, in their eagerness to behold him, trampled one another to death. His portrait graced ten million fireplaces; his incisive apothegms and aphorisms entered into the very grammar of homiletics; he seemed the legitimate heir of Socrates, Francis Bacon, Cotton Mather, John Bunyan and Geoffrey of Bouillou. Among all the patriots there was none so all-fired patriotic. Folks began to wonder what the world would do with him after he had served two or three terms as president.

And yet that towering giant, that animated colossus, that pearl of great price, is today an obscure commoner, robbed alike of his whiskers and his fame, and with none so poor to do him reverence. Gone is his portrait from the American hearth, gone is his image from the American heart. His very name is forgotten. The comic journal, called Judge, prints a crude wood cut of him and offers \$10 to anyone guessing whom it represents. The New York Tribune, last stronghold of chemically pure republicanism, refers to him, in a staring headline, as "Mr. Fairchild?" Ah, woe! Is this to be the finish of that serene and remote spirit, that most republican of all the republicans—Charles Warren Fairbanks of Indiana? Is he so soon forgotten in the citadel? Is Mohammed a mere disordered dream, a vague memory, an uncertain specter, in Meccah? Who turned that picture toward the wall? What wind blew out that meteor?—Dublin Courier-Dispatch.
