TIMES DRIFTING TOWARD UNIVERSAL PROHIBITION

President of W. C. T. U.
Makes Stirring Address
at Seattle.

Seattle, Wash., Oct. 11.—There was a ringing note of triumph in the address with which Anna A. Gordon, the president, greeted the first business session of the National Women's Christian Temperance Union here today. Her address came after the report of the executive committee and the appointment of credentials and other committees. It swept the world as affected by the crusade against alcohol, and found therein great cause for rejoicing.

Miss Gordon's address was voluminous. It dealt in detail with all branches of the work—prohibition by constitutional amendment; the situation in Europe; total abstinence; the progress of women's suffrage, in which temperance workers are prominent; the work of the young people; the movement of a Frances L. Willard day in the public schools, and a map showing prohibition territory for the same institutions. She reported a net gain of 29,709 members in 1915.

Declaring that "the world will banish John Barleycorn," Miss Gordon said:

"The extraordinary gain for prohibition in Russia, France, Germany, England, Italy and in all the vast areas involved in the European war, is unprecedented. By one official edict Nicholas II., Czar of Russia, emancipated that nation from the thrall of vodka. Later even the use of wine was proscribed. Russia thus lost an annual vodka revenue of many millions of dollars, but she gained a larger revenue through the morality and the efficiency of her people. The controller of the treasury, Kharitonoff, affirmed: 'Russia without vodka and with the war is better off than Russia with vodka without the war.' There is reason to believe that the czar, on the re-establishment of peace, will continue his prohibition policy.

"As Russia interdicts vodka, so France, as a war measure, has prohibited the manufacture and sale of absinthe. General Joffre, convinced that drinking soldiers endangered the safety of the country, has forbidden the sale within the war zone of all alcoholic liquors.

"In Switzerland, Holland and Belgium the sale of absinthe has been interdicted. In Germany, army recruits are warned by the government against the use of beer, because it is injurious and causes, nearly all army excesses and disturbances.

"Another nation in the throes of a struggle against alcoholic drink declared by eminent men and women to be the country's bitterest enemy, is the Kingdom of Great Britain. In our western hemisphere we have welcomed the glad tidings from Alberta and Saskatchewan, province in Canada that have driven out the liquor traffic, and as loyal Pan-Americans we long to help the drinking millions in South America.

"Last January Iceland outlawed the liquor traffic. The Roumanian government has cut down the number of saloons in its country nearly 50 per cent. The parliament of Italy has passed an act forbidding the sale except within very narrow limits and rigid conditions, of all liquors.

"In Holland the number of saloons has been reduced nearly one-half and campaigns for nation-

WAYCROSS HOTEL BURNS

W. B. Ellington Loses His
Life—Loss \$170,000

Waycross, Oct. 10.—The LaGrande Hotel, covering an entire city triangle, was destroyed by fire early this morning. So far as known only one guest lost his life in the flames. Two firemen were injured. W. B. Ellington, real estate man, was killed by leaping from a fourth-floor window. The loss is \$170,000.

The fire originated in the kitchen on the second floor at 2:30 o'clock this morning. The flames spread rapidly and the guests of the hotel had difficulty making their way from the building.

When Ellington awoke he found that the stairway had been cut off. He ran to a window and leaped to the street.

The lower floor of the LaGrande Hotel was occupied by many business concerns and the right wing had been used for business offices. The Western Union was among the offices burned out. Six streets were blocked by falling walls.

THE CENTRAL OF GEORGIA'S RULES

Regarding Bulky Baggage
Passenger Coaches.

"Rule No. 835: Conductors must not allow passengers to carry into passenger cars bulky packages or other articles which obstruct the aisles, seats or the space between the seats to the inconvenience of other passengers. Articles of this description, which are entitled, to be carried as baggage, must be sent to the baggage car and checked. If not entitled to be so carried, they must be forwarded by express or otherwise disposed of by the owner.

Overhead racks are provided in passenger cars for such articles as coats, wraps, hats, umbrellas, etc., and conductors should see that heavy articles, which might, in falling, injure a passenger, are not permitted in racks.

Explosives and highly inflammable articles, such as fireworks, loaded firearms, gasoline and moving picture films may not lawfully be taken into passenger cars.

Under no circumstances should baggage or any other package be permitted to remain in the aisles of passenger coaches, sleeping cars, or parlor cars.

"The Wholesale Liquor Dealers Association appropriated \$50,000,000 for the fight against the national prohibition amendment," declared Mrs. Francis P. Parks, corresponding secretary of the National Women's Christian Temperance Union, in her annual report to the forty-second annual convention of that organization today.

The treasurer's annual report showed a balance of \$60,000 on hand.

Report of Trades Conditions
South Atlantic States
October 9th.

ATLANTA.—In most all lines of business improvement continues, with more favorable outlook apparent than has existed for past year. Unseasonable weather conditions and rain the past week, combined with the last cotton reports showing a still further shortage of the crop, have advanced the price of cotton. This, with the ready and increasing demands for the staple, has brought about a more satisfactory situation in the cotton belt, improving the condition of the farmers, enabling them to take care of their debts more satisfactorily and benefiting the supply merchants, as well as stimulating wholesale and retail trade generally. Money continues plentiful and at low rates. Bank clearings and deposits are showing steady increase. Collections, on the whole, are reported satisfactory.

MACON.—General improvement is noted in practically all lines of trade. Bank clearings are showing considerable increase and collections are coming in very well. Orders are more numerous from country merchants, though there is still a tendency on their part to buy only for immediate needs. The upward trend of the cotton market has had a stimulating effect on retail trade, and there seems to be a more optimistic feeling generally in all lines. Weather has been favorable for gathering cotton. Moisture is needed for the preparation of the soil for seeding winter grain and cover crops.

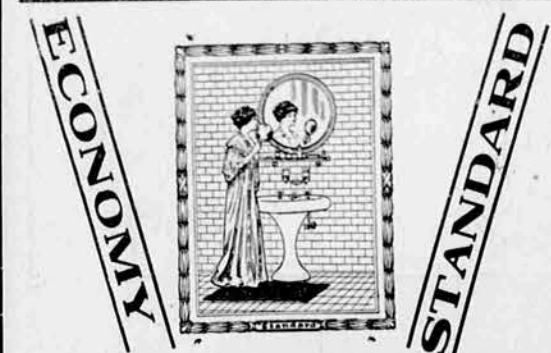

MISS PEARL WHITE

The Popular Actress Now Playing in Exploits of Elaine at Star Theatre.

"The Director Who Crosses My Path at Every Turn In My Career—Mr. Theodore Wharton."

(By Pearl White—The Pathe Star.) Miss Pearl White, the famous moving picture star, can hardly be called a superstition, but she feels that Theodore Wharton, the Pathe producer, is her guiding star, and

when he advises anything she can be depended upon to follow the advice without question. She explains this feeling as follows:

"About five years ago I was leading woman of a stock company playing near New York, and was just about played out. I'd had no vacation in a long time, and my voice needed a rest. Mrs. O. L. Miller joined the company one week and suggested that I go into moving pictures. 'Sure! I'm willing,' says I, 'but where can I get a job?' She gave me a list of film companies, so the next morning I dressed in my best, went to the theatre, rehearsed my next week's play until noon, and then caught a train for New York. It was January, the thermometer was below zero, and there were several feet of snow on the ground. Oh, yes, be sure I remember it very well!

"Arriving in New York I set out on foot to a film studio in 19th Street. You see money was scarce with me then, and I wanted to save that nickel. I asked to see the man who engaged the players and was asked to wait. After a while a man walked out and said, 'I am Mr. Wharton, the director, and the man who engages people.' I was very young and very small, and he seemed about eight feet tall. I asked him for a job and, as he afterwards admitted, he took me for a young thing from the country with a stage bee in her bonnet. So, in a very fatherly way he gave me a lot of advice, told me it was hard to get an engagement in pictures, and still harder to keep it—that if I had a job of any sort to stick to it. He said he had no opening for me at that time but later if I was in New York permanently, he might be able to use me once in a while.

"I went back to my show somewhat disappointed but still determined. The next week I came again to New York and saw the second name on my list. There the director took me more seriously, and offered me and engagement beginning with the next week. I stayed with that company for one year, and then determined to try a bigger concern. So I went over to Jersey to the Pathe Studio and asked to see a director. In a couple of minutes I was in the presence of Theodore Wharton again. This time he was more encouraging and recommended me to a fellow director. I was engaged and remained with the Pathe for some years, but Theodore Wharton left the company the day after I joined my affairs again took a turn.

"I had just finished 'The Perils of Pauline' and my contract was nearly over with the Pathe. I

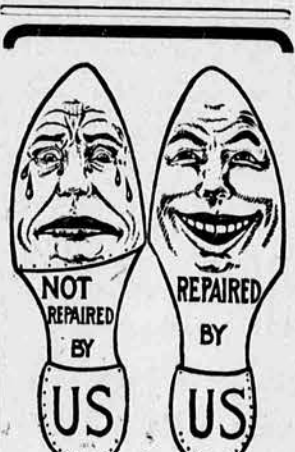

THANKSGIVING PROCLAMATION

By the President—Thursday November 25th

Washington, D. C. Oct. 21.—President Wilson today in a proclamation designated Thursday, Nov. 25, as Thanksgiving day called attention to the fact the United States has been at peace while most of Europe has been at war.

"We have been able to assert our rights and the rights of mankind without breach of friendship with the great nations with whom we have to deal," said the President.

The text follows:

"It has been the honored custom of our people to turn in the fruitful autumn of the year in praise and thanksgiving to Almighty God for his many blessings and mercies to us as a nation. The year that is now drawing to a close since we last observed our day of national thanksgiving has been, while a year of discipline because of the mighty forces of war and of changes which have disturbed the world, also a year of special blessing to us.

Another Year of Peace

"Another year of peace has been vouchsafed us; another year in which not only to thank thought of our duty to ourselves and mankind, but also to adjust ourselves to the many responsibilities thrust upon us by a war which has involved almost the whole of Europe. We have been able to assert our rights and the rights of mankind without breach of friendship with the great nations with whom we have to deal, and while we have asserted rights, we have been able also to perform duties and exercise privileges of succor and helpfulness which should serve to demonstrate our desire to make the truly of friendship the means of truly disinterested and unselfish service.

"Our ability to serve all who could avail themselves of our service in the midst of crisis has been increased, by a gracious Providence, by more and more abundant crops; our ample financial resources have enabled us to study the markets of the world and facilitate necessary movement of commerce which the war has made possible; and our people have come more and more to a sober realization of the part they have been called upon to play in a time when all the world is shaken by unparalleled distresses and disasters.

Prosperity Here

"The extraordinary circumstances of such a time have done much to quicken our national conscience and deepen and confirm our confidence in the principles of peace and freedom by which we have always sought to be guided. Out of darkness and perplexities have become firmer counsels of policy and have clearer perceptions of the essential welfare of the nation. We have prospered while other people were at war, but our prosperity has been vouchsafed us, we believe, only that we might the better perform the function which war rendered it impossible for them to perform.

"Now, therefore I, Woodrow Wilson, president of the United States of America, do hereby designate Thursday, the twenty-fifth of November next as a day of thanksgiving and prayer, and invite the people throughout the land to cease from their wonted occupations and in their several homes and places of worship ren-

The Georgia Harvest Festival Week.

Atlanta, Ga., Oct. 27th.—Governor Nat. E. Harris has issued a special proclamation making Thursday, November 18, Agricultural Day of Georgia Harvest Festival week, a state-wide event and holiday.

Agricultural Day is the day on which the great agricultural parade will be held in Atlanta, and several hundred thousand people are expected from every section of the state. There will be special railroad rates and places of business will be closed in response to the request of the governor, in many towns and counties throughout Georgia.

The celebration of Agricultural Day in Atlanta will be essentially a state-wide event and will probably bring the largest crowds of the week to this city.

Following the issuance of Governor Harris' proclamation, suggestion has come from many sources that it would be a fine idea to have a day set apart every year by proclamation in Georgia for Agricultural Day, just as Arbor Day, Memorial Day and Thanksgiving Day are now appointed by special proclamation.

It will be good-by to French chefs, city cooking and delicatessen dainties in Atlanta on Agricultural Day Thursday, November 18. The agricultural feature of Harvest Festival week will be gastronomically celebrated on that day, as all hotels and restaurants in Atlanta have agreed that they will serve a special Georgia produce country-cooked dinner. In addition, of course, will be held the big annual Georgia Products dinner at the Auditorium-Armory.

The Agricultural Day program is in charge of the Ad. Men's club of Atlanta and will combine a number of big features, the chief of which will be the monster agricultural parade. The Southeastern Fair will be in progress. Over 2,000 boys and girls of the Corn Clubs and Canoeing Clubs will be here; the ball weevil conference will be here. There will be a big ball at the auditorium; there will be carnival attraction, fireworks, aeroplane battles, fashion shows and many free amusements on the streets.

FAY ADMITS PLANNING TO DESTROY U. S. SHIPS

A Serious Offense Against Our Nation.

Washington, D. C., Oct. 25.—If the State Department determines that Robert Fay is telling the truth in his story to the New York police of how he, a lieutenant in the German army, was sent here by the German secret service to disable steamships lying at American ports destined for Europe, the matter probably will be made the subject of vigorous representations to the German government.

State Department officials were much interested today in press accounts of Fay's confession, and it said that a report on the case would be expected tomorrow from agents of the secret service who assisted in arresting Fay and alleged accomplices.

The American government, the officials said, would regard such an action as Fay attributes to the German secret service as a grave offense against the United States. As to Capt. By-EI and Capt. von Pappe of the German embassy, it was said that if Fay told the truth in his so-called confession no blame could be attached to them. Fay is quoted as having said that Capt. von Pappe refused to have anything to do with the scheme.

All the information in the hands of the State Department has led officials to believe that no action toward prosecuting Fay and his alleged co-conspirators could be taken by the federal authorities. In fact it was pointed out, the government might appear more in the nature of a defender than prosecutor when the men came to trial in the New York or New Jersey courts for the reason that it is bound to see that all rights of Fay
