MOTION:

That the Faculty Senate request that the Provost/Vice President for Academic Affairs increase the 2009-2010 allocation available to the Faculty Development Committee by an amount that will allow funding each summer stipend awarded at the level of \$4,000, plus fringe benefits, instead of the current level of \$3,000, plus fringe benefits.

RATIONALE:

Although members of the Faculty Development Committee, a committee of the Faculty Senate, voted unanimously to make this request, budget constraints prohibit implementation of this plan for FY 10.
