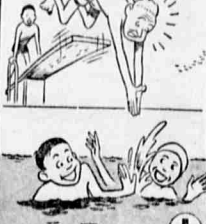

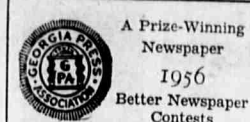

## Editorials

### Want to help?

So you want to do something for the community?

And so you are already doing your bit? That's fine and commendable. Then this is not for you.

This is for you who would like to do something specific for the city's Recreation Center.

Near the swimming pool is a little clump of trees and a concrete patio. Its purpose is for picnicking crowds and outdoor gatherings during the spring, summer and fall months, when outdoors can be so delightful.

If a rain comes up—and we've been blessed with rains this summer—groups using the patio and picnic area get drenched, which makes the rest of the party uncomfortable or breaks the gathering up altogether.

A movement is afoot to put a cover over the concrete patio. Several civic-minded citizens have already contributed generously to the project. It has the endorsement and support of the Statesboro and Bulloch County Chamber of Commerce.

A stop sign on 301 and the stop light over the intersection stops 301 traffic. And for the timid and safety-conscious driver it's a problem breaking into traffic with the right of way.

A study could be made of the traffic pattern there and we believe that something could be done.

Of all these important projects, none is more important in the long run than the new library. The quiet appeal and immeasurable value of books is often overshadowed by the drama and color

of business development, political combat and spectator sports but books continue to be civilization's depository of all worth-while knowledge.

Screven county's library provides young people and adults alike with windows through which they can look out on the vast and varied world. Such a valuable resource deserves a fine building.

Going up on East Ogeechee street is a structure that would seem to be just that. A walk through its interior reveals it to be much more spacious than might be expected by anyone who knows how limited the funds provided are and a glance at the plans and specifications show that it is to be modern and efficient in every respect.

The credit for the ingenuity that is providing the county with 6,000 square feet of modern library building at a cost of less than \$28,000 should go largely to Knapp Boddiford, county school superintendent and a member of the county library board.

Boddiford, who as school superintendent has supervised the construction of more modern school buildings than Screven countians could have dreamed of a couple of decades ago, is applying his "know-how" to the problem of providing the county with a maximum of library facilities at a minimum of cost.

### Lifesaving important

Riding over Bulloch county we are impressed with the growing number of ponds. Built as part of a soil conservation program, as a source of recreation, fishing, swimming and boating, they are a fine thing for our county.

And upon viewing these wonderful addenda the question pops into our mind, "Wonder how many of the kids and adults swimming or boating or fishing in these ponds know anything about lifesaving?"

We believe that every kid, when he can, should take a course in lifesaving, such as the one offered at the Statesboro Recreation Center. To know the fundamentals of lifesaving is valuable from a personal safety angle as well as for the safety of all who go into the water.

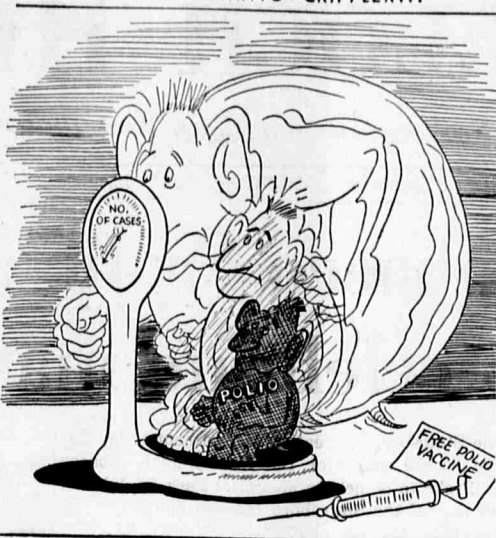

between June 1940 and September 1950. Survivors of many deceased servicemen and veterans who died within this period were originally denied social security benefits. They were told at the time of death that the deceased had not worked long enough on jobs covered by social security. In many cases even the use of the military service wage credits did not make benefit payments possible.

Effective September 1, 1954, many survivors of deceased veterans became eligible for benefits for the first time. The new law requires only 6 quarter years of coverage for an insured status for those who died between June 1940 and September 1950. Many deceased veterans qualify on their military service alone.

Widows age 65 and younger widows with minor children under age 18 who were previously told they were not

eligible and who have not contacted the social security administration since August 1954, should do so without delay. Benefits may now be payable. In some cases dependent parents of the deceased may qualify for benefits if there is no other eligible survivor.

Payments to a widow and two minor children range from \$50 to \$200 per month. For aged widows and aged dependent parents the range is \$30 to \$81.40 per month.

DISABLED VETS  
Veterans who are disabled and unable to engage in a substantial gainful activity are urged to contact their social security office for the purpose of "freezing" their social security record. Time lost from employment under the law usually reduces benefits payable. Disabled persons who meet other requirements may "freeze" their account so that the lost time due to disability will not count against them. It does not matter whether the disability was incurred in civilian or military life. A certain amount of social security work is needed for this purpose, and military service wage credits count toward this requirement. Social security district offices have free pamphlets which explain these requirements.

Claims and inquiries on any phase of the social security law should be made at the nearest district office of the Social Security Administration.
