

Mrs. William L. Deal Dies From Burns Sustained From Auto

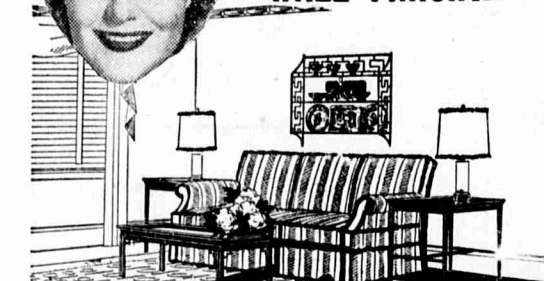

## Your Check Will Come If You Follow Rules

In schools and colleges, in factory and shop throughout the Statesboro area, hundreds of veterans are continuing their training and education through the Veterans Administration. To all of them, the monthly check for subsistence is an important part of living; many thousands get it regularly and on time, some do not.

Because recent laws have led to many changes in the procedure whereby VA determines the eligibility of a veteran to receive subsistence and the amount which he may be paid, many veterans do not understand the amounts to which they are entitled. Many more do not get their checks on time because, through lack of knowledge of what is required of them, they fail to cooperate in the program.

Here are some tips from the Veterans Administration to veterans who look forward anxiously each month to that subsistence check. Always submit the earnings report promptly. Once every four months, VA sends a form for this report to the veteran to be filled out. The amount which a veteran earns is not limited; however, under the law VA cannot pay subsistence to veterans with dependents whose income is more than \$200 a month. For veterans without dependents the ceiling figure is \$175. Don't, VA officials caution, include subsistence payments as earnings. What the government wants to know is the veteran's total income exclusive of subsistence payments. Don't include occasional overtime payments as income. Only if overtime is scheduled on a regular basis, should such payments be listed.

Many veterans have had subsistence suspended because the school or place of business where they entered has not been approved by the state for participation in the program. A veteran should know whether an institution or establishment is approved before he begins school or training. Some institutions, particularly firms offering on-the-job training, have recently been taken from the approval list. This is because the firm had failed to provide a genuine training program. Most employers are willing to correct such a situation; if they are not, the veteran has no alternative but to train elsewhere if he wishes to continue to receive subsistence. A veteran is not necessarily required, however, to take related technical instruction at night. Some employers require it as a part of their job training program; others do not. It all depends on the type job which the veteran is training and the particular veteran involved. It is the employer's responsibility to determine whether related technical instruction will be required of a particular veteran.

Subsistence checks for other veterans are delayed because veterans fail to submit evidence of dependency. To receive the increased subsistence paid for dependents, a veteran must submit a certified copy of the public record of marriage or of the birth of children or proof of dependency for parents.

Above all, VA advises, if there's a delay in a check, don't wait, but go to the VA office at 21 1-2 East Main Street, Statesboro, Georgia, and tell a contact representative about it. Sometimes the VA's fault, but in many cases the veteran himself has failed to supply the proper evidence to entitle him to receive a check.

Plans are already underway by the officials of the Southern Air Lines, Inc., to begin this passenger service within the near future. Stops on the flight from Savannah to Atlanta will include Statesboro, Swainsboro, Dublin, Macon, and Milledgeville. Two round trips daily will be made between Savannah and Atlanta.  
These trips will be made in the daytime.  
Southern Air Lines is a privately owned corporation and Charlie Olliff, president of the Sea Island Bank, is a member of the board of directors.  
Let's hope nothing changes the plans of the officials of the new airline setting up this passenger service for Atlanta to Savannah, and let's hope they continue to keep Statesboro on the schedule as one of their "stops".  
And speaking of travel, the Central and Georgia Railway has come up with a new idea in travel. They are going to let you "charge" it" after April 1, according to Mr. T. J. Stewart, Passenger Traffic Manager.  
"The travel credit card system," Mr. Stewart explained, "will be as easy as a department store charge account. It is to be available to individuals, firms or corporations upon application to the Comptroller of the Central of Georgia Railway Company, Savannah, Georgia.  
Under the new "charge" system, an individual may make application for Credit Card, and upon receipt of his or her card, use it at any Central of Georgia ticket office in lieu of cash payment on all kinds of rail, sleeping car or parlor car tickets which are routed in whole or in part via Central of Georgia lines.  
The Credit Card will be honored, also, at Central of Georgia Baggage Offices for charges assessed on excess weight or valuation of baggage, and for storage of baggage.  
In the case of company or corporation, the firm may make application for Credit Cards to be issued to one or several employees, billing to be made directly to the firm.  
Billing for all charges made on a Credit Card will be submitted to the individual or business firm soon after the first day of the succeeding month. Bills will be agents.

## VETERANS CORNER

(A public service feature offered by The Bulloch Herald in cooperation with the Statesboro Contact Office of the U. S. Veterans Administration.)

Does the Veterans Administration employ disabled veterans in its offices. How long can veterans carry wartime National Service Life Insurance policies?  
Here are the answers to these and other questions of interest to veterans:  
Q. Are there any restrictions on which you have lost type of work I do?  
A. No. The insured may engage in any occupation, no matter how hazardous, live where he likes, and travel any way he chooses, without affecting the value or cost of his insurance policy.  
Q. How long can I carry the World War II National Service Life Insurance that I bought while in service?  
A. National Service Life Insurance was issued originally upon the 5-year level premium plan, which was extended three years for all policies issued before January 1, 1946. However, veterans have the privilege of conversion to a permanent plan after their term insurance has been in effect for a year. If term insurance has been converted, it remains in effect as long as the premiums are paid.  
Q. I am a veteran with a service-connected disability. Does the Veterans Administration hire disabled veterans for work in its offices?  
A. Yes. It is the policy of VA to employ disabled veterans and other physically impaired persons whenever possible.  
Q. My first husband was killed in World War II and I remarried. I divorced my second husband and now would like to know if my widow's pension can be reinstated?  
A. Existing legislation provides that compensation or pension shall not be allowed to a widow of World War II who has remarried. Her status cannot be changed if she is divorced.

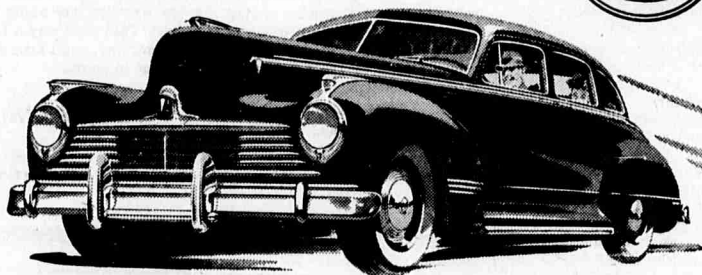

**Bulloch School Busses Pass State Check-Up**  
School transportation has become a major phase in the administration of public education. From 1930 to 1940 it expanded until there were nearly four million children riding to and from school's duty in 86,000 school busses which traveled one and a quarter million miles of school bus routes daily.

Today the number of busses has increased to more than 92 thousand in the United States. Here in Georgia the number has increased from fourteen hundred in 1930 to twenty-eight hundred in 1946.

In 1946 a conference sponsored by the National Council of Chief State School Officers, was held at the Teachers College at Columbia University. This conference was attended by representatives from the 48 states. During this conference minimum standards for school busses, both from the standpoint of operation and safety, were discussed, and minimum standards were prescribed.

Again in 1945 the same organization sponsored a conference in which some of the standards set up in 1939 were revised and raised. At the conference a resolution was adopted in which each state was urged to inaugurate the necessary legislation to insure the enforcement of minimum requirements for all busses used in the transportation of school children.

During the war period the Georgia State Patrol when inspecting schoolbuses, was very lenient, knowing that parts were scarce and no new bodies and new chassis were obtainable. Now that repairs can be made more easily, and old used bodies and chassis can be readily replaced with new ones, there is no excuse for busses to remain in operation that are unsanitary and unsafe.

According to records on file with the Safety Division of the Georgia State Patrol, there were 36 school busses inspected in Bulloch County. Every one passed the inspection.

**Rifle Expert to Be at Forest Heights Country Club on April 15 for Fancy Shooting**  
Ken Beagle, Remington Arms Company expert, will demonstrate shooting ability here.

"They give as their reason for this existing doubt the fact that they are extremely nervous, especially when shooting. My answer is always the same—'If I were direct, it is the solution to their problem: shooting teaches nerve control."

Don't wear a wrap nor too many clothes while inside the room, but stay away from a crowd as much as possible. Leave off going to the show, ball games and other entertainments until the weather clears up and this "flu" subsides. It will take the cooperation of everybody to get our school attendance back to normal again.
